

1. Stand charges are listed on the booking form.
2. Breed Societies must indicate clearly the number of pens required.
3. The closing date for stand application is 5th November.
4. Exhibitors of livestock must ensure that movement forms are completed and handed in together with the passport to the stewards on arrival.
5. All TB and other movement regulations in place at the time must be adhered to.
6. No Exhibitors shall be permitted to arrange their stand or to place signs in such a manner as to obstruct the light or to inconvenience or disadvantageously affect the display of any other exhibitor. No form of intrusion into a neighbouring site will be permitted.
7. Electricity can be provided as indicated on the booking form – please ensure you book sufficient supply for your requirements.
8. Water is available on site.
9. Straw will be provided for pens/stalls.
10. All electrical equipment must be in good condition and have been PAT (Portable Appliance Tested) within the last 12 months.
11. No LPG is permitted inside the buildings.
12. All exhibitors must fill out a risk assessment form and return it to the organiser together with a copy of the public liability insurance certificate.
13. Each exhibitor is responsible for the removal of refuse from their stand.
14. Access to the breed society area will be available from 10:00am to 17:00 on Tuesday 7th November.
15. All Cattle **MUST** be on site by 17:00 on Tuesday 7th November and remain in their stalls until 16.30 on Wednesday 8th November 2023.
16. Access for trade stands area will be available from 12:00 to 17:00 on Monday 6th November from 08:00am to 18:00 on Tuesday 7th November and between 06:00 and 08:00 on Wednesday 8th November.
17. **All Machinery and large items of equipment must be sited on Monday 6th November before 17:00.**
18. Stands must be staffed at all times between 09:00 and 17:00 on Wednesday 8th November.
19. No person other than the exhibitor who has applied for and been allocated space will be allowed to sell or display articles of any description on the site. Sub-letting of stands is not permitted.
20. The catering/bar rights have been granted to Posh Nosh. Exhibitors are not permitted to sell food/drink for consumption onsite.
21. The Devon County Agricultural Association will not be responsible for any accident damage or loss, however caused which may occur to any exhibitor or to their animals, articles or property brought onto the site. Neither will they be responsible for any actions or expenses on account of or in respect of any such damage or injury caused. All exhibitors must have third party Liability Insurance and if requested should provide a copy of their current policy to the organisers. All exhibitors indemnify the organisers and the Association from any claims made in connection with the exhibitor's staff, equipment, display, animals and vehicles.
22. If, for any reason whatsoever, Agrifest South West has to be cancelled, a minimum of 90% of the stand fee will be returned.
23. Exhibitors using gazebos on external stands must ensure they have adequate weight to secure them.
24. No vehicles to be parked on the grass.
25. The decision of the organisers about the interpretation of these conditions will be final.
