



## WHY TRADE?

### TRADE STAND OPTIONS

\*Please note, if you require a marquee or gazebo this must be provided by yourself, these are not provided by the society.\*

### BLUE TRADE SITES

Our Blue trade sites are our situated along our prime shopping roadway, the Edward Hardy Avenue. This avenue is bustling with visitors and receives some of the highest footfall of all the shopping areas. All pitches will be outside and mainly on grass, with no marquees provided by the Society. Sizes start at 3m frontage with 3m depth and increase in multiples of 3m.




#### GREEN TRADE SITES

Green trade sites are our general trade stands situated in various key locations across the Showground. Pitches are all outside, mainly on grass with some limited stands on tarmac available. Sizes start at 3m frontage by 3m depth and can only be increased in multiples of 3m.

#### YELLOW TRADE SITES

Our yellow trade sites are along The New Kent Road, which is an additional shopping area parallel to the prime avenue aimed at local Kent based businesses and up and coming traders leads onto our Woodland area. There are a limited number of these pitches available so please enquire early if interested.





### **TRADE STAND PRICES**

When calculating your stand costs, please ensure that you have sufficient space to allow for all items which are needed, **including ground plates**, **tent guy ropes**, **and any vehicles**. **No equipment or vehicle is allowed to trade outside the boundary of your trade stand**. Please check with your marquee contractor if you are in any doubt before reserving your space.

If you wish to secure a corner stand then please make this known at the point of booking to the trade stand coordinator who will accommodate all requests were possible. An additional cost of £100 is applied to corner stands.

### **SPECIALIST TRADE STAND PRICES**

Our Specialist Trade Areas offer the opportunity for businesses from selected areas of interest to trade with us at a discounted rate. The application for a specialist trade area must meet the qualification criteria as set out below.

**Agricultural** - Trade stands must solely relate to the agricultural industry or breed societies. Examples include agricultural machinery or services, livestock feed, etc.

**Country, Game & Canine** - Trade stands must relate to country and gaming pursuits such as hunting, shooting, fishing, conservation, rural life or dog food, accessories or bedding etc.

**Equine**- Trade stands must relate to tack, feed, bedding, transport, stabling, equine fencing, equipment or accessories.

**Horticulture** - Trade stands must relate only to the selling of flowers, plants and/or trees.



 Deadline for all 2025 exhibitors. The Office must have received completed application forms and full payment by this date to secure a space within the Show and to guarantee inclusion in printed material such as the show guide/map.

### **APPLICATION PROCESS**

All applications must be submitted, which **must** include a Show Guide entry, picture of the set-up, and be signed by the exhibitor or your representative.

We accept applications for all three days of the Show **only** and stands must be open from 8:00am to 6:00pm on **all** three days. Single day bookings will not be accepted and early closure of stands at the Show may lead to disqualification for future years.

#### HOW TO APPLY

All application forms must be completed via Showing Scene by the application date, along with an image of your stand set-up. We will review your application and let you know whether you have been accepted. Once your application has been accepted you will receive an invoice and instructions on how to pay your fees. Please make sure this is paid promptly to avoid losing your space.

#### SHOW GUIDE ENTRIES

Each exhibitor must complete the Show Guide description section of the application form and select up to four categories in which their products or services fit. Please note, if an application is submitted after the deadline we cannot guarantee that the exhibitor will be acknowledged in the Show Guide.

#### REFUSAL OF APPLICATIONS

The Society reserves the right to reject any application for trade stand space and we reserve the right to cancel the exhibitor's use of the trade stand at any time without reason being given.

#### WITHDRAWAL OR CANCELLATION OF SPACE

Where an exhibitor withdraws from the Show or cancels the space for any reason, the following refunds will be received.

### TRADE STAND REGULATIONS

Please read our trade stand rules and regulations thoroughly before completing your application. By submitting your application you are agreeing to abide by these terms and conditions. Any trader not adhering to these regulations could be asked to leave the Show without reimbursement and receive a ban from future events. If you have questions, please get in touch with Paige the Trade Stand Coordinator on 01622 633061 or email tradestands@kentshowground.co.uk.

### USE OF TRADE SPACE

The sale of jokes and tricks, including any item containing or capable of discharging any noxious smell, noise, coloured spray, foam or other product that could be a nuisance to any other person on the Showground is not permitted. Any misrepresentation of goods on application will result in the trade stand and goods being removed from the Showground **without** compensation.

The sale of knives and catapults is restricted to persons over the age of 18 years. Please note at no time should knives be left unattended on tradestands.

The sale of any firearm, shotgun, air pistol or pellet gun is strictly controlled on the Showground (including any item that fires an object whether or not it is classed as a toy). Permission must be obtained from the Show Office prior to the Show and a copy of appropriate Fire-arms Dealers License must be sent to the Show Office. Handling of guns by the general public must be under the strict supervision of the exhibitor. All sales must be held on the stand for collection by customer upon exit. These regulations are part of the Tradestand Regulations and are in addition to any Police and Firearms licence requirements.

#### 'Cheap jack' traders and auctions

Vendors of 'cheap jack' articles or itinerant vendors who may have gained admission to the grounds will be evicted immediately. **The selling of goods by action, shouting, or behaviour that causes a nuisance to visitors or other exhibitors is strictly forbidden.** Staff and trade stand stewards will be patrolling the site regularly and will have the power to remove offending exhibitors and their goods from the Showground should they be caught breaking this rule.

#### **Political activity**

Applications for any Political Party or Organisation cannot be accepted, nor any political activity on the Showground tolerated.

### ALLOCATION OF SITES

Please check trade stand prices and spaces (refer to the enclosed map) carefully before submitting your application. We will try our best to put you in your preferred location but please note this isn't always possible.

- Allocation of sites and positioning of trade stand space is entirely at the discretion of the Society, although every endeavour will be made to meet any request made by an exhibitor about the position of their stand.
- No refund will be given if an exhibitor is not satisfied with the location of their stand upon arrival to the Show. **Under no circumstances will abuse towards our staff or volunteers be tolerated.** Anyone who does so may be asked to leave the premises and not invited to return to any further events.
- We will try to accommodate the same space as you have held in previous years. However, it is your responsibility to make any requests known at the point of booking as spaces are not guaranteed.
- Boundaries of sites will be marked with white pegs at the front of the stand, and red pegs at the back of the stand. In no circumstances will exhibitors be allowed to occupy a larger space then has been allocated to them. If an exhibitor uses any part of the Showground outside the boundary, or goes over the front line, they will have to pay for any additional space used as the Society see fit.

You must provide your own marquee or gazebo if required. There is no shedding available, and we are unable to provide any marquees or gazebos.

### HEALTH & SAFETY AND LEGAL REQUIREMENTS

#### **Health and safety**

Anyone exhibiting at the Kent County Show should be aware of their duties under the Health & Safety at Work Act 1974, and are required at the time of booking, to provide a completed risk assessment addressing all the risks associated with attending the Show.

#### **Electricity**

All electrical equipment should be PAT tested before being used at the Show and we advise you seek surge protection.

#### **Insurance**

All exhibitors must carry Public Liability Insurance with the minimum limit of indemnity required for your business. This must be submitted along with your application, or prior to the Show. Exhibitors should also hold the relevant Employers Liability Insurance where required by statute. Under the Consumer Protection Act 1998, all exhibitors supplying goods or services should hold product liability insurance under an annual policy.

#### Loss, theft or damage

The Society will not be held responsible for the loss, theft or damage of any vehicles, goods or marquees etc. on site before, during and after the event. All exhibitors are fully responsible for the security of their stand and stock at all times before, during and after.

#### Food and drink regulations

You will need a personal license to sell alcohol at the Show. If you plan to sell alcohol, you will need to fill out an alcohol declaration form with your application and send along with a copy of your personal license.

If you are selling food or soft drinks at the Show, you need to send your food handling certificate, food safety management documentation, gas certificate (if applicable) and electrical certificate along with your application.

Please note, this brochure does not cover catering units. If you would like to sell food or drink for consumption on site, please email Paige at the tradestand@kentshowground.co.uk separately about catering units.

#### Fire safety precautions

Each exhibitor must conform to precautions against fire and provide a fire risk assessment for any space allocated to them and in any stand, exhibit, tent, marquee or other temporary or moveable structure erected or installed within their allotted space. All stands using bottled gas are required to have a Gas Safety Check. It is suggested the gas connection to have crimps fitted rather than jubilee clips.

All exhibitors who produce heat or are considered high fire risk are required to supply a suitable fire extinguisher on their stand. A CFOA form, which can be obtained from the Show Office, must be completed.

### GENERAL SHOW REGULATIONS

No passes will be available until full payment, a completed risk assessment form and a copy of the exhibitor's Public Liability has been received by the Show Office.

#### **Generators**

#### For health and safety reasons, the use of generators is strictly forbidden.

All electricity required must be ordered via the application form. Any generators found to be used during the Show will result in an on-the-spot fine of £100 and may result in future disqualification.

#### Goods ordered at the Show

All orders taken at the Show must be dispatched promptly. Where the delivery time is more than three months after the closing date of the Show, customers must be made aware of this at the time of ordering. Failure to abide by this regulation may result in stands not being invited back in future years.

#### Litter

Exhibitors must have their stands and immediate adjoining avenues cleaned up at the close of the Show each day. Any litter should be placed in bins provided ready for collection by the Society's contractors. Anything for recycling should be placed on the road edge for collection each evening.

#### Livestock / animals

If any animal is going to be kept on a stand as part of an exhibit during Show days, an Animal Declaration Form must be completed and returned along with your application. All exhibitors must conform to current legislation if they wish to keep animals on their stand.

Trade exhibitors with animals of any type on their stand should be aware that they must provide both soap and running water or a map directing the public to the nearest hand washing facilities. The public should not be permitted to eat or drink in areas of animal contact.

#### Sale of birds or any other animal

The sale of birds and all other animals is strictly forbidden. Orders may be taken but no animal or bird can be exchanged during the Show period.

#### **Dogs**

Dogs must be kept on a lead at all times and are not permitted inside the livestock areas. Please ensure you clear up after your dog.

### SIGNS AND ADVERTISING

#### **Signs**

- Trade signs must not be erected in a way that overshadows other stands.
- Where possible, flagpoles should be freestanding with a base plate and secured
  with marquee pegs. Please let the Show Office know if you wish to put flagpoles
  into the ground, this is due to an underground electric network. Any flagpoles
  must fit within your allocated space.
- Flags are not permitted around the display rings.

#### **Advertisements**

Advertising is available in the Show Guide. Please contact Jim Skwarek at Geerings Print Ltd on 01233 658611 or email jim.skwarek@geeringsprint.co.uk for more information.

It is strictly forbidden for any exhibitor to:

- Affix any placard or advertisement to any part of the Showground unless prior written permission has been obtained.
- Distribute leaflets or display advertisements on the Society's property, except on their own stand.
- Roam into the avenue and other stands, or around the Showground to encourage visitors onto the stand, to offer hand-outs, leaflets, or make charitable donations etc.
  - Place leaflets/handbills on vehicles in car parks.

#### **Press Office**

The Press Office welcomes press packs and media information to be distributed to our media network. If you plan to hold a media event, please email the relevant information to emmas@kcas.org.uk or call 01622 633058, including details of stand name, timings, potential invitees and general details of the event.

#### Social Media

### NOISE

Exhibitors must not use any public address equipment (PA system), call attention to their goods, or otherwise cause noise that disrupts visitors and traders. **Staff and Trade Stand Stewards are authorised by the Show Manager to stop any activity which is deemed to be offensive.** 

#### Two-way radio equipment

Exhibitors wishing to use two-way radio equipment must have the appropriate license. The Society requests that you inform us of the frequencies which are to be used at least one month before the Show.

#### **Radio microphones**

Exhibitors, demonstrators or display acts wishing to use radio microphones during the Show are required to inform the Society of the frequencies that they are intending to use, at least one month prior to the Show.

In regard to two-way radios and radio microphones, the Society reserves the right to limit the number of frequencies and power, should they interfere with the Society's own equipment or that of the main contractors. Any organisation using the same frequency will be asked to change, or cease using the equipment.

### SERVICES

#### **Electricity**

If you require electricity on your stand, you will need to apply via Showing Scene by the 7th June .

#### Water

Standpipes are available at many points on the Showground. Water connections may be made to individual stands in certain areas only. Please complete the water form along with your application (please note we cannot guarantee that water connections will be available for all stands). A charge will be levied for stands requiring water for filling spas, swimming pools, ponds, etc.

#### **Furniture hire**

The Society does not hire out furniture to trade stands. Exhibitors should organise their own furniture, tables, chairs, etc.

#### **Grass Cutting**

The Society will keep all grass on the Showground mown up to **two weeks prior to the Show** (weather permitting). Fine cutting thereafter will be the exhibitor's responsibility.

#### Wifi

Wifi at the Kent Showground is minimal and there are no additional provisions in place to boost the network over the Kent County Show weekend. There is therefore no guarantee of this service, we recommend you source your own device to improve your own wifi connectivity. Please note, clients who try and use their own equipment that issues DHCP will cause interruption and downtime which will not be our responsibility to isolate or resolve.

### STAND PREPARATION, PLACING & REMOVAL

#### **Setting up**

Exhibitors may start building stands from Monday 30th June. The Showground is open from 8:00am to 5:00pm. Security will be on site from Monday 30th June. Entrance 1 (Main Gate), and Entrance 6 (Back Gate) will remain open 24 hours a day until closure on Wednesday 9th July.

All sites allotted to exhibitors will be clearly marked by the Society. Marking pegs must not be removed, disturbed or obstructed. Exhibitors who mow their own sites, or employ contractors to do so, must replace marking pegs in their correct positions.

Exhibitors with large mobile units should arrange to have these in position by Tuesday 1st July. This is especially important if it is necessary to encroach on an adjoining stand space to manoeuvre the unit into position. No fork lift will be available to help unload goods before, during or after the Show.

All sites must be fully stocked and ready for business by 6:30pm on the day before the Show. After this time there may be no staff available to help with any problems.

Please note that the local Council and HSE Inspectors will be onsite before, during and after the Show checking satisfactory siting, access and exits from marquees etc. This duty is authorised by the Kent County Agricultural Society.

#### **During the Show**

Once the Show has commenced, no trader will be able to move their trade space.

There will be three trade car parks close to Entrances 1, 3/4 and 6 for trade stand holders. Access to these car parks is free and you must request the number of parking passes you require upon application. Any additional exhibitors requiring parking will have to park in the general public parks which are free, but spaces near to the entrance can't be guaranteed.

All trade stands must be open and manned from 8:30am to 6:00pm daily.

#### **Setting down**

No part of a stand may be dismantled before 6:00pm on the last day of the Show. Vehicles for removal of stands will not be allowed to enter the Showground until 6:30pm on the last evening, or such time as circumstances require. Any stands dismantling before this time will not be invited back to future events.

Stands and exhibits must be cleared from the Showground within 3 days of the close of the Show. Any stand, exhibit or part remaining on the Showground after the 3 days will be removed and disposed of by the Society. Any cost involved will be charged to the exhibitor. Any damage to marquees hired by the Society, or to Society buildings, will be charged to the stand holder.

### SECURITY AND VEHICLE ADMISSION

#### **Security**

The Showground covers over 60 acres, and while security is provided, it can only be in general terms. Security will be on Entrance 1 and Entrance 6 24 hours a day from 8:00am on Monday 30th June to 8:00pm on Wednesday 9thJuly. Night security patrols will be in operation during this time.

In order to improve security, no person will be allowed onto the Showground from Wednesday2nd July to Tuesday 8th July without a valid ticket. Exhibitors will be issued with tickets for the Show days which will also be valid for setting up and breaking down days. You will also need to apply for a Static Vehicle pass if a vehicle is to remain on site during Show hours (as part of your stand only).

KCAS's security may carry out random security searches on all vehicles and trailers at any time without notice. Refusal of this request may result in attendance of Kent Police.

#### Vehicle admission pre/post Show

Vehicles will only be admitted from Entrance 1 off the A249, and Entrance 6 off Scragged Oak Road.

Any vehicles which are not essential to setting up the stand should be left in the car park and exhibitors should walk to their stand. No vehicle should be parked and left unattended on a neighbouring stand at any time during build-up and Show hours.

#### **Vehicle admission during Show**

Vehicle movement is strictly forbidden between 8:00am and 6:30pm on 4th,5th, 6th of July, and no vehicle will be allowed entry to the Showground.

Vehicles with supplies will be admitted between 6:30pm and 8:00am on Friday, Saturday and Sunday. You will be asked to give a £100 cash deposit on the gate for each vehicle you wish to enter. This cash deposit will be returned to you upon leaving the Showground before 8am.

Even if you have parked your vehicle on the Showground during the Show for a number of years, you must inform the Society and apply for the appropriate pass. Do not assume we are aware of the location of all vehicles parked in previous years. We will not issue passes without an application.

#### Static vehicle pass

This is required for those vehicles that form an essential part of the stand by may be removed each night of the Show. Only one per stand will be issued (more may be granted for motor stands) and this should be applied for on the initial trade stand application form. Please note static vehicle passes are NOT guaranteed and will be issued at the discretion of the Society. The static vehicle pass must be displayed in the vehicle at all times and any vehicles found onsite without this pass may be liable to towing.

#### **Vehicle admission post Show**

Vehicles entering the Showground for the removal of stands or those who are already within the Showground will not be able to enter or leave until 6:30pm on the last evening.
