Dear Vintage / Classic Vehicle owner

We are inviting applications from owners with vintage and classic vehicles over 25 years of age (Vehicle registered during or before 2000), to exhibit them at the show. If, however, a vehicle is of exceptional interest and merit, but younger, it may be considered, at our discretion. We would welcome an application from you to join us at this year's show.

Successful applicants will be issued with a vehicle pass, specific to the vehicle, which will permit entry on the day via gate 8, for the vehicle and the driver of the vehicle. An entry ticket will be required to be shown for all passengers. All vehicles should be on site ready for the show to open at 09.00.

This section of the show has proved very popular over the years and as numbers are now restricted, we would therefore urge you to apply without delay. We can take a maximum of 150 entries. Entries close on July the 12th but we expect to have reached our maximum in advance of this date.

REGULATIONS & GUIDELINES FOR VINTAGE & CLASSIC VEHICLE SECTION

All Owners shall be considered as having read and understood the following regulations.

Insurance: Details of the current Insurance Policy must be forwarded to the Show with your application

Security: Owners are reminded that only a limited security presence will be on the showground for the duration of the event, including some set up and breakdown time. The Okehampton Show cannot accept any responsibility for the loss or damage to vehicles, goods or equipment.

Theft: The Show reserves the right to appoint a Show Official or Security Guard with powers to stop and search vehicles leaving the Showground and/or to assist the Police.

First Aid: First Aid, including ambulances will be available on the day of the Show.

Guidelines and regulations for set up and breakdown: All vehicles must be on site ready for the show to open at 09.00am. In the event of a late arrival for a genuine reason then it is possible that we will be able to walk a vehicle into the site. Late entry should be the exception rather than the rule. All vehicles must not be moved from their allotted position, until authorised by the Show Organiser.

The vintage section will not be permitted to leave the site until after the Vintage Parade, and this is unlikely to be before 16.30. Early exit after the Vintage Parade will only be by Gate 8. Gates 1 and 2 will not be available for exit until after the show has finished and the majority of the public have left (no earlier than 17.30 unless deemed safe to do so by the Show Secretary). It is the responsibility of the vintage stewards to ensure that vehicles do not leave before this time.

This is a requirement by the HSE and the insurance companies.

I have read the conditions of entry by the Show and agree to be bound by them and all the information I have supplied above is correct The vehicle being entered is suitable for the use to which it will be put during the event and that it is roadworthy. I and any other persons I may nominate to move, drive, control and otherwise operate the vehicle are competent to do so. The vehicle will be legal and covered with adequate insurance. I will undertake not to allow anyone who is not insured to do so to start, drive and otherwise operate the vehicle entered in to this event. **I will ensure that people only ride in/on the vehicle in a safe manner and as considered legal on the road.**
