APPLICATIONS

- 1. Applications for trade space must be made on our online booking system at stithians.show/tradeapply Paper applications will only be accepted in exceptional circumstances at the discretion of the Trade Secretary.
- 2. As part of the application, you will be required to upload evidence of your Public Liability insurance, Fire Risk Assessment and Health and Safety Assessment for your stand. To assist this, proforma documents are available within the 'Download Documents' area of the application site or during the application process. Please prepare these documents before starting your application. Should you already have such risk assessments prepared they may be permissible to use providing they are adequate, up to date and pertain to the activities being undertaken at the Show.
- 3. Payment will **NOT** be required on application but will be due on acceptance and the issue of our invoice. We request that prompt payment is made by card and BACs details will be on the invoice.

NON-TRADE STAND APPLICATIONS

PASSES

- 7. Entrance Passes:
 - Two free entrance passes will be issued for each 6m deep stand.
 - Three free entrance passes will be issued for each 8m deep stand up to the 12m x 8m size.
 - Four free entrance passes will be issued for each 8m depth stand 14m x 8m and above.
 - Extra passes may be purchased at time of application or via our website (www.stithians.show) at £14.59 each + VAT (provisional price). Please ensure any additional passes are purchased prior to arriving at the Showground.

8. Vehicle Passes:

- Up to four green Trade vehicle passes will be issued per pitch. These <u>MUST</u> be displayed in vehicle windscreens at all times; you will not be able to enter the Showground without one. If you require additional vehicle passes please make a note on your application or email <u>tradeexhibitors@stithians.show</u> as soon as possible to allow time for them to be posted.
 Note all vehicles that are not part of, or not required to remain in your trade stand area <u>MUST</u> be parked in the Exhibitors' carpark which is signposted as you exit the Showground. Please remember that there is no vehicular
- If you wish to park your vehicle on your plot you <u>MUST</u> book a plot that fits <u>BOTH</u> your stall and vehicle. If you <u>CANNOT</u> fit your vehicle on your plot you <u>MUST</u> use our Exhibitors' carpark. Our Health and Safety Officer will check plots and if your vehicle <u>DOES NOT</u> fit within your plot you will be asked to move it.
