## TERMS & CONDITIONS FOR THE SUPPLY OF ELECTRICITY & HIRE OF EQUIPMENT

1	Supply 230volt single-phase, 400volt three-phase 50 cycles alternating current (AC).
2	The charges detailed on the price list include for the supply, hire and installation from the electricity power supply, a proportion of the necessary mains cable, overhead/underground network, switch fuse and control gear, together with all necessary circuit wiring and fittings and for taking down and removing at the close of the show.
3	The electrical connection will be terminated at the nearest point on the stand to the distribution box. Exhibitors requiring a different termination point should give details on separate paper and attach it with the application.
4	It is strictly understood that only <u>ONE</u> item of equipment is connected to each point. Bayonet adaptors shall not be used.
5	The use of trailing/block type 4-way fused sockets shall be restricted to the following: One 4-way unit per socket outlet, with a maximum loading of 500watts total with its fuse rated accordingly.
6	Exhibitors will be held responsible for all equipment on hire that is damaged or missing at the end of the show and it is the responsibility of the exhibitor to ensure that equipment is returned in good working order.
7	Applications for the supply of electrics must be received by us no later than the date stated on the order form. After which date no guarantee will be given that the work will be carried out, but if it is carried out the cost will be as per the price list plus a surcharge for modifications to our supply network.
8	We reserve the right to refuse any faulty equipment being connected to our supply. Any work carried out on equipment to bring it to the required standard will be charged on a time and material basis.
9	The electrical supply is of a temporary nature and may be from a generator set.
10	Every effort will be made to provide uninterrupted power supply. However, no liability will be accepted by McConnells Electrical Services Limited or the organisers for any loss or damage due to power failure.
11	Supply of electricity should normally be available to most stands from mid-day on the day prior to the show commencing, until the official closure of the show. However, should this not be possible for whatever reason McConnells Electrical Services Limited will not be held responsible and will not accept any claims for loss of earnings or otherwise.
12	All portable electrical appliances being used during the show must carry a current Portable Appliance Test Certificate. This certificate must be available for inspection at all times, any appliance not carrying a certificate will be refused connection to the electrical supply.
13	For the unedited version of the Terms and Conditions, please contact the office. It is the responsibility of the hirer to fully understand the full terms and conditions made available to them.
