- 1. Site Booking: Traders who exhibited at our 2019 Show have priority until the end of December to rebook their existing site. After this date all remaining sites will be offered to new traders on our waiting list. Although every effort is made to meet the site requirements of exhibitors, allocation of a previous year's site cannot be guaranteed. Where possible we try to separate similar products offered for sale, but reserve the right to give the public variety and choice.
- 2. Site Size: When calculating your site costs exhibitors are reminded to allow enough space to accommodate tow bars, marquee foot plates and guy ropes, vehicles etc. Eg: It is not possible to erect a 6m x 6m tent on a 6m x 6m site.
- 3. **Premium Sites:** are on Main Drive and Fourth Avenue facing the Jubilee Arena and incur a 30% surcharge, these are very popular and usually booked very early so please contact the office to discuss before sending your application in.
- 4. Website Listing: Your Company, contact details will be listed on the website www.hertsshow.com
- 5. Show Guide: Your Company Name, email address and website details will feature in our show guide along with a brief description of your products/services. Deadline: 1st March.
- 6. Tickets: Every person entering the Showground must have a wristband, these are valid for both days, including drivers of trade vehicles must have a wristband or pay the full price of admission at the gate (i.e. £24 incl VAT). Pre Show tickets and vehicle passes are not needed.
  - Stands of up to and including 9 metres frontage traders will receive 6 exhibitor wristbands.
  - Stands 12 metres frontage and over traders will receive 12 exhibitor wristbands.
  - Additional entrance tickets can be ordered on the Trade Exhibitor Application Form or will be available from the Show Office until 30<sup>th</sup> April 2022 at a special discounted price of £12.50 + VAT these are one day tickets.
  - After that date please order from our ticket hotline: 0344 850 2122
- 7. Vehicle Passes: 1 vehicle pass is allocated to each site which permits entry to the main Showground on both Show days. Sites 12 metres frontage and over will be allocated 2 vehicle passes. Extra passes can be bought at £15 + VAT each for vehicles needing access to either the trade stand or the trade car park on Show days. Staff cars and any other vehicles can use the public car park free of charge. Parking behind the Food Hall is for its exhibitors only.
- 8. Trade Camping is in the reserved area inside Gate 14. Please make us aware if you are camping for the weekend.
- 9. Pre Show Set Up Times: Thursday 9am 6pm. Friday 9am 9pm. Saturday 6am 8.30am.

  Contractors employed by trade stand holders will not be allowed access to the Showground before these times unless previously agreed with the Trade Stand Secretary. Open site exhibitors are advised to rope off their sites to prevent damage by 'trespassing' vehicles during build-up. Please ensure all equipment, including marquees, guy ropes, supports and vehicles do not extend outside the total area of the site you have booked.
- 10. Electricity must be ordered in advance with our electrical contractors. A booking form will be sent to those traders who have ticked the box on their application form; it can also be downloaded from our website. The use of personal generators is strictly prohibited. Electrical contractors will be on site to arrange connection and to take any electrical enquires. Electricity will be switched on from midday Friday 27th May.
- 11. Food Hall: Food and Drink (alcoholic and non-alcoholic) sold must not be for consumption on the Showground. Wooden flooring to stand areas is included in the site cost. Overhead lighting is provided but power to each site, if required, must be booked in advance with the electrical contractor. For table hire see note 15 below.
- 12. Market Sites: 3 x 3 or 6 x 3 metre site including an Individual Frame marquee. 3 rows available.
- 13. Charities: A limited number of sites are available for agricultural charities which are allocated at the Show's discretion, the Charity Registration number is needed as proof of status. The Show may refuse any Charity whatsoever without reason. We are restricted to a few charity stands chosen by our Society, and will be picked by the 1st March.
- **14. Hardwood Flooring** can be ordered on the form for marquee sites only. Carpets can be ordered but cannot be laid directly onto grass so wood flooring must also be ordered.
- 15. Table Hire: Only available for Marquee Sites not for Open Grass Sites. Tables are not included in the stand fee but can be ordered on the Trade Exhibitor Application form or by calling the office by 31st March 2022 latest, a deposit cheque of £100 per table is required.
- **16. Agricultural & Breed Societies**. Traders of an agricultural nature or breed society in their entirety are eligible for 50% reduction
- 17. Water: If water is required the office MUST be notified in writing as it will affect the siting of the stand.

#### TRADE EXHIBITOR RULES & REGULATIONS

- 1. The Society retains the right to refuse any exhibit that it considers unworthy of being shown and also to order the removal of any unsightly or unsuitable stands.
- 2. No application will be accepted unless accompanied by the correct remittance. Exhibitors are not 'booked in' until **full** payment has been processed and written confirmation has been sent from the Show office.
- 3. No exhibitor may sub-let any part of the site allocated. Single day bookings are not accepted.
- 4. No exhibitor may move to an alternative site or designated trade stand area on the Showground without the express permission of the Senior Trade Stand Steward or the Trade Secretary.
- 5. Amplification equipment may be used providing it is at a reasonable level and not intrusive to other traders or members of the public. In the event of a dispute, the Senior Show Steward will determine what is deemed to be 'reasonable'.
- 6. No exhibitor shall be allowed to call attention to goods or services or use any equipment or machinery so as to cause annoyance to other traders or members of the public.
- 7. Promoting your business or charity by distributing leaflets or other marketing material fly posting away from the confines of the site or selling of goods by auction are all prohibited.
- 8. Live animals, birds, fish etc. are not to be sold or offered as prizes and must not be handled by the public at any time unless previously authorised by the society and signed off by the showground veterinary team prior to the start of the show.
- 9. Organisations wishing to make appeals for contributions or to run competitions must obtain written permission from the Secretary.
- 10. Exhibitors must display their name and address at all times in a size and style that can be easily seen by the public.
- 11. Well behaved dogs are welcome but they must be kept on a lead at all times and are not allowed in the Livestock Marquees, Food Hall, Entrepreneurs or Made in Hertfordshire Marquee.
- 12. Where possible we try to separate traders who are likely to offer similar products for sale, by placing them in different locations. However, the layout of the Showground and of the Trade Stands means there will be occasions where it is unavoidable that traders are in close proximity to their competitors. Traders who exhibit at the show must accept that this may occur.
- 13. Prohibited Items that may NOT be used either on your stand or offered for sale within the Showground include, but are not restricted to, the following: Kites, Silly String, Air Horns, Stink Bombs, Drones, Twoway Radios, Weapons, Replica Weapons, Balloons, Fireworks, Generators.
- 14. The Society reserves the right to terminate a booking for any reason at any time before the date of the Show by written notice. ("Termination Notice")
- 15. Force majeure If an event defined hereafter as Force Majeure occurs the Hertfordshire Agricultural Society (HAS) will not be responsible for the financial consequences or any losses or any actions claims or demands caused to or made by an exhibitor or their servants or agents caused by the failure of the Hertfordshire County Show to be held on one or more of the days but for the event of Force Majeure on which it would otherwise to be held. Force Majeure means for the purposes of this clause exceptionally inclement weather; flooding of the whole or any part of the Hertfordshire County Showground or the whole or any part of the car parks associated with it; an act of God including but not limited to fire, flood, earthquake, windstorm or other natural disaster; act of any sovereign including but not limited to war, invasion, act of foreign enemies, hostilities (whether war be declared or not), civil war, rebellion, revolution, insurrection, military or usurped power or confiscation, nationalisation, requisition, destruction or damage to property by or under the order of any government or public or local authority or imposition of government sanction embargo or similar action; law, judgment, order, decree, embargo, blockade, labour dispute including but not limited to strike, lockout or boycott; interruption or failure of utility service including but not limited to electric power, gas, water or telephone service; failure of the transportation of any personnel equipment, machinery supply or material required by HAS to run the Hertfordshire County Show; breach of contract by any essential personnel; any other matter or cause beyond the control of HAS

#### **HEALTH & SAFETY INFORMATION**

- 1. Our Health and Safety Risk Assessment Forms will be sent to you once you have booked a trade site these **must** be completed and returned to the Show office as soon as possible.
- 2. It is the responsibility of the Exhibitor to hold the necessary Public Liability Insurance cover for the Third Party risks and to ensure all their staff and contractors work in accordance with the relevant Health & Safety legislations. The Exhibitor Public Liability Insurance must also include all and any risks including personal injury that might arise from any sale or distribution of inflatable balloons by the Exhibitor to cover Show visitors, other Exhibitors and Hertfordshire County Show staff with a recommended minimum £2.5 million of insurance cover.
- 3. The Society has taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, please take reasonable precautions to avoid and prevent accidents occurring and obey the instructions of the Society's Officials and Stewards. Please clear rubbish and debris regularly and after the Show, fill in holes and make good any damage to the ground.
- 4. Any exhibitor who brings their own marquee must provide a Health and Safety Risk Assessment together with a suitable serviced fire extinguisher(s) as appropriate. Smoking is prohibited in all marquees. If you require any advice please contact David Sendall at The Fire Protection Company, Knebworth on 01438 816693.
- 5. There will be continuous night security patrols during the Show weekend but it is the responsibility of exhibitors or their agents to safeguard their property. The Society does not accept any responsibility whatsoever for any losses in the build up/take down/during the show.
- 6. All sites must be staffed, stocked and open to the public continuously from **8.30am to 5.30pm** on both Show days and early departure is not permitted.
  - Vehicles must be parked in their appropriate parking area by 8.30am on Show days and vehicle movements are not permitted within the Showground until 5.30pm or until the Show Stewards permit their movement, whichever is later.

#### **CANCELLATIONS / REFUNDS**

- The Society reserves the right to cancel all or part of the Show for any reason. To the extent permitted by
  the Unfair Contract Terms Act 1977 the Society will not be liable for any loss or damage whether caused
  by the negligence of the Society its servants or agents or in any other way whatsoever. The Society shall
  in no circumstances be liable to the Trader for any loss of business, profit or production or any similar loss
  or damage whether direct, indirect or consequential and be under no obligation whatsoever to compensate
  the trader.
- 2. Please confirm cancellation of a trade site in writing or via email to trade@hertsshow.com
- 3. Any exhibitor who cancels a booked site, for whatever reason, shall forfeit all fees paid and the Society shall reserve the right to re-let such sites.
- 4. No refunds will be given due to bad weather or ground conditions.
- 5. Exhibitors must ensure that they are adequately insured covering public liability for Third Parties plus cancellation cover by the Trade Exhibitor. The Society will not, under any circumstances, entertain any claim on behalf of any exhibitor.

#### **FOOD**

- 1. Food sold in The Food Hall and the Made in Hertfordshire Marquee is for consumption OFF the Showground. Hot and cold samples may be offered to visitors. Food (to be taken home) can also be sold from outside Trade Sites at the discretion of the Show office; written permission MUST be obtained.
- See item 12 in the Rules and Regulations section. We cannot and do not guarantee exclusivity on produce for sale in the Food Hall and we will do our best to site your company in a suitable position within the marquee.
  - NB: A few of our well established existing exhibitors in the Food Hall have permission to sell food to eat at the Show. This is by special arrangement with the Society and a premium is charged for this.

#### **DRINK**

- 1. Drink (alcoholic and non-alcoholic) is NOT to be sold for the consumption <u>ON</u> the showground to our Show visitors. You are only permitted under the Show's rules to sell alcohol for consumption <u>OFF</u> the Showground, NOT by the glass from the Trade Exhibitor Site. However complimentary samples may be offered. Please note outside stands you still require your own TEN License issued by St Albans City Council to offer Alcohol products sold during our Show for consumption off-site. Our Food hall and Made in Herts marquees both have TEN license set up by HAS for you.
- 2. <u>ALCOHOL SALES:</u> The Hertfordshire County Showground does not hold a Premises Licence for the sale of Alcohol. The sale of Alcohol for consumption during our Show is restricted to our approved Restaurant and Mobile Bars. For your information all 4 of these authorised Alcohol concessions are licensed under Temporary Event Notices for their sole use in designated areas.

#### **NEW EXHIBITORS**

- 1. The siting of exhibitors will be at the discretion of the Trade Stand Secretary who will endeavour to accommodate any requests.
- 2. All exhibitors from the previous year's County Show are given first refusal on re-booking their space until the end of December 2021 and therefore a waiting system is in place.
- 3. A small photograph/logo can be added to your listing on our website, once you have booked please upload at www.hertsshow.com
- 4. Only items/services you list on the application form are permitted to be sold or promoted on your stand.
- 5. Trade Exhibitor forms and general information on the Show are on our website www.hertsshow.com.
- 6. You will be allocated a Trade Site Number two weeks before the Show and the area will be highlighted on the plan sent to you with your tickets and wristbands. This number will be on small white plastic flags at the front of your site so please set up WITHIN the flags and do not move them. Stewards will be on site to assist. Encroaching on another Exhibitor's space is strictly forbidden, if your marquee is too big for the site booked you will be expected to take it down.
- 7. Encroaching on another Exhibitors space is strictly forbidden, if your marquee is too big for the site booked you will be expected to take it down.
- 8. Exhibitors can set up from the Thursday before the show, if you need access earlier please contact the Trade Stand Secretary to discuss. During the set up days and the show weekend the Trade Stand Information office will be located in the centre of the Showground under the large Oak tree.

#### **RETURNING EXHIBITORS**

- Traders who exhibited at our previous Show have priority until the end of December 2021 to rebook their
  existing site. Payment must be received in full by this date to secure the same site as at the previous
  show. After this date all remaining sites will be offered to new traders on our waiting list. Although every
  effort is made to meet the site requirements of exhibitors, the layout of the showground does change each
  year so allocation of a previous year's site cannot be guaranteed.
- 2. Please check your details are correct on the application form sent to you and make any amendments where necessary. Please inform us of any change of address immediately.
- 3. Our trade site numbers may change on the plan from year to year so even if you book the same site it may not necessarily have the same number.
