EQUINE FLU (Reg. 55) IMPORTANT INFORMATION The minimum requirement is two vaccinations, at least */ not less than*, 21 days apart. There must also be a clear 7 days after the second vaccination, before entry on to the showground. It is mandatory that all other horses/ponies/donkeys must have received a booster within the **6 calendar months** of their entry on to the showground. Foals of 6 months of age or older must meet the Equine Influenza vaccination requirement. Foals of less than 6 months of age must be out of a mare that meets the above requirement. Passports may be inspected at any time; any horse without a valid vaccination protocol or owner/exhibitor unable to produce a valid passport will lead to immediate eviction of that horse/pony/donkey from the showground.

PASSPORTS (Reg.56) All animals must be accompanied by a legal and currently valid passport. On arrival at the showground and prior to unloading your animal/s, please go to the Stable Managers Office (located near the Main Ring Collecting Ring) and present your passport/s in order for the Flu record/s to be validated. Passports must be inspected before any stabling can be allocated (if previously booked). Exhibitor numbers will also be available for collection at this point.

ANIMAL WELFARE (Reg.77) In addition to this regulation, the rule has been enhanced in the interests of welfare and probity in relation to the following classes: Animals in classes 130, 131, 165, 166, 167, can only be ridden at all times by the child that is entered to ride it in the class. A substitute rider may ride the animal outside of the ring, but they must be eligible in age to compete in the class entered. For example: Class 130 M&M FIRST RIDDEN - states "Suitable to be ridden by a child who has not attained their 10th birthday by 1st January in the current year". Therefore, the age of the rider applies to the rider in the ring or anywhere on the showground, exercise areas or vehicle parks, at all times up to the relevant class. Where an animal is entered in multiple classes, the respective restrictions apply up to the conclusion of each class and thereafter immediately pass to those regulations associated with the next class; at all times the general rule about riders needing to be appropriately sized to their mount, is applicable

WHISKERS/SENSORY HAIRS (Reg.78)

All equines should present with no evidence of whiskers or sensory hairs having been trimmed or removed (other than for veterinary purposes in which case you must provide written proof of a valid veterinary reason, from your Vet; this proof must be available at Show if requested by a Show Official). Sensory hairs are the hard hairs located on the horse's muzzle and around the eyes, also known as 'whiskers' that are used for sensation.

Following several enquiries regarding trimming of ear hair, as part of Reg.78 the hair on the internal aspect of the ear pinna should not be excessively trimmed as it performs a protective function against insects, sun and foreign objects. The Society may take actions against anyone who is in breach of any of our regulations.

DISPLAYING CATALOGUE NUMBERS (Reg.79) All riders/handlers MUST display their animal's catalogue number at all times when riding or working their animal anywhere on the showground, exercise areas or vehicle parks, day or night.

The deposit will be marked as "to be repaid" once the stable has been inspected by the Stable Manager. If you vacate your stable without having it inspected, your deposit will be forfeited.

Deposits will be returned following the Show via bacs if this is marked as "to be repaid".

Competitors are prohibited from moving stables, once they have been allocated. Please advise of any additional info e.g. Stallion, horse size etc. when entering.

Please note the times that stabling becomes available; anyone entering a stable without prior permission, or moving other people's property before the specified time, may be asked to leave the showground.

The stone built permanent stables are reserved for Heavy Horses only. e.g. Shires, Clydesdales, etc.

Stables will generally be allocated on a first-come, first-served basis. Exhibitors can only book stables for the night before their class and/or the night of their class. Once a waiting list is established, exhibitors travelling for more than 4 hours or those exhibitors travelling with mares with foals may be given priority at our discretion.

If your entry is dependent on stabling we advise that you submit your entry in as early as possible. Please read ALL of the regulations carefully before making your entry.

EXHIBITOR TICKET/WRISTBAND ALLOCATION (Reg.54) Tickets/wristbands will be allocated to exhibitors on the basis of TWO tickets/wristbands per entry. Tickets/wristbands are valid for any ONE show day. Additional tickets/wristbands can ONLY be purchased in advance of the show as tickets/wristbands will not be available to buy at the Show. Please see Regulation 16 for more details.

READ ME BEFORE YOU ENTER

ENTRIES CLOSE

Tuesday 2nd May 2023. Due to high demand in some classes, entry numbers may be restricted. Please ensure you enter your animal/s in the correct class, check you have recorded all details, including the age, height and type of your animal, as we use this information to check it fits the class description.

STABLES

Stables are allocated on a first come first served basis, demand is very high so to avoid disappointment book your stable on the entry. Please remember, some classes start very early in the morning. <u>Exhibitors can only book stables for the night before their class and/or the night of their class.</u>

We cannot guarantee being able to satisfy late requests for stables. When all the stables are booked a waiting list will be created.

At our discretion, priority may be given to exhibitors bringing mares and foals or who are travelling more than 4 hours to get to the Showground.

See Passports below re checking in at the Stable Managers office prior to unloading. **A REFUNDABLE DEPOSIT SYSTEM IS IN PLACE** - The deposit will be marked as "to be repaid" once

• EQUINE FLU (Reg. 55)

The minimum requirement is two vaccinations, at least */ not less than*, 21 days apart.

There must also be a clear 7 days after the second vaccination, before entry on to the showground.

It is mandatory that all other horses/ponies/donkeys must have received a booster within the 6 calendar months of their entry on to the showground.

Foals of 6 months of age or older must meet the Equine Influenza vaccination requirement.

Foals of less than 6 months of age must be out of a mare that meets the above requirement.

Passports may be inspected at any time; any horse without a valid vaccination protocol or owner/exhibitor un able to produce a valid passport will lead to immediate eviction of that horse/pony/donkey from the showground.

PASSPORTS (Reg. 56)

All animals must be accompanied by a legal and currently valid passport. On arrival at the showground and prior to unloading your animal/s, please go to the Stable Managers Office (located near the Main Ring Collecting Ring) and present your passport/s in order for the Flu record/s to be validated. Passports must be inspected before any stabling can be allocated (if previously booked). Exhibitor numbers will also be available for collection at this point.

• EQUINE WELFARE (Reg. 77)

Welfare is of paramount importance and all riders should be of an appropriate size and weight for the horse/pony being ridden (anywhere on the showground, exercise areas or vehicle parks, day or night).

The Society reserves the right to take further action (See Disqualifications, Sanctions and Exclusion Orders) against any competitor or exhibitor whose animal is being ridden (anywhere on the showground, exercise areas or vehicle parks, day or night) by anyone whose size or weight compromises the welfare of the horse/pony being ridden; this would be based on the recommendations of the on-site veterinary team, who will use the 20% ratio as a guideline (this means the combined weight of rider plus their saddle should be less than 20% of the animal's weight). This would be based on a relatively fit, healthy animal, as an overweight animal is also a welfare concern.

This rule has been enhanced in the interests of welfare and probity in relation to classes:

Animals in classes 130, 131, 165, 166, 167 can only be ridden at al times by the child that is entered to ride it in the class. A substitute rider may ride the animal outside of the ring, but they must be eligible in age to compete in the class entered. For example:

Class 130 MOUNTAIN & MOORLAND FIRST RIDDEN - states "Suitable to be ridden by a child who has not attained their 12th birthday by 1st January in the current year".

Therefore, the age of the rider applies to the rider in the ring or anywhere on the showground,

exercise areas or vehicle parks, at all times up to the relevant class.

Where an animal is entered in multiple classes, the respective restrictions apply up to the conclusion of each class and thereafter immediately pass to those regulations associated with the next class; at all times the general rule about riders needing to be appropriately sized for their mount, is applicable.

WHISKERS/SENSORY HAIRS (Reg.78)

All equines should present with no evidence of whiskers or sensory hairs having been trimmed or removed (other than for veterinary purposes, in which case you must provide written proof from your Vet; this proof must be available at Show if requested by a Show Official). • DISPLAYING CATALOGUE NUMBERS (Reg. 79)

All riders/handlers MUST display their animal's catalogue number at all times when riding or working their animal anywhere on the showground, exercise areas or vehicle parks, day or night.

GROOM'S DRESS CODE (Reg. 66)

Grooms/attendants appearing with animals in the judging rings must have suitable footwear and be dressed appropriately, i.e. of smart appearance (NO JEANS/SHORTS/MINI SKIRTS). HATS MUST BE WORN IN THE RINGS e.g. Trilby type or riding hats are acceptable (NO BASEBALL TYPE HATS/CAPS). Any person not complying with this regulation may be asked to leave the ring by the Steward or the Judge.

DATA PROTECTION

The Yorkshire Agricultural Society will hold your personal information on its' database for the purpose of operating the Show.

- **HOYS NUMBERS**: If entering a HOYS qualifying class, you must include ALL the relevant HOYS ID Numbers, i.e. owner, agent (if applicable), animal, rider, postcodes and all other required information, on the online system so that your entry is valid. If you don't have HOYS ID numbers please contact: **GRANDSTAND MEDIA EQUINE SECTION, Tel: 02476 858205**
- **ENTRY CHANGES**: Requests for any changes must be done in writing/email and must be received in the Livestock & Entries Office before Thursday 18 May; this will then be considered by the Office.
- **CANCELLING ENTRIES**: Entry fees will only be refunded when supported by a veterinary certificate. Instruction to cancel entries must be done in writing/email and sent to Livestock & Entries Office before **Monday 17 July 2023**. ALWAYS request confirmation of receipt of your instruction. If exhibitor packs have already been despatched refunds will ONLY be given upon return of the complete pack containing all tickets, wristbands, vehicles passes etc.
- **ENTRIES NOT FORWARD (Reg. 61a):** Entries not forward for any reason other than illness or injury will forfeit all entry fees.
- <u>CANCELLING STABLES (Reg. 61b)</u>: Refunds for stables can only be given if stables are cancelled in writing/email before noon Friday 30 June to Amanda or Jo-Anne to enable the Office to resell the stables. Stables bought and sold anywhere other than through the Livestock & Entries Office will not be recognised. Anyone found buying or selling stables on any social media site will risk having their entry withdrawn.
- EXHIBITOR TICKETS (Reg. 54): Tickets (in the form of wristbands) are limited to two wristbands per class entered. If you need extra tickets/wristbands, these can ONLY be purchased in advance as tickets/ wristbands will not be available to buy at the Show.
- **OTHER REFUNDS:** HOYS fees and Membership subscriptions are Non-Refundable.
- <u>CAMPING</u>: Tents must be pitched next to your horsebox/trailer within your allocated pitch and are charged at £25 per night.
 <u>Tents are restricted to one tent per exhibitor; this is due to limited space and to meet the fire regulations.</u>

This Show is a **Horse of the Year Show** qualifying round for the **Price Family Supreme In-Hand Championship** the final to be held at **Horse of the Year Show, NEC, Birmingham, 4th-8th October 2023.** The Champion Pure Bred Cleveland Bay and Champion Part-Bred Cleveland Bay will both go forward into this qualifying round (if eligible), unless already qualified, then the reserve (if eligible) will go forward into this round which will be held on the Thursday of Show.

Foals or Geldings of 4 years or older are NOT eligible.

- Class 1 PURE BRED COLT, FILLY OR GELDING, yearling.
- Class 2 PURE BRED COLT, FILLY OR GELDING, two or three year old.

The request will be looked at on an individual basis; this may vary from section to section - see individual Breed Regs.

9. Checking of Entry Details

Exhibitors are entirely responsible for the eligibility of their animals for the classes entered and should check that all details are complete and accurate before submitting their entries via the on-line system on our website. Requests to amend incorrect details may attract an admin fee. Entry Fees will not be refunded to exhibitors who enter ineligible animals.

10.Substitution of entries is NOT allowed. (Unless stated separately in the individual section Regulations).

11.Competitor/Exhibitor Declaration

By submitting entries (in any section), you agree to abide by the content and spirit of and Codes of Conduct regulations of the Yorkshire Agricultural Society. Any exhibitor who breaks any of the Society's rules or uses unfair means to win a prize, will be subject to the rules on Disqualification, Sanctions and Exclusion Orders contained herein and, as a result, may forfeit all prizes and be barred from attending future shows.

12. Disputes

In the event of any dispute, parties are directed to the procedure contained under Disqualification, Sanctions and Exclusion Orders contained herein. (Sections 33 -50).

13. Breed Society/Governing Body Regulations

Any exhibitor competing under breed society or governing body affiliation will be considered to have agreed to abide by the rules of that society in addition to the show rules.

14. Emergency Veterinary Treatment

It is a condition of entry to the Show that the Society's Veterinary Surgeons can treat any animal if emergency treatment is required. This applies whether the owner/exhibitor is present or not at the time. If emergency treatment is provided exhibitors are responsible for the cost of any medication or drugs used in the treatment of their animal and payment must be made directly to the Vets at the time. An animal receiving veterinary treatment prior to the date of the show should not be entered for competition, unless the owner has had the animal examined by their own Vet, and their Vet considers it is safe for them to be entered. **Any animals showing clinical signs of infection or illness, and in particular Ringworm will not be permitted to be shown.** On arrival on the Showground if an exhibitor has any doubt or concern the Show Vet's must be contacted immediately to examine the animal and the Vet's decision as to whether it is fit to remain on the Showground will be final. Exhibitors should also refer to Regulation 32.

14. Fitness to Travel / Transport of Pregnant Animals

Animals must be fit for the intended journey prior to beginning the journey and must remain sufficiently fit throughout the travel period. This means the animal should be healthy enough to tolerate the entire journey it is about to make (including loading, unloading and any journey breaks) with no or very little adverse effect on it and the journey should not cause the animal any suffering or injury. The means of transport must be designed, constructed, maintained and operated so as to avoid injury and suffering and ensure the safety of the animals. A journey includes the period from the loading of the first animal to the unloading of the last animal. Any animal entered in the Show that is not fit to travel should be left at the holding premises.

The transport of pregnant animals for whom 90% or more of the expected gestation period has already passed, or who have given birth in the previous week is prohibited. Any animal entered to which these criteria apply should not be brought to the Show under any circumstances. [Council Regulation (EC) 1/2005, implemented by The Welfare of Animals (Transport)(England) Order 2006]

15. Entry to the Show

Exhibitor tickets in the form of wristbands will be allocated in accordance with the details on the schedule. Additional day tickets may be purchased in advance – please order with your entries. Advance prices are as follows:

Adult: £32.00 Child: £13.00 (5yrs to 18yrs) Family: £80.00 (2 adults & 3 children)

- **16.** Prize money can only be paid by bank transfer following the Show. Bank details are required (when entering) for any monies to be paid out. If no details are given, we will assume you wish to donate your winnings to the Yorkshire Agricultural Society. All prize money will be paid by the end of August in the current year.
- **17.** No exhibit may be covered during show opening hours. No rosettes or prize cards except those won at the Great Yorkshire Show in the current year may be displayed and are displayed at the owner's risk. Duplicates will not be supplied.

18. Showing Ring Dress Guide

All exhibitors, stockpersons, and grooms must be appropriately dressed. Exhibitors are under the jurisdiction of the Judge until the class has been completed and must stay in the ring throughout the class unless instructed otherwise by either the Judge or the Steward.

19. Merit

The Judge has discretion to withhold any prize where he/she considers there is insufficient merit.

20. Protests

Any protest must be lodged in writing within two hours of the class being judged and accompanied by a deposit of £50. The protest must be handed in at the Show Office. The protest will be considered by a Committee chaired by the Show Director or the Chief Executive and the Committee's decision is final. If the protest, in the view of the Show Director, is deemed to constitute a Dispute then it will be dealt in accordance with the procedure under Disqualification, Sanctions and Exclusion Orders, contained herein. If the protest is not sustained then the deposit may be forfeited at the Society's discretion. Please note: This is a general regulation and Individual Section Regulations regarding protests may differ to the above.

21. Cups and Trophies

All YAS Society cups and trophies are perpetual and cannot be won outright. Cups and Trophies may be collected from the Show Office on show days on production of the winner's slip which will be handed to the winner in the ring.

THIS MAY DIFFER FOR THE 2023 SHOW DEPENDANT ON GOVERMENT GUIDANCE AT THAT TIME). Cups and Trophies will not be posted after the Show. Cups/Trophies must be returned to the Society's Office no later than 15 March 2024 at the expense of the exhibitor. THIS IS A CONDITION OF TAKING THE CUP/TROPHY. When returning trophies to the Society please ensure the correct details are supplied for engraving purposes.

PLEASE DO NOT HAVE YAS SOCIETY CUPS/TROPHIES ENGRAVED. All engraving will be carried out on return of the YAS cup/trophy and must ONLY be at the appointment of the Society. **Please note:** Due to the age and value of a few of the cups and trophies listed in the schedules, a keepsake/tankard may be offered by the Society instead of that particular cup or trophy, although the winner's details will be added to any such cup or trophy for posterity.

- 22. Dogs/Pets are not allowed on the Showground, (including Car Parks, Camp sites, etc.) except for Assistance Dogs and those taking part in competitive classes or events.
- **23.** Any exhibitor removing their exhibit before the permitted time as detailed in the relevant schedule shall be deemed to have breached these rules and it will be categorised as a Major Breach (as defined) and will be subject to the rules governing Disqualification, Sanctions and Exclusion Orders.

24. Responsibilities of Exhibitors

It is the responsibility of the exhibitor to ensure they arrive on the showground in sufficient time for the commencement of their classes. Any ring timetables publicised are provisional and may be subject to change. The Society will not accept responsibility for any exhibitor missing their class(es).

25. Conditions of Admittance

Persons are admitted to the showground and car parks at their own risk and vehicles, together with their accessories and contents, are parked at the owner's risk. While every care is taken to ensure the safety of people and vehicles the Society will not accept liability for any loss or damage or personal injury however caused.

26. No Smoking

All enclosed AND substantially enclosed areas on the Showground are Smoke Free (no smoking including the use of e-cigarettes). This includes permanent buildings, temporary structures, tents, marquees or similar, stables, cattle sheds, sheep, pig and goat lines, the Main Ring and White Rose Ring Grandstands. Any persons breaking this rule may be excluded from future shows.

27. Animal Welfare

Any person causing suffering or any form of cruelty to animals will be deemed to have committed a Major Breach of these Rules. Both the first instance adjudicators and any subsequent Appeal Panel will rely on the proposed sanctions below as guidance when considering any decision:

- (a) A lifetime Exclusion Order preventing you from ever exhibiting and/or attending the Show;
- (b) An Order to forfeit of entry fees, prizes and prize monies;
- (c) YAS reserve the right to report any cruelty to animals to any relevant prosecuting authority including but not limited to; the Police, NYC Trading Standards and APHA, RSPCA or any Breed Association.

28. Health and Safety

Any exhibitor who fails to comply with health and safety or fire safety legislation may be liable to enforcement action by NYC Environmental Health and the North Yorkshire Fire and Rescue Fire Safety Officer.

It is the responsibility of all exhibitors to familiarise themselves with the Health and Safety Policy for the Show and to comply with any requirements placed on them whilst competing at the Show. Livestock exhibitors will indemnify the Yorkshire Agricultural Society for any losses suffered as a result of their failure to provide competent handlers in accordance with these regulations and the GYS Health and Safety Policy.

29. Disclaimer

In the absence of any negligence or other breach of duty by us, the Society and its officers shall not be responsible for any accident, damage or loss howsoever caused that may occur to any exhibitor or his servant or to any animal, article or property exhibited or brought on to the showground by him." Each exhibitor shall indemnify the Society from and against all actions, suits expenses or claims on account of or in respect of any such damage or injury however caused. **30.** The Society and it's officers shall not be responsible for any accident, damage or loss however caused that may occur to any exhibitor or his servant or to any animal, article, or property exhibited or brought onto the showground by him. Each exhibitor shall indemnify the Society from and against all actions, suits expenses or claims on account of or in respect of any such damage or injury however caused.

31. Insurance

By submitting an entry you indemnify the YAS that on or from the date of application up to and including the end of the Great Yorkshire Show the applicant will hold valid insurance to insure against loss or damage caused to any person or property to a minimum value of $\pounds 2$ million.

32. By submitting an entry you are confirming to the following:

You are stating that you understand, confirm and agree to the following statement:

"To the best of my knowledge and belief, the animal(s) I have entered is/are free from any clinical disease at the time of entry including Ringworm lesions. I further declare that all necessary precautions will be taken to prevent the said animal(s) from being exposed to infectious or contagious diseases from the time of entry to their arrival on the Showground.

Each and all of the particulars given are correct to the best of my knowledge and belief; that these animals are my own property; and that they are duly qualified, according to the Society's regulations and conditions, to compete for the prize or prizes for which they are entered.

To conform, as an exhibitor, to all the Regulations, Code of Conduct, Conditions and Orders of the Great Yorkshire Show; to hold the Society blameless in the event of any illness, loss or damage occurring to, or through, any animal I may enter or exhibit at the Show, or of mis-delivery of the same: and to indemnify the Society against any legal proceeding arising from any such illness, loss, damage or mis-delivery".

Disqualification, Sanctions and Exclusion Orders

33. Disputes

In the event of any dispute between you and any other person attending the Show (other than persons connected with, employed by or representing the Show/YAS) regarding any matter relating to the Show, the parties shall refer the matter to the Show Director or Chief Executive who will make a decision which shall be binding and exclusive.

34. In the event of a dispute between you and the YAS (or any officer, member, associate or employee of the same) the matter will be directed to the Show Director, in the first instance. The Show Director will, at his sole discretion, decide the appropriate procedure necessary to achieve resolution. The procedures available to the Show Director are contained in this section alone and by entering this agreement, you agree that the dispute resolution procedures contained herein will be final and binding on the parties.

35. Here the VAC be

• Upon the YAS becoming aware of any breach of this agreement (the Rules), the matter will be put before the Show Director who will, at his sole discretion, decide whether the breach is deemed to be Minor or Major.

Disputes under these Rules will be deemed to fall into 3 categories:

36. (a) Disputes arising out of Minor Breaches;

Minor Breaches The following examples are intended to be illustrative only and this list is not exhaustive. The Show Director will, at his sole discretion, determine whether any breach is Minor or Major:

- i. Procedural misdemeanours in pre-showing organisation;
- ii. Late arrivals for showing;
- iii. Any other act deemed to be a Minor Breach by the Show Director.

(b) Disputes arising out of Major Breaches;

Major Breaches The following examples are intended to be illustrative only and this list is not exhaustive. The Show Director will, at his sole discretion, determine whether any breach is Minor or Major:

i. Any act of cruelty to animals or acts that may cause suffering to any animal;

ii. Any act of dishonesty in competing, showing or exhibiting;

iii. Any other act that could reasonably be regarded as "cheating", to be determined by the Show Director;

iv. Any breach of any laws, statute, regulation, statutory instrument or bylaw from time to time in force governing any of the following: transport of animals/livestock, care of animals, presentation of animals, breeding of animals, prevention of disease in animals;

v. Any other act deemed to be more than a Minor Breach, as determined by the Show Director.

- (c) Disputes not relating to a breach of the Rules.
- **37. Disputes arising out of Minor Breaches** Disputes arising out of Minor Breaches will be dealt with at the hearing chaired by the Chief Executive or the Show Director. The decision of the hearing will be final and binding and there will be no right of appeal. No representation, legal or otherwise, will be allowed at such a hearing and submissions will only be heard from you.
- **38.** Sanctions handed down at a hearing regarding Minor Breaches will be limited to any of the following, singularly or together:

(a) Formal written warnings. Repeated breaches may lead to a matter being re-categorised as a Major Breach and will be dealt with accordingly;

(b) A fine of up to £1000 to be paid to YAS;

(c) A direction that you leave the Show immediately and not partake in any showing or competition for the remaining duration of that year's show. (N.B this will not impact on any Show, Prize or Remuneration already achieved, prior to the breach, and will not equate to a lifetime ban. Refusal to leave the Showground may constitute a Major Breach and will be dealt with accordingly);

- (d) An Order to forfeit prizes and prize monies.
- **39.** Disputes arising out of Major Breaches Disputes arising out of Major Breaches will be dealt with at a hearing, in private, chaired by the Chief Executive or the Show Director, in the first instance. Evidence will be heard from any witness(es) and submissions will only be allowed from you.
- **40.** No representation legal, or otherwise will be allowed at such a hearing.
- **41.** The hearing will make a decision which shall be binding on all parties.
- **42.** Decisions made in the first instance regarding Major Breaches will be subject to a right of appeal. Should you wish to appeal, you must set out your grounds (reasons) for appeal in writing and these must be lodged with the YAS Chief Executive within 48 hours of the first instance decision.
- **43. Appeals** Upon receipt of validly served grounds of appeal, YAS will form a panel of between 3-5 appropriate representatives to hear the appeal (The Appeal Panel). The panel may include Council Members, current and former Presidents and any appropriate expert as the appeal may require. The panel will set an appeal date to take place not before 28 days from the date of the first instance decision and elect a person to chair the Appeal Panel.
- **44.** The Appeal Panel at their discretion can appoint a suitably qualified person to provide the Appeal Panel with legal advice, if this occurs and only if this occurs you, the appellant, will be allowed legal representation at any future hearings.

All appeal decisions shall be final, binding and exclusive. By entering this agreement you agree that any decision of the Appeal Panel shall be final.

- **45.** The Appeal Panel may make any order to ensure the effectiveness and efficiency of the appeal hearing. This includes: the adjournment of the appeal hearing in order to gather further evidence; request further information or disclosure from you; an order that skeleton arguments or any other documents are provided by the parties to the Appeal Panel; and any other reasonable order. Failure to adhere to any reasonable order will be a waiver of your right to appeal and the first instance decision shall be enforced.
- **46.** At the Appeal hearing evidence may be heard from witnesses, both in person and in writing. Any witness whose evidence is in dispute must give evidence in person and any other parties will have the opportunity to ask further questions of that witness.
- **47.** Opening and closing submissions will be allowed from any party involved in the appeal.
- **48.** At the end of the appeal proceedings the Appeal Panel will make a decision. This may be in writing or verbally.
- **49.** Sanctions handed down at first instance hearing or any subsequent appeal hearing concerning a Major Breach will be limited to any or all of the following:
 - (a) A lifetime Exclusion Order preventing you from ever exhibiting and/or attending the Show;
 - (b) An Exclusion Order for a term of years prescribed by the first instance hearing or Appeal Panel at their discretion. (Any Exclusion Order prescribed by an Appeal Panel will be final and binding);
 - (c) An Order to forfeit of prizes and prize monies;
 - (d) A fine not exceeding £10,000 to be paid to YAS;
- **50.** Costs relating to Minor Breaches or Major Breaches, in the first instance, will be borne by the parties. An Award of costs in relation to appeal proceedings will be decided by the Appeal Panel at the conclusion of the appeal and in the event of a dismissal of the appeal may include any costs incurred by the YAS in relation to the appeal hearing.

51. Publicity and Data Protection

Yorkshire Agricultural Society is committed to protecting your personal data and processing it only in accordance with legal requirements. We process your personal data as it is necessary for the facilitate performance of our contract with you to your entry to the Show. We will not transfer your data outside of the EEA (European Economic Area) and will not share your data with third parties, except for our online system provider, Breed Societies and/or affiliated Societies and Equine Events, to whom we submit entries and results, to be checked for validity and eligibility based on their legitimate interests. Results will also be circulated with members of the Press and published on our website, this will include the names and town locations of exhibitors. We retain your data in accordance with our retention schedule to simplify future applications. The Society will retain the rights to photographs of any exhibitor or other person on the Showground and store and use the resulting image (including edited or altered versions) for any of the Society's commercial or non-commercial purposes in all and any media, including, without limitation, use in promotional materials and on the Society's website, or supply to carefully selected third parties for use for their own purposes. The Society shall own the copyright in any such images. For further details see our website www.greatyorkshireshow.co.uk/privacy/

52. Show Cancellation

If the Great Yorkshire Show was to be cancelled prior to its commencement, for reasons outside our control, all competitive entries would be refunded for the full amount paid. There will be no refund or payment for any consequential losses of the show cancelling.

Violent, abusive or threatening behaviour

The Society reserves the right to refuse entry to or remove from the Show anyone, including exhibitors or competitors, who are intoxicated, abusive or offer threats of violence to any person regardless of the circumstances. In such situations the Police may be called and the person or persons responsible will be removed from the Showground and may be excluded from future Shows and other events organized by the Society.

HORSES, PONIES & DONKEYS

The general conditions and regulations of the Show are also apply to this section.

Animals will be admitted to the Showground from 10am on Sunday 9th July unless a special arrangement has been made in advance.

Please note: Equine exhibitors (mounted or leading) must use Black Gate/Horse Walk at all times.

- 53. **Breed Society Regulations** All persons entering, competing or exhibiting an animal in a class affiliated to a Breed Society shall be deemed to have consented to the jurisdiction or the relevant Breed society and be subject to its constitution and rules (including disciplinary procedures)
- **54. Tickets** these will be allocated to exhibitors on the basis of TWO tickets/wristbands per entry/horse, e.g One horse in one class 2 tickets/wristbands; One horse in two classes 4 ticktes/wristbands. Tickets/ wristbands are valid for any ONE show day. Additional tickets/wristbands can ONLY be purchased in advance as tickets/wristbands will not be available to buy at the show (see Reg. 16)

One day tickets/wristbands will be sent out for the day of your class/es; if stables are booked and your tickets do not cover the following day, please contact the office for a removal permit (if you are a YAS member, this will allow you to collect your animal/s). Please remember stabling is provided for the convenience of the exhibitor. Tickets/wristbands will not be provided for sponsors on top of the allocation, although, as above additional tickets/wristbands can only be purchased in advance as tickets/wristbands will not be available to buy at the Show. (See Reg. 16).

55. Equine Flu The <u>minimum</u> requirement is two vaccinations, at least */ not less than*, 21 days apart. There must also be a clear 7 days after the second vaccination, before entry on to the showground.

It is <u>mandatory</u> that all other horses/ponies/donkeys must have received a booster within the 6 calendar months of their entry on to the showground.

Foals of 6 months of age or older must meet the Equine Influenza vaccination requirement. Foals of less than 6 months of age must be out of a mare that meets the above requirement. Passports may be inspected at any time; any horse/pony/donkey without a valid vaccination protocol or owner/exhibitor unable to produce a valid passport will lead to immediate eviction of that horse/pony/donkey from the showground.

- **56. Passports** all animals must be accompanied by a legal and currently valid passport. On arrival at the showground and prior to unloading your animal/s, please go to the Stable Managers Office (located near the Main Ring Collecting Ring) and present your passport/s in order for the Flu record/s to be validated. Passports must be inspected before any stabling can be allocated (if previously booked). Exhibitor numbers will also be available for collection at this point.
- **57. Equine Viral Arteritis** All exhibitors should read, understand and adhere to the common code of practice for Equine Viral Arteritis (EVA) as published by the Horse Racing Levy Board.
- **58. Judges Interest in Exhibits** Exhibitors are not permitted to enter any animal/s in the class which is to be judged by a person who has or who has had a financial interest in the animal/s, or which has stood in his/her stable. Stud fees are not considered to be financial gain. The onus of complying with this regulation rests entirely on the exhibitor.
- **59. Stallions/Colts** All stallions or colts, of three years or over, must wear a bit or chifney at ALL times whilst on the showground.

60. **Protective Headgear**

<u>All</u> riders of horses, donkeys or ponies on the showground or exercise areas are now required to wear head protection (hard hat) that conforms to the following revised standards for head protection for equestrian activities: All PAS 015; VG1; (BS)EN1384 2017; ASTM F1163 04a onwards; SNELL E2001; SNELL E2016; AS/NZS 3838 2003 onwards. Correctly secured Skill Caps/Riding Hats that meet one of the following current Safety Standards/Specifications MUST be worn by all Riders between the ages of 15 to 17 inclusive: All PAS 015; VG1; (BS)EN1384 2017; ASTM F1163 04a onwards; SNELL E2001; SNELL E2016; AS/NZS 3838 2003 onwards.

The most recent additions to the list are SNELL E2016 and EN1384 (2017); The newest version of the EN1384 Standard was effective from 2018. Helmets must be worn with chinstraps correctly and securely fastened at all times whilst mounted. This applies to all ridden competitions, demonstrations and whilst exercising.

61a. Refunds (Entry Fees)

Entry fees will only be refunded when a vet's certificate is supplied to the Society before noon on Monday 17 July 2023, stating that the animal is unfit to show and providing the full Exhibitor pack containing all wristbands, vehicle passes etc., are returned to the Livestock & Entries Department. Entries not forward for any reason other than illness or injury will forfeit all entry fees. Stable fees will not be refunded unless cancelled by **Friday 30 June**.

61. Refunds (Stabling)

Refunds for stabling can ONLY be made if stables are cancelled (in writing or email) **before noon on Friday 30th June,** to enable the office to re-sell the stable. Stables bought and sold anywhere other than through YAS will not be recognised. <u>*Please note*</u> : <u>Membership is</u> <u>non-refundable</u>.

62. Responsibilities of Equine exhibitors with reference to Class Timings

It is the responsibility of the exhibitor to ensure they arrive on the showground in sufficient time for the commencement of their classes. Any ring timetables publicized are provisional and may be subject to change. **The Society will not accept responsibility for any exhibitor missing their class(es) and under no circumstances will fees be refunded**.

63. Mares & Foals

Brood Mares must be shown with own foal at foot where the classification states "Brood Mare with own foal at foot". Mares that have lost their foals are not eligible.

Foals must be a minimum of six weeks old and born in the current season, or as otherwise stated in the breed section. Please contact the Livestock & Entries Dept. if your foal arrives late and is consequently too young to come to Show. At this point a refund can be requested; if exhibitor packs have been sent out, they or the relevant tickets would need to be returned (unused) for a refund to be processed.

64. Line Breeding

The Yorkshire Agricultural Society does not encourage "Line Breeding" and therefore will not accept entries that are "Line Bred".

65. Dope Tests

The Society forbids the administration of tranquilizers or other substances which may affect the behaviour or performance of any animal at Show. The Yorkshire Agricultural Society will uphold the rules of the recognized Breed Society in the respect of the administration of forbidden substances to show exhibits and will permit such Societies to carry out tests or inspections provided for in their rules.

In the event of any such test proving positive, Societies may be expected to take disciplinary action in accordance with their rules.

The Yorkshire Agricultural Society is also able to sample horses/ponies/donkeys independently from the Breed Societies.

Any action by you and/or your agent in contravention of this section or that inhibits the Society's Veterinary Officer or Breed Society undertaking any inspection of the animal shall constitute a Major Breach as defined in the section Disqualification, Sanctions and Exclusion Orders, and will be dealt with under the appropriate procedures contained therein.

Please note that if an exhibitor requests any form of test from our Veterinary team, payment must be made directly to the Vets at the time of the test being carried out.

66. Groom's Dress Code

Grooms/attendants appearing with animals in the judging rings must have suitable footwear and be dressed appropriately, i.e of smart appearance (NO JEANS/SHORTS). HATS MUST BE WORN IN THE RINGS, e.g Trilby type or riding hats are acceptable (NO BASEBALL TYPE HATS/CAPS). Any person not complying with this regulation may be asked to leave the ring by the Steward or the Judge.

67. Leading Animals

No person may lead more than one animal when moving on the showground.

68. Mobile Phones

The use of a mobile phone whilst riding or in charge of an animal is strictly prohibited.

69. Number of Entries in Classes

Where large entries are catalogued exhibitors may be asked to give individual shows in pairs and only the first twelve may be asked to strip and run up for the judge. The Society reserves the right to enforce a ballot system where entry numbers exceed allocated ring time or to meet with the Health & Safety requirements.

- **70. Ridings Ring** Where large entries are catalogued for any class held in this ring, classes may be split. This will be at the discretion of the Chief Steward.
- 71. **Substitution of Judges** The Society reserves the right to substitute other Judges for those named in the schedule or make additional appointments. Where time permits exhibitors will be informed of any changes; this will be on our website where possible.
- **72. Measuring** Animals entered in the Riding Pony Breeding classes will not be measured prior to entering the classes this year. Alle exhibitors with animals entered in classes with height conditions are advised to have an Annual or Lie Official Height Certificate issued by the Joint Measurement Board or those which are registered with a recognized Breed society. These certificates must be available should they be requested by a show OFFICIAL.

- **73. Animals at Show** In the interest of Health & Safety, when animals are out of their stables/ boxes, they must have approved bridles or headcollars which are fit for purpose and enable the handler to control them in the event of difficulty. It is requested all exhibitors refrain from exercising animals within the showground and use the exercise area provided. Horses, Ponies and Donkeys must enter the showground at Black Gate (off Railway Road) and use the designated Horse Walk at all times.
- **74. Stable Manager's Office** and Jumping Declarations Office is situated off Stock Avenue opposite the side of the Main Collecting Ring. This Stable Manager's office is staffed pre-show and during show from:

Sun 11am – 10pm | Mon 8am – 10pm | Tues - Thurs 6am – 10pm | Fri 6am - 7pm .

Stables must be allocated by the Stable Manager's office; this is in case of an emergency situation.

Please note: The showground does not have CCV facilities in the stable lines and therefore stables are booked entirely at the risk of the exhibitor.

- **75. Marking Sheets** may be used by the judges in the ridden classes throughout the Equine section. Unless specified by the Breed Society these will NOT be available to anyone other than officials of the society.
- 76. Age Classification For the purpose of the classification in this schedule, the following will apply:
 Yearling An animal born in 2022
 3 year old An animal born in 2020
 2 year old An animal born in 2020
 4 years or over An animal born in 2019 or before

The age of the horse/pony must be stated on the entry form in years; in the case of a foal, the date of birth is to be given. Failure to state the age of your animal as requested on the entry form may result in the entry being held up or returned.

77. Equine Welfare

Welfare is of paramount importance and all riders should be of an appropriate size and weight for the horse/pony being ridden (anywhere on the showground, exercise areas or vehicle parks, day or night). The Society reserves the right to take further action (See Disqualifications, Sanctions and Exclusion Orders) against any competitor or exhibitor whose animal is being ridden (anywhere on the show-ground, exercise areas or vehicle parks, day or night) by anyone whose size or weight compromises the welfare of the horse/pony being ridden; this would be based on the recommendations of the onsite veterinary team, who will use the 20% ratio as a guideline (this means the combined weight of rider plus their saddle should be less than 20% of the animal's weight). This would be based on a relatively fit, healthy animal, as an overweight animal is also a welfare concern.

This rule has been enhanced in the interests of welfare & probity in relation to the following classes:

Animals in classes 130, 131, 165, 166, 167, can only be ridden at all times by the child that is entered to ride it in the class. A substitute rider may ride the animal outside of the ring, but they must be eligible in age to compete in the class entered.

For example Class 130 M&M First Ridden - states "Suitable to be ridden by a child who has not attained their 12th birthday by 1st January in the current year".

Therefore, the age of the rider applies to the rider in the ring or anywhere on the showground, exercise areas or vehicle parks, at all times up to the relevant class.

Where an animal is entered in multiple classes, the respective restrictions apply up to the conclusion of each class and thereafter immediately pass to those regulations associated with the next class; at all times the general rule about riders needing to be appropriately sized to their mount, is applicable.

78. Whiskers/Sensory Hairs

All equines should present with no evidence of whiskers or sensory hairs having been trimmed or removed (other than for veterinary purposes, in which case you must provide written proof of a valid veterinary reason, from your Vet; this proof must be available at Show if requested by a Show Official). Sensory hairs are the hard hairs located on the horse's muzzle and around the eyes, also known as 'whiskers' that are used for sensation.

Following several enquiries regarding trimming of ear hair, as part of Reg.78 the hair on the internal aspect of the ear pinna should not be excessively trimmed as it performs a protective function against insects, sun and foreign objects. The Society may take actions against anyone who is in breach of any of our regulations.

79. Displaying Catalogue Numbers

All handlers and riders must display their catalogue number at all times when riding or working their animal anywhere on the showground, exercise area or vehicle parks, day or night.

80. Indemnity

By completing the entry you are conforming to the following: You are stating that you understand, confirm and agree to the following statement "To the best of my knowledge and belief, the animal(s) I have entered is/are free from any clinical disease at the time of entry and will be free from disease when they are brought to the Show.

I further declare that all necessary precautions will be taken to prevent the said animal(s) from being exposed to infectious or contagious diseases from the time of entry to their arrival on the Showground. Each and all of the particulars given are correct to the best of my knowledge and belief; that these animals are my own property; and that they are duly qualified, according to the Society's regulations and conditions, to compete for the prize or prizes for which they are entered.

To conform, as an exhibitor, to all the Regulations (General and Equine specific), Conditions and Orders the Great Yorkshire Show; to hold the Society blameless in the event of any illness, loss or damage occurring to, or through, any animal I may enter or exhibit at the Show, or of mis-delivery of the same: and to indemnify the Society against any legal proceeding arising from any such illness, loss, damage or mis-delivery.

81. The first and second prize winners in each class are invited to compete for the Championship.

THE 2023 GREAT YORKSHIRE SHOW HEALTH & SAFETY POLICY

This policy is a legal requirement and outlines the roles and responsibilities within the Yorkshire Agricultural Society (YAS) to ensure compliance with its statutory and moral obligations for health and safety at the Great Yorkshire show.

All Staff (permanent, temporary and contracted), Contractors, Exhibitors, Stewards, Judges and Visitors are expected to comply with the Show Health and Safety Policy and any legal obligations placed upon them.

This polity conforms to the Health and Safety at Work etc Act 1974, the Management of Health and Safety at Work Regulations 1999 and other relevant legislation including the Construction (Design & Management) Regulations 2015 (CM 2015).

Organisational Responsibilities

It is the overall responsibility of the Operations Manager to ensure the policy is implemented and individual responsibilities are fulfilled so far as is reasonably practicable. The Operations Manager will ensure all activities under the management and control of the YAS fulfil their statutory requirements with regard to health and safety at the Great Yorkshire Show.

The Operations Manager is responsible through effective planning in ensuring risks involved in work activities and control measures in place are communicated through a process of briefings and the provision of a staff and officials guidance booklet.

The Operations Manager will ensure locations under the control of the YAS and used in connection with the GYS are maintained in a safe condition, entrances and exits used for the movement of people, animals and vehicles are safe and without risk so far as is reasonably practicable.

The Operations Manager assisted by the Facilities Manager will provide up to date safety information for staff, exhibitors, contractors and visitors if individuals are exposed to new or increased risks or are exposed to any substance that may be hazardous to health. The use of all hazardous substances will be supervised by a competent person at all times.

The Facilities Manager is responsible for the management of all Facilities Department staff, contractors and their activities at and in connection with the Show.

Equine Exhibitors

The YAS reserves the right to suspend any activity or remove any contractor or exhibitor from the show ground if they are considered to be unsafe or indirect contravention of health & safety legislation or Show Regulations. All trade, equine, livestock and other exhibitors are responsible for ensuring that plant and machinery is safe and that safe systems of work are set out and followed particularly in respect of the movement of horses and livestock around the showground and they follow any directions given to them by YAS Stewards.

All exhibitors must ensure that thev maintain safe working environment and а safely that all articles, substances are stored moved, and used and that health and with. safety and fire safety legislation complied fails is Anv exhibitor who comply with health and safety or fire safety legislation may liable to to be action by NYC Environmental North Yorkshire enforcement Health and/or the Fire and Rescue Fire Safety Officer. Prize money will also be withheld and exhibitors may be removed Livestock and Equine exhibitors are that a from the Show. reminded show environment be extremely stressful for their animals and animals with unpredictable temperament or can character should not be brought to the Show.

Livestock and Equine exhibitors will be responsible for carrying out their own risk assessments for the control, movement and conduct of their animals at all times and in the case of livestock applying reasonable controls to ensure that they do not escape or pose a danger to the public whilst being moved around the Showground for grooming, washing, milking, exercise or during loading and unloading. Livestock must be under the control of a competent handler using approved restraints when being moved around the public areas on the Showground and into the judging rings and safeguards are in place to prevent an animal from escaping.

<u>First Aid</u>

First aid and medical facilities the Great Yorkshire Show at are provided by an approved medical contractor who will provide extensive coverage for the four days of the show. First aid points are clearly identified on the showground and on maps and in catalogues.

qualified All contracted medical personnel are first aid Emergency or Care Practitioners. Persons needing transported hospital care will be to Harrogate District Showground with a a dedicated Medical Centre on the Hospital. There is Doctor in attendance when the Show is open to the public. The medical contractor has trained staff at the Show to assist with adults and children at risk.

Emergency Procedures

In the event of a major incident during the Great Yorkshire Show the YAS/GYS emergency procedures will be put into effect. See supplementary document **GYS Major & Critical Incident Plan (2022, Revised).**

Fire Precautions

All staff, temporary workers, contractors and exhibitors must comply with the Show Fire Risk Assessments which conform to the requirements of the Regulatory Reform (Fire Safety) Order 2005. This includes persons in charge of activities within temporary structures and marquees including multi-occupancy units.

be All fire exits be clearly marked the to them will must and route kept clear at all times. No person shall place an obstruction in aisles, corridors or walk ways that are designated escape routes at any time. Fire extinguishers and other safety equipment will be located at easily accessible points and will be clearly visible and as fire safety equipment. person should attempt identified No to use fire safety any equipment which places themselves or others at risk. Fire safety equipment must not be moved or tampered with or used to prop open doors.

The use of naked flames, or any direct burning appliance is prohibited within multi-occupancy marquees and trade stand. This includes candles and other similar items of any type.

Any person who discovers a fire should dial 999 and inform Event Control or Black Gate Security Point when Event Control is closed.

To supplement any portable fire safety equipment carried on machinery or plant the YAS will have additional equipment on the site located in the Facilities Department.

Smoke Free Regulations/Policy

All enclosed and substantially enclosed areas on the Showground are Smoke Free (No Smoking; this includes the use of E-Cigarettes). This includes all permanent buildings, temporary structures, tents, marquees or similar, stables, cattle sheds, sheep, pig and goat lines and the Main Ring and White Rose Ring Grandstands.

Smoking is only permitted in open spaces on the Showground. Exhibitors who smoke in contravention of this regulation may be excluded from future Shows. The requirements apply to all smoking, including the use of e-cigarettes 24 hrs a day and the Safety Stewards/Security will be responsible for enforcing these regulations on behalf of the Society.

Vehicle Movements/Speed Limits on the Showground

Vehicle movements are not permitted on the Showground when the Show is open to the public except essential service and emergency vehicles. The <u>maximum</u> speed limit on the showground for any type of mechanically driven vehicle including ATVs and quad bikes is 20 mph unless indicated otherwise. This should not be exceeded under any circumstances and due care and consideration should be demonstrated by the drivers of all vehicles when the Show is open to the public, particularly in crowded public areas and when livestock and horses are moving or visible. In public areas if the volume of the public in these areas is so great as to be a hazard or risk to the drivers of mechanical vehicles they should not enter these areas until it is safe to do so.

The safety of the public and workers on foot is of primary consideration regardless of the purpose that the vehicle is being used for. A banksman must be used where any vehicle is required to reverse in a public area.

The use of All Terrain and Off Road Utility Vehicles is prohibited on the Showground unless they have been authorised for use by the Society.

Drivers must not be under the influence of alcohol or drugs (prescription or otherwise) and anyone considered to be a danger to themselves or others may be removed from the Showground or car parks and the Police will be informed.

Complaints in relation to the way a vehicle is driven on site should be reported to the Operations Manager, the Facilities Manager or Event Safety Officer.

Risk Assessment

A Risk Assessment has been prepared by the Society that identifies potential hazards that could pose a risk during the build-up, breakdown and when the Show is open to the public and the controls in place to remove or reduce the risks. A copy of the risk assessment is available on request from the Operations Manager.

The Risk Assessment is a legal document and will be made available in the event of any subsequent claim or investigation against the YAS or an exhibitor or contractor for negligence or damages arising from any act or incident at the Great Yorkshire Show.

Other Arrangements

Storage

Exhibitors or contractors are not permitted to store items or equipment on the showground particularly hazardous substances unless prior agreement has been reached with the Show and Trade Stands Coordinator prior to the Show or it forms part of the contractual arrangements for the Show. Any items that are stored must be stored in accordance with specific instructions outlined by the YAS and must be stored safely. Liquid Petroleum Gas (LPG) and other flammable items must be stored safely and at least 2 meters from a vehicle, building or structure. Exhibitors and contractors must ensure that the storage of any items or equipment does not contravene fire safety regulations.

Use of Barbecues

The use of barbecues by exhibitors or contractors is not permitted within the Showground perimeter unless they form part of a legitimate trade stand demonstration and the necessary safety controls are in place. The Shoe &Trade Stands Officer must be notified prior to the Show if a barbecue is to be used and approval given in writing. The use of barbecues in the cattle sheds is strictly prohibited.

Disposable and gas barbecues are not permitted in the Caravan and Camping areas or car parks under any circumstances as they are considered a serious fire risk.

Use of e-Scooters & e-Bikes

E-Scooters and e-bikes are not permitted on the Showground at any time. If they are used on the vehicle, caravan or camping parks riders are responsible for operating their vehicles safely and in accordance with the law, and they should check the legal status of their vehicles prior to arrival. The Yorkshire Agricultural Society accepts no responsibility for loss or injury resulting from the unlawful use of vehicles on site.

COVID-19 and other Public Health Measures

If are feeling unwell before attend the Show, must you you you stay at STOP home. If you feel unwell when the Show you are at what you are doing and go straight to the Medical Centre near White Gate.

FOR YOUR SAFETY

Please follow any health protection measures including COVID-19 that may be in place at the Show. These are outlined in the Visitor's Code of Conduct on the Show web site.

HEALTH PROTECTION STATEMENT

The Yorkshire Agricultural Society looks forward to welcoming you to the 2023 Great Yorkshire Show. In line with current government guidance on the admission of visitors to the Showground, the Code of Conduct acts to principally guide and advise you of any protocols in place during the event. The organiser's, the YAS has put in place a range of health protection measures to ensure the safety of all visitors to the Show. However, it is vitally important that everyone plays their part in making the event safe and enjoyable and we need your continued support and cooperation to achieve this. Visitors are therefore kindly reminded of the requirement to adhere to the Code of Conduct, and follow all safety requirements, to assist staff and stewards, and to help protect you and your fellow visitors.

Access around the Showground is by concrete or tarmac footpaths and roads. Some parts of the Showground are sloping and mainly grass which may be difficult for visitors with limited mobility and wheelchair users.

Evacuation & Safety Announcements

In the unlikely event of an evacuation of the Showground please follow any instructions given to you by Stewards, Officials or Police Officers or over one of the public address systems. You will be directed to vacate the Showground by the nearest exit and to go to the back of the car park opposite the exit to wait for further instructions, unless advised otherwise.

If a full or partial evacuation of the Main Ring and/or White Rose Ring Grandstands or the Exhibition Halls is required, an announcement will be made over the PA system in those areas.

Please listen carefully to any safety announcement which may direct you to a specific area on or around the Showground. Evacuation should be undertaken calmly and quickly taking any personal items with you. Stewards, the Police and Officials will direct and provide you with further information. Further announcements including updates via social media may be made explaining the nature of the incident and any additional action you may be required to take.

You should not attempt to re-enter the Showground or a building until you are advised to do so for safety reasons.

Health & Hygiene

Visiting The Great Yorkshire Show is an enjoyable and educational experience. However, such visits can never be free from all risks. Farm animals naturally carry a range of microorganisms, some of which may be harmful to people even when the animals appear clean and healthy.

Microorganisms such as E. coli O157 and Cryptosporidium are a particular health risk, especially for young children, expectant mothers, and the elderly.

Touching animals, consuming contaminated food or drink and contact with dirty surfaces may lead to infection if microorganisms are accidentally transferred into the stomach.

Washing hands thoroughly with soap and water immediately after contact with animals will reduce the risk of infection. Hand gels or wipes are not a substitute for washing hands with running water in an agricultural environment.

There are several permanent toilet blocks with washing facilities on the Showground and their locations are clearly indicated on the Showground map.

Always wash your hands thoroughly with soap and warm water after contact with any animal.

Animals have feelings too please respect them and keep a safe distance as a startled animal may well kick-out or bite!
