PLEASE NOTE THE FOLLOWING EXTRACTS FROM THE RULES AND REGULATIONS:

**VACCINATIONS:** All horses and ponies on Moreton Showground must have up to date Equine Influenza and Tetanus vaccinations. The requirement for the first 3 vaccinations is as follows: the first 2 vaccinations **21 – 60** days apart, a third booster between **100-180** days, and an annual booster vaccination within 365 days thereafter. Horses may compete having received the primary course and prior to the first booster but not within 7 days of receiving a vaccine dose. We strongly advise that due to the current Equine Influenza Outbreak that all equines are moved to 6 monthly vaccinations. **PASSPORT CHECKS WILL BE CARRIED OUT AT THE SHOW AND HORSE/PONIES WITHOUT THE CORRECT VACCINATIONS WILL NOT BE ALLOWED TO UNLOAD AND WILL BE ASKED TO LEAVE THE SHOWGROUND.**

**HORSE PASSPORTS:** A Defra acceptable equine passport must accompany all horses and ponies on showground; **SPOT CHECKS WILL BE CARRIED OUT.**

**TIMING:** Classes may commence at or after the published time. The Society will not be responsible for any loss where an exhibitor has made entries in more than one class and because of a time overrun it is not possible for him/her or the horse/pony to compete in one or more later classes. No claim for refund of fees paid or other loss, direct, indirect, or consequential will be accepted or paid.

**CONDUCT:** If a competitor's behaviour or actions are deemed to be inappropriate by the steward, judge, or any other show official, or it is believed that a competitor, or its groom's behaviour is impairing the welfare of the animal, **this includes someone riding an animal whose size and weight is compromising its welfare**, the Horse Chairman shall have the power to disqualify the animal and depending on the severity of the actions, ask the offender to leave the Showground and recommend that the Council shall refuse that person's entry for future Shows. Should an exhibitor be aggrieved at such action he/she may lodge an objection in writing. Such objections will be considered by a panel of not less than three members of the Society appointed by the Chairman or Vice-Chairman and their decision shall be final.

## **GENERAL SHOW RULES AND CONDITIONS**

The use of sub-headings as well as emboldened type in these rules is for ease of reference and does not affect the interpretation of the rules.

- 1. ENTRIES: -**
- 1.1 RULES: -** Every exhibitor making entries for the show shall be deemed to have agreed to abide by these rules and it is on this understanding only those entries are accepted.
- 1.2 ENTRIES: -** All entries must be made on the Society's on-line entry system [www.moretonshow.co.uk](http://www.moretonshow.co.uk) before the dates specified in the Schedule.
- 1.3 CLOSE OF ENTRIES: -** On-line entries may be closed at any time after the published date – please check website.
- 1.4 RIGHT OF REFUSAL: -** The Council reserves the right to refuse any entry.
- 1.5 WITHDRAWAL OF CLASSES: -** Except where British Show Jumping Rule 76.14 applies, in the event that there are less than six entries in any class at the date of closing, such class may be withdrawn, in which case the entrants will be advised, and their entry fees returned. Rule 76.14 may be applied where there are fewer than 4 starters.
- 1.6 NOMINATION ENTRIES: -** These will not be accepted.
- 1.7 ESSENTIAL ACTION: -** Exhibitors will comply with any directions or instructions given to them by the Society which the Society deems to be expedient.
- 1.8 RESTRICTED LIABILITY: -** In the event that a class or classes are cancelled by the Society (whether or not the Show takes place) then the maximum compensation due to an exhibitor will be a refund of the entry fee(s) paid by the exhibitor in respect of the class or classes that have been cancelled.
- 1.9 QUALIFYING CLASSES: -** Competitions qualifying for events organised by other bodies are offered in good faith on information provided by those bodies. No liability is accepted by this Society if those events take place in circumstances other than those originally stated or do not proceed.
- 2. OWNERSHIP: -** Exhibits in all classes must be the bona fide property of the exhibitors and all exhibits must have been the property of, and in the possession of, the exhibitors at the time of entry. Any person who has care and control of an exhibit on the Showground will be deemed to be the Agent of that exhibit's owner for all purposes connected with that exhibit.
- 3. ENTRY/STALLAGE AND PENNING FEES: -**
- 3.1 SEE SPECIAL CONDITIONS: -** Entry/stallage and penning fees must accompany entries. The entry/stallage and penning fee for any animal entered and not exhibited will be forfeited. Any additional costs incurred by the Society arising from non-clearance of a cheque must be paid by the exhibitor before he/she is allowed to compete.
- 3.2 INTEREST: -** Interest upon sums due to the Society under these Rules shall be payable at the rate of 3.5% above the base rate charged by Lloyds Bank from time to time and shall be payable commencing 14 days after the published date for the close of entries in the relevant section.
- 4. PASSES: -** See Special Regulations applying to the appropriate section.
- 5. JUDGES: -**
- 5.1 APPOINTMENT: -** A list of Judges for the forthcoming Show shall be nominated by the Council.
- 5.2 DEPUTY: -** In the event of a Judge or Judges failing to attend on Show Day, the Secretary or Chief Steward may appoint a Deputy or Deputies.
- 5.3 JUDGES' INTEREST IN ENTRIES: -** Exhibitors are particularly requested to note the name of the Judge appointed for the Classes they wish to enter, and are advised, in the interest of all concerned, not knowingly to enter an animal bred by, or that has been owned by, the Judge appointed. In cases where the Judge has a continuing business or financial relationship with an exhibitor, he/she should not judge the animal(s) entered by that exhibitor, whether or not the particular animal(s) form part of the business relationship. Where the Judge has had a past financial or breeding interest in a particular animal(s), he/she should not judge it. In the event of a Judge having an interest in any exhibit(s) then he/she shall first judge and place all other exhibits and an alternate Judge, if possible, from the Breed panel, shall then place the exhibit(s) in question. The alternate Judge shall be nominated at the absolute discretion of the Society through the Chief Steward of the Section.
- 6. STEWARDS: -** An exhibitor cannot act as Steward in any class in which he/she has an entry.
- 7. OBJECTIONS: -** The decision of the Judges shall be final. Objections of any kind must be made in writing and delivered to the Secretary making clear that it is an objection which is being handed in. A deposit of £60 shall be paid with each objection which must be made within one hour of the Judge's decision being given on the day of the Show; in the case of a joint objection a deposit shall be payable by each objector. Such objections will be considered by a panel of not less than three members of the Society appointed by the Chairman or Vice-Chairman and their decision shall be final. Anonymity will not be available to any objector. The deposit may be forfeited at the discretion of the panel.

- 8. HEALTH & SAFETY:** - The Organisers of this Show have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, everyone must take reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the Organisers and all Officials and Stewards. It is a condition of entry that exhibitors conform to the requirements of the Society's Safety Policy and of the Health and Safety at Work Act 1974 and for ensuring that safe working practices are followed by themselves, their employees, Agents, and Contractors. (See also Cattle Regulation on Cattle Handling). A full copy of our Health and Safety policy can be found on our website.
- 9. UNRULY ANIMALS:** - All animals must be controlled to the satisfaction of the Stewards who shall have power to exclude from the Showground any vicious or unruly animals. Animals with a previous record of unruly behaviour should not be brought to the Showground.
- 10. LIABILITY:** - The Council will not be responsible for any error which may appear in the Catalogue or for any entry being made in the wrong class, nor will the Council be held responsible for exhibits not arriving in time to be judged. The Council do not hold themselves responsible for any loss, injury or damage to any persons or exhibit at the Show, and it shall be a condition of entry that exhibitors hold the Society blameless and indemnify it against legal proceedings there from.
- 11. CONDUCT: -**
- 11.1 BEHAVIOUR:** - In the event of a competitor, or anyone connected with a competitor, being guilty of improper or abusive behaviour towards his or her animal, any Official of the Society, or the general public, the Chairman or Chief Steward shall have the power to order the offender to leave the Showground and recommend that the Council shall refuse that person's entry for future Shows. Should an exhibitor be aggrieved at such action he/she may lodge an objection in writing. Such objections will be considered by a panel of not less than three members of the Society appointed by the Chairman or Vice-Chairman and their decision shall be final.
- 11.2 ANIMAL HEALTH: -**
- 11.2.1** If any exhibitor brings an animal to the Showground suffering from a contagious disease all his animals may be sent home and future entries from him may, by resolution of the Council, be refused.
- 11.2.2** Unfit or diseased animals may be sent home.
- 11.2.3** In any case concerning the health or well-being of an animal, the decision of the Society's Veterinary Officer shall be final.
- 11.2.4** The Society deplors the administration of substances not naturally occurring or abnormal quantities of natural substances to animals or humans intended to alter their behaviour in the ring ("doping"). Certain of the Societies to which the Show is affiliated, or under whose rule's classes are held, set conditions regarding doping and dope testing and all entries in such classes are subject to those conditions.
- 11.2.5** Any animal showing signs of infectious disease or appearing to be about to give birth or abort will be isolated until the Show Veterinary Surgeon (if necessary, in consultation with the Divisional Veterinary Manager) permits its return to the farm of origin.
- 12. PRIZES:** - Prize cards will be given to all winners and prize money paid out in the Horse Secretary's Tent. For late classes only please claim from the Show Office before 30th September. Prize money not claimed will be forfeited. Trophies must be left on the showground on show day.
- 13. DATA STORAGE & PUBLICITY:** - The rules & regulations in the schedules should be read, and when the exhibitor has ticked the consent box on the entry form, either paper or online, the Society will use the information as follows: Store, process and retain, including electronically, all data and personal information provided by exhibitors for the purposes of operating the Show, maintain appropriate records and communicating with exhibitor in future concerning any of the Societies activities. Information about exhibitors and their animals may also be provided to DEFRA, Trading Standards, County Council departments, BCMS, SAC, breed societies and others having regulatory functions as well as the Society's veterinary, environmental health, legal and safety advisers. Publicise the names and home locations (Town & County only) of exhibitors in Show catalogue and on Society website. Information about results may also be published and/or provided to the press and breed societies for publication. Photograph any exhibitor or other person on the Showground and store and use the resulting images for use in the Society publications, the Society will own the copyright of such images.
- 14. CONTRACT:** - The contract between an exhibitor and the Society shall be made at Moreton-in-Marsh.
- 15. SPECIAL REGULATIONS:** - applicable to any Section and any special class conditions shall be deemed to be part of these General Conditions. In the event of a conflict, then the Special Regulations shall prevail.
- 16. LEGAL COMPLIANCE:** - Exhibitors shall comply with all relevant Statutes and Regulations.

## SPECIAL REGULATIONS APPLYING TO ALL HORSE CLASSES IN ADDITION TO THE GENERAL SHOWING RULES

1. **ENTRIES:** - No horse may be entered in both a Hack and Hunter or Riding Horse Class. No Horse which has been nicked or docked may be shown.
2. **ENTRY FEES:** - All entry fees are inclusive of VAT.
3. **RESTRICTED ENTRIES:** - It may be necessary to restrict entries in any class if warranted; accordingly, entries may have to be accepted on a first come first served basis.
4. **CANCELLATION OR COMBINING OF CLASSES:** - The society has the right to cancel or combine classes due to insufficient entry numbers. A full refund will be given if a class is cancelled due to insufficient entries.
5. **AFFILIATION:** - In any Class or Section which is affiliated to a Governing Body it shall be a condition of entry that exhibitors, whether or not members of that Body, shall comply with its Rules and will be liable to dope testing.
6. **TICKETS, PASSES & NUMBERS:** - The first horse entered will receive 3 wristbands, each additional horse on the same ENTRY will then receive 2 wristbands. These wristbands will need to be worn to gain access onto the showground from the Horse Car Park.  
**Exhibitors will be emailed QR coded horse vehicle passes and exhibitor tickets prior to the event.** Exhibitor packs with wristbands and numbers will be available for collection from the secretary's tent on show-day. If you have ticked the box for owners traveling separately then two owner admission tickets will also be emailed out prior to the show. Additional tickets can be purchased through the show website. Personnel not holding tickets will be charged normal prices at the pay on foot entrance gate.
7. **PARKING:** - **QR CODED VEHICLE PASSES WILL BE ISSUED TO EXHIBITORS AND ONLY VEHICLES WITH THESE PASSES WILL BE ADMITTED INTO THE DESIGNATED HORSE PARKING AREAS.** Vehicles other than horseboxes will not be admitted into the Horse Parking areas – but can park for free in the Public Car Parks. Your Vehicle pass must be displayed to get access into the Horse Parking areas.
8. **SUBSTITUTION:** - Substitution of animals in place of those already entered but unable to be exhibited is NOT allowed, except where BS rules permit.
9. **REFUND:** - The entry fee for horses unable to be exhibited after entry owing to accident or illness will be refunded if written notification accompanied by a Vet's Certificate is received before the Show (scan acceptable), except where British Show Jumping rules apply. Any levy which has been or is to be paid to Horse of the year Show, or any other organization will not be refunded. An administration fee will be charged. No refund will be made if the exhibit is found to be ineligible to compete, whether for want of registration or otherwise, nor if duplicate entries are made. No entry fees will be refunded should the exhibit be unable to attend the show due to any Animal Health Order issued by DEFRA.
10. **STYLE:** - Horses must be ridden astride in all classes except Side Saddle.
11. **HARD HAT:** - On the showground and for all classes, anyone riding a horse or pony must wear headgear to current BSI or European Safety Standard specification, or of a standard approved by the governing body of their respective horse or pony society.
12. **PRIZE MONEY:** - Prize money will be paid out from the Horse Secretary's Tent. For late classes only please claim from Show Office before 30th September. Prize money not claimed will be forfeited. Prizes may be withheld if in the opinion of the Judge the exhibits do not reach the standard required.

13. **TROPHIES:** - No trophies to be taken off the showground. They will be awarded and then given back to the Horse Ring Steward. Photographs of winner with the trophy will be available at no charge.
14. **LOCAL CLASSES:** - Open to exhibitors residing or farming within a 20-mile radius of the Showground. Local exhibitors will need to wear a white arm band to show that they are a local exhibitor in Open classes. Any part of the exhibitor's regular holding coming within the area entitles him to show. The words "regular holding" to mean Ownership, Tenancy or Lease. Show officials shall not be held responsible for acceptance of entries which may prove out of area.
15. **JUDGING:** - If the judging of the number forward in a class may exceed the time allowed for that class, at the Judge's discretion it is regretted that it may not always be possible for the Judge to ride each horse or for every competitor to be allowed an individual show.
16. **FALL:** - If a rider falls off a horse in a class, the rider is not allowed to remount in the ring and the horse is eliminated from the class. No judge or steward has the authority to waive this rule. The rider is permitted to compete on other horses entered in the class, unless the medical services personnel or judges' rule this unsafe. The horse is permitted to compete in other classes in which the horse has been entered unless the vet advises otherwise.
17. **TIMING:** - Classes may commence at or after the published time. The Society will not be responsible for any loss where an exhibitor has made entries in more than one class and because of a time overrun it is not possible for him/her or the horse/pony to compete in one or more later classes. No claim for refund of fees paid or other loss, direct, indirect, or consequential will be accepted or paid.
18. **LUNGING:** - This is not permitted anywhere on showground. Anyone found lunging will be disqualified from their class and asked to leave the showground.

- 19. AMATEUR:** - Amateur Status – a person is an Amateur for the purpose of classes run under Society Rules if he/she does not, during the current or previous season:  
Engage in showing livery/production, buying, selling, dealing or hiring of horses in any commercial capacity, or owning/standing a stallion at stud, teaching or coaching, as means of deriving a source of income.  
Receive remuneration, whether it be monetary or goods in kind, for employment in the connection with horses in showing livery/production, teaching or coaching, (instruction at Pony Club and Riding Club excepted). This Rule does not include the suppliers of ancillary services in equestrianism, such as farriers, vets, therapists or administrative office roles.  
Show a Horse owned or sponsored by a company or a commercial firm or show a Horse for which his/her immediate family accepts showing livery production or training charges, from a person outside the immediate family concerned, in any showing classes, Sport Horse Breeding (GB) or otherwise.  
Act as a Brand Ambassador, in any showing classes, Sport Horse Breeding (GB) or otherwise.  
A competitor is not eligible to compete in Amateur classes on an Exhibit, which has been ridden by a Professional Rider in ANY class, Sport Horse Breeding (GB) or otherwise, with the exception of Working and Side Saddle classes, during the current year and the following year, up to and including the Royal International Horse Show.  
NOTE: Novice horses ridden by a Professional before the 1st January 2026, will not be affected by the rule changes, and therefore will be eligible to compete in Amateur classes during the 2026 Show Season".  
(The above Rule, 3e(v), does not apply, if the Horse has been Professionally Produced and ONLY ridden by a Showing Professional, during the previous season, or if the horse has subsequently been sold and re-registered under new Ownership).  
If you ride/compete equines on a regular basis, which you do not stable at home, your Amateur status will be reviewed by the Board/Council, i.e., if you ride / compete multiple equines or ride regularly for one or more owners, you could be deemed professional.  
At any time whilst on the showground, where an Exhibit is going to be competing in Amateur classes, Showing Professionals, including Professional Show Grooms, are not allowed to ride, work-in (in any form), teach or coach the rider/horse, compete, or enter the Ring to groom/strip the Horse.  
Amateur Owner/Rider Classes: Open to Horses owned and ridden by an Amateur. No Showing Professional, including Professional Show Grooms, are allowed into the ring to groom/strip the Horse, with the exception of Amateur Working Hunter Classes where ALL Amateur's including Amateur Home-Produced can receive professional help when walking the course and warming-up in the Collecting Ring for the jumping phase only – no professional assistance is permitted during the flat ridden /ride section of the class.  
Amateur Home-Produced Classes: Open to Horses, which are either stabled at home or in a D. I. Y. yard, assisted livery permitted, and which since 1st January in the current year, have not been shown by a Professional during the current season or stabled in a Professional yard at any time in the current year. To be ridden by an Amateur. This does not exclude Amateur Owner Home Produced riders having lessons at any time with an instructor, providing the Horse remains stabled at home. No Showing Professional, including Professional Show Grooms, are allowed into the ring to groom/strip the Horse. We may require a statement of your eligibility to compete in Home Produced classes.
- 20. MOBILE PHONES:** - The use of mobile phones is not permitted within the collecting and judging rings.
- 21. VACCINATIONS:** - All horses and ponies on Moreton Showground must have up to date Equine Influenza and Tetanus vaccinations. The requirement for the first 3 vaccinations is as follows: the first 2 vaccinations (primary course) **21 – 60** days apart, followed by a first booster **within 6 months and 21 days** of the 2<sup>nd</sup> primary course vaccination, and an annual booster vaccination within **12months** thereafter. Horses may compete having received the primary course and prior to the first booster but not within 7 days of receiving a vaccine dose. We strongly advise that due to the current Equine Influenza Outbreak that all equines are moved to 6 monthly vaccinations. **PASSPORT CHECKS WILL BE CARRIED OUT AT THE SHOW AND HORSE/PONIES WITHOUT THE CORRECT VACCINATIONS WILL NOT BE ALLOWED TO UNLOAD AND WILL BE ASKED TO LEAVE THE SHOWGROUND.**
- 22. HORSE PASSPORTS:** - A Defra acceptable equine passport must accompany all horses and ponies on showground; **SPOT CHECKS WILL BE CARRIED OUT.**
- 23. CONDUCT:** - If a competitor's behaviour or actions are deemed to be inappropriate by the steward, judge, or any other show official, or it is believed that a competitor, or its groom's behaviour is impairing the welfare of the animal, **this includes someone riding an animal whose size and weight is compromising its welfare**, the Horse Chairman shall have the power to disqualify the animal and depending on the severity of the actions, ask the offender to leave the Showground and recommend that the Council shall refuse that person's entry for future Shows. Should an exhibitor be aggrieved at such action he/she may lodge an objection in writing. Such objections will be considered by a panel of not less than three members of the Society appointed by the Chairman or Vice-Chairman and their decision shall be final.
- 24. PUBLIC LIABILITY INSURANCE:** - Anyone making entries should ensure there is adequate public liability insurance cover for the animals entered. By submitting an entry, you indemnify the Moreton Show Society that on, or from, the date of application up to and including exit from the showground, the applicant will hold valid insurance to insure against loss or damage caused to any person or property to a minimum value of £5 million.

- vi. Horses should be turned out in a traditional manner as per their breed society rules, tail plaits including wool are optional, flights/standings are not permitted.
- vii. For Clydesdale horses, they are to hold a Clydesdale Horse Society passport with full pedigree details, stallions and mares are to appear in the main section of the Clydesdale Horse stud book. Geldings are to have appeared as produce of their dam if they have not been issued with a Clydesdale Horse Society Passport.
- viii. Horse Turnout: Plain noseband and browband with snaffle or traditional double or pelham bit. No bitless bridles, running gags or Liverpool bits are permitted.
- ix. If shod, only normal shaped shoes that do not cover the frog are permissible. Shoes must be fitted to the circumference of the foot and give maximum support at the heels.

Judging Guidelines:

- i. Ride judges may be selected from the BSHA full judge's panel or one of the appropriate Heavy Horse Breed Panels (Suffolk Horse Society, Clydesdale Horse Society, The Shire Horse Society and The British Percheron Horse Society).
- ii. Conformation judge to be selected from those on one or more of the appropriate Heavy Horse Breed Panels (Suffolk Horse Society, Clydesdale Horse Society, The Shire Horse Society and The British Percheron Horse Society).
- iii. Judges may only judge one qualifier during the current year.
- iv. At the final marks must be awarded in the following way. Qualifiers should be marked in the following way:

Ride	50 maximum
Breed type and conformation	50 maximum

In the case of equality, the horse with the highest conformation mark will be deemed the winner. If there still be equality at this point, then the judges' decision will be final.

To be judged 25% conformation and action, 25% manners and way of going, 25% rider, and 25% turnout of horse & rider. Judges may request a short show, but exhibits; but horses will not be stripped. Traditional habits must be worn. Fancy Dress and Period Costumes NOT permitted. NB Silks Hats are permitted to be worn in this class AT ANY TIME OF THE DAY. Judges must use the mark sheet provided.

The highest placed horse/rider combination qualifies for the Final to be held at the National Side Saddle Show. In the event of previous qualification, the Qualification Card may be passed down to fourth place. The highest placed horse/rider combination qualifies for the Final to be held at the National Side Saddle Show. One special rosette and the qualification card will be given to the qualifying combination adult each show, this may not always be the winner. If the winner has already qualified they may be passed down to fourth place. Qualifiers kindly sponsored by Mrs. T. Mitchell and Mr. L. Mitchell. Qualifying combinations are required to become Full Members of the SSA 21 days prior to the National Side Saddle Show or as soon as possible if qualified after that date to be eligible to compete at the Final. Combinations qualifying between one National Side Saddle Show and the next may carry forward the qualification, for that year only.

The course for this competition comprises six vertical obstacles placed in a straight line with two non-jumping strides between each obstacle. In indoor arenas the first two obstacles may be placed on one straight line and the last four obstacles on a different straight line. The top element and fill of each obstacle must be poles only. No obstacle may be set at a lower height than the obstacle preceding it. The competition is judged under Table A not against the clock with a time limit of two minutes. In the event of a disobedience, the competitor must restart the course at the obstacle where the error occurred but may make his/her approach at an angle from outside the space between the obstacles and is not required or allowed to take any of the previous obstacles again. If an obstacle is disturbed as the result of a disobedience, the procedure in Rule 251.4 must be applied, but no time penalty is incurred. In the event of equality of faults for first place there will be up to four successive jumps-off not against the clock. The first jump-off must be over all six obstacles, but the course may be reduced progressively for each further jump-off to a minimum of three obstacles by removing in succession first, second and third obstacles. The Judge at his/her discretion may terminate the competition after the third jump-off. In the event of equality of faults in the final jump-off competitors are placed equal and divide the prize money. Competitors who withdraw from or retire during a jump-off are placed equal with those who are eliminated in the same jump-off (Rules 203, 204).

### **63. THE HAYMAN-JOYCE PAIRS RELAY CHALLENGE**

The competition is run under the following rules.

1. Competitors must be a minimum age of 12 years on the day of the competition
2. All hats must be of current BSI or European Safety Standard. We strongly advise all competitors wear back protectors of a current BETA 2018 level 3 standard.
3. Cross country colours or hacking jackets should be worn. No jewellery, watches or stop watches allowed. No electronic recording devices are permitted on horse or rider.
4. All ponies and horses must be over 5 years of age and be up to date with their vaccinations as outlined in front of schedule. Passports should be made available if requested. We reserve the right to carry out spot checks on passports.
5. Whips must not exceed 75cm in length.
6. Each competitor must carry their own insurance.
7. Each team must have two team members, with the team being made up of two individual riders and horses.
8. **Payment of £60.00 PER TEAM** A refund of £10 per team will be made in cash on show day, upon return of the number bibs to the Horse Secretary tent. Deposits will not be refunded to teams not forward.
9. **Declarations must be made in person to the Horse Secretary's Tent between 8.00am and 11.00am on the day of the Show. Teams will receive their coloured number bibs (1 yellow, 1 white) when they sign their declaration form. It is the Team members responsibility to ensure that they are wearing the correct coloured bib that they have put their name to on the declaration form.**
10. This competition will take place as a Baton Relay Knock Out Competition in which two teams each consisting of two competitors compete over separate courses simultaneously. The course will consist of obstacles and fences at a maximum height of 85cms.
11. The draw will be made at the close of declarations, and the drawn order will be displayed in the Collecting Ring shortly thereafter.
12. Both members of each team enter the arena together.
13. The start will be supervised by a judge. Choice of course will be decided between the two teams by the starting judge tossing a coin.
14. The first competitor from each team jumps the course and then completes the cup obstacle, before the **whip must then be passed to the second member of the team whilst both competitors are behind the start line.** The second competitor then jumps the course, completes the cup obstacle and crosses the start line to finish.
15. Failure to pass the whip behind the start line incurs elimination of the team. If the whip is dropped, the competitor must dismount (without penalty) and recover the whip before continuing their round or passing the whip to the next member of the team. Failure to do so will result in elimination.
16. **Outside assistance is not allowed at any time. No personnel other than the riders are allowed into the arena. Failure to abide by this rule will result in the team being eliminated.**
17. Any fall will result in elimination of the team. **Riders are not allowed to re-mount before being cleared by medical personnel.**
18. First and second disobediences/refusals during the round are not penalised, except by the time lost. Third refusal by an individual during a round will result in elimination of the Team.
19. A time penalty of 5 seconds will be given for any knock downs of fences. A time penalty of 20 seconds will be given if the cup is dropped during the cup obstacle.
20. The winner from each pair of teams proceeds to the next round of the competition. This continues until the final four pairs compete in the semi- final. The winning pairs proceed to the final and the two losing pairs will then compete against each other for 3<sup>rd</sup> place prior to the final.
21. In the event of equality between teams, one member of each team will jump again against each other.

22. The judges' decision is final, and they may disqualify any rider at any stage in the competition for dangerous riding, inappropriate behaviour, misuse of whip or spurs, ill treatment of the horse or if in their opinion the horse is lame, sick or exhausted.
23. The Organising Committee of Moreton Show horse committee reserves the right to make any changes/ amendments to the competition or rules.
