This event ("Show ") is organised by the Newark & Nottinghamshire Agricultural Society (the "Society") is held in accordance with the Memorandum & Articles of Association and the Regulations of the Society which are binding on all Exhibitors ("exhibitors", "competitors", "trade stand exhibitor") and others attending the Show. Copies of the Memorandum & Articles of Association and Regulations are held in the Society Office.

Exhibitors should read carefully all the documentation in relation to exhibiting at the Show including the *Exhibiting Conditions and Guidance*, *Show Regulations* and *Information* and *Exhibitors Code of Practice* which are listed in the Schedule of Classes document and available on the Show website.

Where appropriate, competition schedules are issued subject to the Orders & Advice of DEFRA (The Department for Environment, Food & Rural Affairs) and any Local Authorities which may be operative at the time of the Show. Traders and trade stand exhibitors should carefully read the *Trade Stand Regulations* available on the Show website or within the Stand Booking information.

By making an entry or booking a trade stand, the Exhibitor is agreeing to comply with all the Society Conditions & Regulations and is irrevocably consenting to the storage and use of the information provided in catalogues, show guides, circulation to the media and regulatory authorities such as Trading Standards.

Membership of the Society is annual from either 1st January to 31st December or 1st July to 30th June the following year. Membership includes entry to all Society Shows on production of a valid Membership badge. Membership is not transferable for any reason and must be presented by the named individual at the time of entry. All Memberships are valid for one year and there are no pro-rata refunds should you wish to terminate membership prior to its expiry. Renewal information will be sent in the post or emailed to you ahead of the Membership year.

The Society reserves the right to postpone or cancel the Show, or any particular section or event, if the Council of the Society resolves that the holding of the Show, or section or event, is impractical or not in the interest of the Society or for any other cause beyond the control of the Society, including, but without limitation, Act of God, Governmental Act, legislation, regulation or request, fire, accident, war, riot, strikes, lock-outs, trade disputes or labour problems, or inability to obtain adequate labour or materials or sufficient number of entries

GUIDANCE FOR EXHIBITORS

Conditions of Entry and Show Regulations

Exhibitors should read carefully the 'Guidance for Exhibitors' at the front and the 'Show Regulations and Information' at the back of this schedule.

Please Note: by making an entry, the exhibitor is making an agreement to comply with all the Newark & Nottinghamshire Agricultural Society Conditions & Regulations.

Entry Closing Date: 16th September 2026

Club Stand Closing Date: 20th August 2026

Entries

Entries can be made either online or by paper. Online entries are free of charge and can be accessed by going to the Show website, **www.newarkvintagetractorshow.com** and selecting the 'Exhibitors' page. On this page there will be a link to take you through to Showing Scene, our online entry system. If you entered the Show online between 2021 – 2025 you will already have a Showing Scene account set up and should sign into the same account using the same email address.

To assist exhibitors who do not have online access, we are making paper entries FREE until the 31st July 2026 only. Thereafter until close of entries, there will be a £5 admin charge with all paper entries which must accompany the entry form by post only. Paper entries will only be accepted on the 2026 Newark Vintage Tractor & Heritage Show paper entry form. Entry forms MUST be completed in full, signed and the handwriting must be legible.

Why do we charge a £5 admin fee after 1st August? All paper entries must be inputted and stored on our online show system, Showing Scene. The admin of paper entry forms is an added process to the small team in the show office, therefore online entries help us to manage a large volume of entries.

Family Entries

Exhibitors from the same household/address should enter under one name, e.g., Smith Family or Mr & Mrs Smith. Every exhibitor pack is a cost to the show. Each household can enter multiple exhibitors and exhibits under one username/account. Wristbands will be allocated on a per household basis.

Prizes:

Rosettes will be awarded to 1st and 2nd places.

Annual trophies will be awarded in some classes and presented at the Awards Presentation in the Sir Stuart Goodwin at 6:00pm on the Saturday evening of the Show.

If trophies are taken away from the Showground, it is requested that they are returned by August the following year to the NNAS office, Newark Showground. All 2025 trophy winners need return their trophy by Friday 7th August 2026.

Wristband allocation - exhibitors

Each exhibitor will receive complimentary entry wristbands as listed below:

1 tractor/exhibit	2 wristbands
2– 3 tractors/exhibits	3 wristbands
4 or more tractors/exhibits	4 wristbands

Wristband allocation - Club Stands

Each Club Stand will receive complimentary entry wristbands as listed below:

6m frontage x 6m depth pitch	3 wristbands
9m frontage x 6m depth pitch	4 wristbands
12m frontage x 6m depth pitch – limited space available	5 wristbands

Extra exhibitor wristbands

Any other passes required for friends and family will be heavily subsidised at £21 for a weekend wristband if purchased alongside your entry or before 30 October 2026. Children under 16 are free to enter the show. Wristbands are valid for both days of the show and must be always worn whilst on the Showground.

Wristbands are not for re-sale. Anyone found to be selling exhibitor wristbands will have their entries withdrawn without any fees being refunded. After 30 October 2026, you can only purchase additional exhibitor wristbands at the show cabin for £27 for the weekend where you will collect the rest of your passes and direction where to site your tractor.

Arrival & Departure for Exhibitors Only

All exhibitors **must wear a High Visibility Jacket or Vest during build up and breakdown of the Show.**

Purple Gate will open for exhibitors only on **Friday 6th November from 8am – 7:30pm hours**. Entry on Saturday morning is via Purple Gate from 7am – 8am only. No vehicle movement will be allowed while the Show is open to the public. **There will be no entry before 8am Friday 6th November.** Arrival out of these times needs to be agreed by prior arrangement with the Show

Manager. Exhibitors with multiple loads can drop off into a holding area from 1pm Thursday 5th November, again, by prior arrangement with the show manager. Please note no security will be onsite and exhibits will not be allowed into the main show area before 8am Friday 6th November.

The Show is open to the public between 9am & 5pm on Saturday 7th November and 9am & 3.30pm on Sunday 8th November.

Show Breakdown: Sunday 8th November 3:30pm until 7pm
Monday 9th November 8am until 12pm

Check-in and Check-out

On arrival at Purple Gate, exhibitors will need to check-in their exhibits and pick up their exhibitor packs. Packs will only be given to the named exhibitor and must be collected in whole. It is requested that exhibitors arrive with their exhibit wherever possible. A pass-out system will be running over the weekend to monitor exhibits leaving the Showground, more details will be provided with your exhibitor pre-show information.

Unloading & Parking

If you require the unloading ramp, you must inform the check-in steward when collecting the exhibitor pack prior to unloading.

Exhibits are to be unloaded on arrival. Exhibitors are welcome to sheet down their exhibit, but the sheet must be removed by 8.30am on both days of the Show.

Any exhibits arriving outside of the set-up times will be directed to park in a holding area, for unloading during set times. Under no circumstances should any exhibit be unloaded outside these times.

Tracked or Metal Wheeled Vehicles & Machinery

Tracked or Metal Wheeled Vehicles & Machinery must not drive or manoeuvre on the tarmac roads within the showground, tracked or metal wheeled vehicles are to be unloaded directly on to their exhibitor location.

Tracked or Metal Wheeled Vehicles & Machinery are not permitted to enter or be exhibited in the George Stephenson Exhibition Hall (GSEH) or Lady Eastwood Centre (LEC). NNAS reserve the right to ask anyone who does not adhere to this request to leave the Showground. Exhibitors of tracked or metal-wheeled vehicles located in other halls must seek advice from Stewards on arrival and before unloading. Road bands are preferred on metal-wheeled tractors.

Tractor Locations and Judging of Entries

Details of where your entry is to be in the show will be provided with your exhibitor pre-show information after entries close. It is important not to move from this position so that your class judge can find your tractor. Any exhibit that is not in its correct location will not be judged.

Exhibit numbers must be displayed clearly to help your class judge identify your exhibit.

If you wish for your exhibit to be located on a Club Stand, **please enter the show first and then apply directly to the Club to be on their stand**. Otherwise, your entry will be in the class it is entered. All Clubs are responsible for nominating which exhibits are on their individual Club stand.

The Society reserves the right to move exhibits if it sees fit to do so. In these instances, judging sheets will be amended.

Exhibitor Camping

Exhibitor camping must be pre-booked with your entry or by 30 October 2026 at the latest. Exhibitor camping passes are £27.50 per pitch, which includes camping for Friday, Saturday and Sunday nights and use of the Showgrounds camping facilities. If hook-up is required, this is an additional £36.00. Camping is only permitted in the exhibitor camping area. Exhibitors camping in commercial vehicles with sleeping accommodation separate to the cab, must buy an exhibitor camping pass. Please note if you withdraw, the exhibitor camping pass will be non-refundable from 30 October 2026.

Newark and Notts Agricultural Society members exhibiting at the Show are eligible for 1 complimentary exhibitor camping pass as part of our membership benefits package. If you would like to join and support the Society, membership can be purchased through Showing Scene with your entry. Single membership is £50 and Joint membership is £75. Please note that 1 membership option = 1 complimentary exhibitor camping pass.

Personal Protective Equipment (PPE) including High Vis Jacket or Vest must be worn when working in and around the tractor movement areas and displays as well as during build up and breakdown of the show.

EXHIBITORS CODE OF PRACTICE

This Code of Practice has been prepared on behalf of the Newark and Nottinghamshire Agricultural Society (NNAS) for guidance of those exhibiting tractors, commercial vehicles, stationary engines, horticultural equipment, military, plant equipment and other equipment pertinent to exhibitors and the exhibitor themselves at any NNAS organised event held at the Newark Showground.

All Exhibits (Tractors, Lorries, Vans, Cars, Stationary Engines, Horticultural, etc.)

1. Any vehicle (including exhibits) movement is prohibited on the showground when the public are present, unless authorised and instructed to do so by a steward or event organiser (for example a tractor parade).
2. A full and valid driving license must be held by anyone moving a vehicle (including exhibits) on any part of the Showground and the driver must be competent and familiar with the vehicle.
3. Exhibits driven on the showground must follow the highway code unless authorised and instructed to do so by a steward or event organiser.
4. Unless specifically designed otherwise, a tractor should only carry one passenger, no additional people on a tractor unless there is a specific seat for passenger.
5. The unloading and loading of exhibits should only take place in specified areas and should not take place when the public are present. Loading of tractors onto vehicles must be completed in the correct manner and all strapping and lifting must be undertaken by a qualified and competent person. If members of the public are present, then the driver/ unloader must halt their activities and call for a steward.
6. When movement is permitted, the speed limit for all vehicles (including exhibits) on the showground is 10mph (walking pace).
7. Exhibits must display (in a visible location), their show number at all times whilst on the showground.
8. To prevent accidental starting, all keys and/or starting handles for exhibits must be removed by the exhibitor during the open period of the event.
9. At all times when an engine is running it must be supervised by the owner or their representative. No under 18s can supervise an exhibit without written permission from the organisers.
10. Those in charge of exhibits should at all times show a careful and responsible attitude, setting a good example to the general public.
11. Exhibits (apart from Stationary Engines, static Horticultural equipment and displays) should be covered by appropriate Road Traffic Act insurance and if driven on the public highway be fully taxed.
12. An exhibit with working lights must use them when it is dark.
13. Exhibits should only be used to move other implements on site if they are suitable and correctly manufactured to do so.
14. Personal Protective Equipment (PPE) must be worn when working in and around the tractor movement areas and displays i.e., Hi viz and correct footwear etc.
15. All exhibits on display either inside a hall or outside must use the drip trays provided where required. Drip trays are available on loan on request from the relevant steward.
16. Exhibits with non-working brakes must be chocked once in position.
17. All hydraulic rams must have a suitable ram stop in place during the event. Any raised loader or raised implement using hydraulics must have a ram stop fitted in the correct position to prevent the uncontrolled lowering/ dropping of the loader or implement due to loss of hydraulics for the duration of the display.
18. Members of public are not allowed inside the allocated barriered enclosure of any exhibits.
19. The loading and unloading of stationary engines should take place within the confines of the appropriate allocated enclosure or as otherwise directed by the Event Organiser or steward.
20. Stationary engines shall be located at least 2m (6 ft) from the enclosure fencing or barrier. There shall be at least 1m (3 ft) between adjacent exhibits.
21. Engines should not be used in such a way or for any purpose for which they were not originally designed or could reasonably be envisaged.
22. As far as is reasonably practicable engines should be arranged so that any exposed flywheel is parallel to the enclosure barrier.
23. Refuelling must take place in a safe manner, all spare fuel must be stored securely away from the engine and be stored in the correct type of container. LPG cylinders should be stored upright with their valves uppermost, outdoors in well-ventilated areas, away from flammable materials, corrosive materials, and other combustible substances. A minimum of 3 meters should separate propane/butane cylinders from other gas cylinders.
24. To help support our trade stands, exhibitors are prohibited from selling at the showground unless you have received written pre-authorisation from the Newark and Nottinghamshire Agricultural Society. The society reserves the right to remove anyone that does not adhere to the code of practice or issue an on the spot fine.
25. Club stands can only sell club membership and their own branded merchandise on club stands with written pre-authorisation from the Newark & Nottinghamshire Agricultural Society upon submitting a risk assessment and public liability cover to a minimum of £5 million. Tractor/machinery parts, scale models, tools, 'other' branded merchandise, etc cannot be sold on club stands. Clubs wishing to sell parts, models, etc. should apply for a trade stand for this element of their stand space. The society reserve the right to remove anyone that does not adhere to the code of practice.

REGULATIONS & INFORMATION

Please observe the following for the smooth running of the Show, your safety and enjoyment of all who visit the Show in any capacity.

Exhibitor responsibilities.

1. Responsibility

The Newark & Nottinghamshire Agricultural Society, its officers, and servants, shall not be responsible to any person whatsoever whilst entering on, or leaving the Society's premises, for any damage or loss, however caused to the property of such person, or for any injury, fatal or otherwise, to any such person. The Society, its officers and servants shall not be responsible for any accident, damage, loss however caused that may occur to any exhibitor or his employee or to any animal, article, or property brought into the showground, or whilst entering, or on leaving, or being carried into or out of the said showground. The exhibitor shall be solely responsible for any loss, injury, or damage that may be done to, or occasioned by, or arising from any animal, article or property exhibited or brought into the showground by him/her and he/she shall indemnify and hold harmless the Society from all action, suits, expenses and claims on account of, or in respect of any such damage or injury which may be so caused or occasioned.

2. Conduct of exhibitors and their employees

Exhibitors will be held responsible for the behaviour of any person accompanying them to Show, and for the consequence of any misconduct of such person. Any fine imposed upon an exhibitor or his/her employee/family member/friend for infringing the regulations, or disobedience to the order of a steward shall be recoverable from the exhibitor as a debt due to the Society, and until such fines be paid shall debar the exhibitor from exhibiting at future Shows of the Society. The Newark & Nottinghamshire Agricultural Society expects all exhibitors to always observe best practice.

Entries

4. Entries will be accepted through our online entry system, Showing Scene or on the official entry form.

Information from entry forms will be stored on a computer and the name, address and details of entries will be published in the Catalogue unless otherwise advised in writing to the Society. Information about results may also be published and/or provided to the press and clubs for publication.

Information about exhibitors may also be passed to any regulatory authority such as Trading Standards.

The making of an entry is irrevocable consent for the storage and disclosure of information in this way.

6. Entries for special prizes

Exhibitors are not required to enter for Special Prizes unless stated. Only exhibits which have competed in ordinary classes are eligible for entry into Special classes.

7. Substitution of entries

Substitution entries can be made but the Show Office must be informed before the close of entries.

8. Closing Date for entries

Please refer to the closing date at the front of this schedule. Entries received after the closing date of entries will not be accepted.

9. Correctness of entry

Exhibitors will be held responsible for the correctness of their entry and must check all entry details when confirmation is sent. If the exhibitor fails, when called upon by the Stewards or Officers of the Newark Vintage Tractor & Heritage Show, to prove the correctness of such entry, the entry may be disqualified, and any award made to it will be forfeited. If it shall be proved that any exhibitor or competitor has knowingly signed an incorrect entry form or has attempted to obtain a prize by unfair means whatsoever, all awards made to such an exhibitor or competitor in any class or competition may be cancelled and he/she may be disqualified from exhibiting at future Shows of the Society. For the purpose of online entries, by accepting the NNAS terms and conditions at the point of confirming their entry an exhibitor or competitor is 'signing' their entry form.

10. Ownership

All exhibits shall be the bona fide property of the Exhibitor at the specified closing date except where the regulation is varied by any condition applicable to specific classes stated in the Schedule. In the event of death of an owner between the date of entry and the date of the Show the executor of the deceased or personal representatives of the deceased will be deemed to be the exhibitor.

11. Entry by minors

Entries by persons under 18 years of age shall be accepted only provided the rule and regulations of entry are agreed by the parent, guardian, or trustee of the entrant, who shall be held responsible for the correctness of the entry and for the compliance with the Show's Regulations.

15. Right to reject entries

The Council of the Society reserves the sole right to reject or cancel the entry or entries made by a person, if it shall deem fit to do so, and right to cancel any class or classes, refunding any fees paid in respect thereof.

16. Cancellation of entries

The Newark Vintage Tractor and Heritage Show reserves the right to cancel or amalgamate any class in the event of there being insufficient entries or exhibitors in the Class - details listed under each section, or to transfer entries to another Class.

17. Nomination of entries

Nomination entries are not accepted.

18. Accuracy of catalogue

The Society will not be responsible for any inaccuracy in any exhibit details or other particulars inserted in the catalogue, though every care will be made to ensure the accuracy of all particulars printed therein. The Society accepts no liability for incorrect details when entries are made online.

Tickets

20. Wristbands - exhibitors' passes

Each exhibitor will receive tickets in the form of wristbands as listed at the front of this schedule. Allocated wristbands are complimentary and are not for re-sale. Anyone found to be selling exhibitor wristbands will have their entries withdrawn without fees being refunded. Wristbands must be worn at all times when on the Showground.

21. Extra entry wristbands

Extra entry wristbands may be purchased in advance through our online entry system for £21 each before 30 October. All wristbands ordered with the submission of entries will be within the Exhibitor Information Pack that must be collected from the Show Team cabin on arrival at the Showground.

22. Vehicle Passes

Exhibitors will be issued with one complimentary vehicle pass; this pass will admit the vehicle only. Please display passes visibly in your vehicle's windscreen. Exhibitors may be issued with additional vehicle passes at the discretion of the Show Manager, applications must be put in writing clearly before the close of entry.

Additional or support vehicles without a vehicle pass will not be admitted into the respective parking area and sent to the public car parking area or away from the Show.

23. Withdrawal of entry

Withdrawal of entry should be given in writing or by email to the show team on show@newarkshowground.com. In the event of a withdrawal, you will not receive the complimentary wristbands, nor will refunds be actioned for purchased wristbands, camping pass or hook ups after 30 October 2026. If you have to withdraw but would still like to use the camping pass and hook up, you must first purchase 2 x adult weekend tickets on the show website, and we will then issue the camping pass.

Awards

26. Rosettes

When the judging of the class has been completed by the Judge, the Judge will display class rosettes on prizewinning exhibits. Annual trophies will be awarded in some classes and presented at the Awards Presentation in the Sir Stuart Goodwin at 6:00pm on the Saturday evening of the Show.

28. Protests

Any Exhibitor wishing to lodge a protest having reference to an exhibit at the Show must make the same in writing to the Society Office and must deposit a sum of £50. All protests must be delivered at the Society Office on the Showground before 3pm on the day on which the protest shall have been made, or in the case of an award judged later than that time, then within one hour of the completion of the judging of that section, and no protest will be accepted subsequently unless a satisfactory reason be assigned for the delay. Protests will be considered by the Chief Steward in consultation with the section stewards. If the Chief Steward is unable to resolve the protest, then he/she will refer the matter to the Society's Appeals Committee. The decision of the Appeals Committee shall be final and if the protest is not substantiated then the deposit will be forfeited. The exhibit, to which the protest refers, must remain on the Showground until permission to leave has been obtained from the Show Office in writing. The Society reserves the right to refer any objection to any authority or organisation to adjudicate, wholly or in part, in respect of an objection, on behalf of the Society.

29. Alteration of awards

In case of any protest made in accordance with Regulation 28 whereby any prize exhibit becomes disqualified, or does not meet the criteria of the class and becomes disqualified, the winner of the next succeeding prize in that class shall take the prize that had been awarded to the disqualified exhibit. This applies to all prizes awarded.

31. Challenge trophies

Cups and Trophies awarded at the Show will be presented at the awards presentation in the Sir Stuart Goodwin at 6:00pm on the Saturday evening of the Show. Winners of trophies must give the Society a written guarantee to return the cup in good condition, to the Showground not less than six weeks prior to the next Show and that, in the event of loss, the amount of its value be made good to the Society by the holder. Any exhibitor who ignores this ruling will be charged a sum sufficient to the value of the trophy plus an admin charge and the cost of any engraving. The Society will not be held responsible for any failure on the part of donors, or others, to produce Cups or Special Prizes offered for competition in the Schedule or Catalogue, nor will the Society accept any

liability in respect of the description of Trophies and Special Prizes as printed in the Schedule and Catalogue. The Society reserves the right to prevent any cup or trophy from leaving the Society's premises. Prize winners must insure their cup or trophy whilst in their possession.

Judging

32. Judges

The Judges decision is final.

33. Substitution of judges

The Society reserves the right to substitute other Judges for those announced or to make other appointments.

34. Change of judge

Should an exhibit be forward for competition which was either restored, or previously owned by the officiating Judge, then a referee may be introduced at the request of the Chief Steward. The onus of declaring an exhibit being exhibited in a class judged by a person who has had a financial interest in it, or which has stood in his/her premises, etc, must be on the exhibitor. If there is an unforeseen change of judge, then the exhibitor should stand down from the class and entry fees will be refunded.

Health and Safety regulations

37. Smoking

Smoking is strictly forbidden in all buildings, temporary structures and communal areas. This includes E-Cigarettes.

39. Health and safety at work regulations

All exhibitors and their families, friends or employees must comply with the Health & Safety at Work Act 1974. Exhibitors are reminded that they are responsible for the observance, by themselves, their employees, and their contractors, of all Health and Safety at Work Regulations. Any item of risk or hazard should be reported to the Chief Steward or Society Office immediately.

Insurance

40. Public liability insurance

Exhibitors should ensure that they have appropriate public liability insurance cover (suggested minimum of £5 million).

General

50. Stoves

Exhibitors are not permitted to cook on an "open fire". Heating or cooking appliances are not permitted to be installed or used inside a tented structure or building which is not specifically set out for this purpose.

51. Stewards

No person shall officiate as Steward at the time of judging of a class in which he or she has an exhibit. In the event of a Steward making entries after his or her appointment as Steward, the Chief Steward shall appoint a deputy Steward to carry out stewarding duties for the class in question.

52. First Aid

There is a designated Medical Centre on the Showground where First Aid will be available.

53. Dogs/Pets

Well behaved dogs/pets are permitted on fixed short leads only and must be friendly. Dogs are not to be left tied on leads in any areas on the Showground including trade stands. Any dogs showing aggressive behaviour will be asked to leave the Showground. No dogs are to be left unaccompanied in vehicles, if found reasonable attempts will be made to rescue the dog. Please be a responsible dog owner and clean up after your dog.

54. Cancellation or Termination of the Show

If by reason of force majeure, severe adverse weather conditions, water-logged ground, failure or neglect on the part of any utility supplying electricity or water, labour strife, civil commotion, war (or threat thereof), act or threatened act of terrorism, fire or explosion or any other event beyond the control of the Society (other than a shortage of money or shortage of materials) the Society deems it necessary for it to cancel or terminate the holding of the Show or any part of it, then the Society shall use its reasonable endeavours to ensure that the Exhibitor is made aware as soon as practicable of such cancellation or termination either in writing, by email, verbally by telephone or mobile, or by publication on the Society's website(s).

In the event of cancellation or termination pursuant to clause above, this Agreement shall determine automatically, and the Society shall repay to the Exhibitor all, charges and fees already paid under this Agreement (if the Show is cancelled before its commencement) or a rateable proportion of such charges and fees (if the Show is terminated after its commencement) but otherwise shall be under no liability to the Exhibitor or its sub-licensees for any loss which they may sustain in consequence of any such determination and the Exhibitor shall in the event of determination be under no liability to the Society in respect of its future obligations under this agreement (but without prejudice to any rights of either party against the other in respect of any claim accrued under this Agreement down to the date of such determination).

55. Penalties

Any infringement of any of the Regulations or Conditions printed in this Schedule will result in the exhibitor forfeiting any prize to which he/she may be entitled in addition to the consequences attaching to the infringement and the Society reserves the right to inform other Agricultural Societies and bodies of any decision it may come to regarding an exhibitor.

56. Interpretation of Regulations

The Newark & Nottinghamshire Agricultural Society reserves the sole and absolute right to interpret these or any other prescribed regulations, conditions, and prize lists, and to settle arbitrarily and determine all matters, questions, or difference in regard hereto, or otherwise arising out of, connected with incident to the Show. Also, to substitute Judges, refuse and to cancel entries, disqualify exhibitors, prohibit exhibition of entries, vary, or cancel awards of prizes or reserve numbers and relax conditions as the Society may deem necessary.

57. Statement

All exhibitors and other persons admitted to the Showground shall be subject to the rules, orders, and regulations of the Council of the Newark & Nottinghamshire Agricultural Society. The Organisers of this Show have taken reasonable precautions to ensure the health and safety of everyone present. In order for these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the Organisers, and of all Officials and Stewards.

Drones

58. Prior Approval

- All drone operations require prior approval. Operators must contact the Show Team in advance and obtain permission from the Society before attending site.

59. Registration & Certification

- Operators must provide valid CAA registration details (Operator ID) and, where applicable, a Flyer ID.
- CAA Operational Authorisation must be provided where required, for example flights near crowds or higher-risk operations.

60. Insurance

- Operators must hold valid Public Liability Insurance, typically with minimum cover of £5 million.

61. Risk Assessment & Documentation

- A site-specific Risk Assessment and Method Statement (RAMS) must be submitted, detailing hazards, control measures, emergency procedures, flight areas and crowd separation.
- A Flight/Operations Plan must also be provided, including take-off and landing areas, flight paths, heights, timings and crew positions.

62. Pilot Competency

- Evidence of pilot competency must be provided where applicable, such as a GVC qualification for authorised operations.

63. Permissions & Airspace Compliance

- Operators must have permission from the event organiser/landowner for take-off and landing.
- Evidence must be provided of airspace checks, including NOTAMs, nearby aerodromes and restrictions affecting the event.

64. Operational Requirements

- All drone operations must comply with CAA regulations and be conducted safely, maintaining appropriate separation from people, structures and restricted areas.

65. Enforcement

- The event Health & Safety Officer may stop any drone activity immediately if it is deemed unsafe or non-compliant. Failure to comply may result in removal from site.
