The Organisers of this Show have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents and must obey the instructions of the Organisers, Officials and Stewards.

Any exhibitor wishing to enter a protest must do so in writing to the Secretary, accompanied by a deposit of £20. If the protest is not sustained, the deposit may be forfeited. If the protest is upheld and any award winner becomes disqualified, the winner of the next succeeding award will take the award of the disqualified winner and the lowest award shall go to the reserve award. No protest can be accepted after the conclusion of the Show, nor will any protest be accepted until all the horses in the particular class have left the ring. This does not affect the protest procedures for affiliated classes.

SHOWING CLASS AFFILIATION RULES

This show is affiliated to the National Pony Society (NPS). Classes 36, 37, 39 to 44 & 46-51 are qualifiers for the **NPS Summer Championship Show** (5th - 7th August 2025) to be held at the Three Counties Showground, Malvern. These classes are judged under the Rules of the NPS. Ponies must be registered in any of the British Riding Pony studbook sections or the Ridden Register; the GSB; the AHSB; the AASB, or registered in the main body of their respective M&M Stud Book. Part bred are not eligible unless over-stamped into one of the British Riding Pony studbook sections. or the Ridden Register. Qualifying rounds for most NPS competitions are open to ponies owned by NPS members and non-members but only ponies owned by adult NPS Qualifying or Life members are eligible to qualify for the final of the competition at the NPS Summer Championship Show at Malvern from **5th - 7th August 2025**. **The highest placed pony, if owned by an NPS member, in each class will qualify for the final. Qualification may pass down to third place if the first and second ponies are already qualified.** NPS/WTJ Insurance Brokers Ltd Home Produced Ridden Championship - Riders of Home Produced ponies (see definition in the NPS Rules Book) can wear a white arm band in classes where this is indicated. These ponies, if owned by NPS members, are then eligible to qualify for the final at the NPS Summer Championship Show. The Owner's Membership cards **MUST** be produced in the ring when requested or the qualification will be forfeit.

Classes 63,65 & 67-70 are qualifiers for the NPS/ Kalusta Stud British Riding Pony (Show Pony) In Hand Supreme National Championship & NPS/Team Charlesworth British Riding Pony (Show Hunter Pony) In Hand National Championship. Both the highest placed Show Pony and the highest placed Show Hunter Pony, if owned by an NPS member, in each class will qualify for the final. Qualification may be passed down to 3rd place if the 1st and 2nd placed ponies have already qualified.

NPS Silver Medal Rosette Championships: These classes are judged under the Rules of the NPS. NPS Silver Medal Rosettes are only awarded when the owner of the champion pony is a **Qualifying or Life** member of the NPS. A valid membership card must be in the rider's/handler's possession on entering the ring and be produced immediately on request by either the judge or the steward. If the owner of the Champion pony is not a member, or the owner's membership card is not immediately produced, the rosette may be awarded to the Reserve Champion provided they have the required membership card. If the Champion pony has previously qualified it is still entitled to the Silver Medal Rosette, but the qualification card goes to the Reserve Champion pony, provided the owner of that pony is a member of the NPS. The Silver Medal Rosette and the qualification card can be awarded no lower than first Reserve (third). Foals are not eligible for Silver Medal Championships. Qualifiers are entitled to compete in the final of the Silver Medal Rosette Championship to be held at the NPS Summer Championship Show **5th – 7th August 2025**.

This show is affiliated to The Shetland Pony Stud-Book Society and "Best Shetland" rosettes will be awarded in **classes 39 & 44** providing the exhibit is registered with the society.

Exhibits in Classes 56 & 57 must be fully paid-up members of the International Miniature Horse and Pony Society Ltd (IMHPS) Horses registered with IMHPS and placed 1st to 3rd in both classes qualify for the Miniature Horse of the Year Show to be held in October 2025 at Keysoe College, Bedford.

This show is affiliated to the British Show Horse Association (BSHA)

BSHA RISING STAR DIRECT QUALIFIERS FOR FINALS AT LONDON INTERNATIONAL HORSE SHOW (18th – 22nd December 2025) - Classes 1-6 qualify for LIHS BSHA Rising Star Supreme Finals at the London International Horse Show, highest placed unqualified in top five to qualify. A results points table will run for all qualifying classes and a 'wild card' will be awarded to those unqualified with the highest points in each section following the final qualifier. The Judge will NOT ride exhibits in these classes or at the Finals.'

This show is affiliated to the British Skewbald and Piebald Association (BSPA)

Classes 25-28 & 58-61 are qualifiers for the BSPA World Championships of Colour National Championship Show to be held at The College EC, Keysoe, Beds, in September 2025.

BSPA classes are open to members and non-members with Skewbald and Piebald horses and ponies only. Only members can qualify for WCC. These classes are affiliated to the British Skewbald and Piebald association and are qualifiers for the World of Colour National Championship Show. All classes will be judged within the rules and criteria of the BSPA. Copies of the rulebook and membership/horse registration/over-stamping forms can be obtained from their show office 01354 638226 or downloaded from www.bspaonline.com. All stallions 4 years and over must be graded licensed and registered with BSPA in order to compete, BSPA bridle discs to be worn). To in order to qualify all owners/handlers/riders must be members of the BSPA and all horses/ponies registered with BSPA prior to the show. BSPA qualification cards must be produced in the ring and be signed by the judge, otherwise qualification is invalid.

This show is a qualifier for TSR Showing Finals. All In Hand & Ridden classes are qualifiers. You do not have to be a TSR member to qualify or enter a final. The Rider/Handler qualifies and can enter any horse/pony in any number of Finals. The 4 highest placed handlers/riders will qualify in each class. Competitors MUST have their qualification flyer signed by judge/steward/secretary. Flyers are available free from the website: www.theshowingregister.co.uk

This show is a qualifier for the SSADL Home Produced In -Hand & Ridden 2025 Qualifiers

Comprising of: The London International Horse Show 1st Round Sponsored by Easy Chip Ltd; Members Open Challenges; Members Mountain & Moorland Challenges; Members Lead Rein/First ridden Challenges; Members Foreign Breeds Challenges; Senior Of Year Championship. Home Produced Qualifiers are OPEN to both Members and Non-Members of SSADL No Spurs with the exception to senior side saddle riders, No Galloping or canter extensions, Foals are NOT permitted SSADL Classes. For In-Hand Classes- Minimum age of handler = 11 years old. STALLIONS- Either for In Hand or Ridden classes, Competitors Must be 16 years of age or over. The same rider/handler/pony/horse combination must stay the same from qualifier to Grand Finals, unless special circumstances should arise, then it will be left to the discretion of the Directors and Advisory Committee to oversee this rule if required.

2025 Qualification System: SSADL Members will receive their own qualification card. This is to be signed in the at time of judging/presentation. This is the members' responsibility to ensure the right qualifier is signed for.

IMPORTANT: Equine Influenza:

In order to attend the 2025 Stithians Show all horses & ponies must have been vaccinated for Equine Influenza to comply with the requirements of the primary course (1st vaccination and then 2nd vaccination between 21 – 92 days later), followed by the first booster (150 – 215 days) and all subsequent boosters. Horses may compete having received the primary course and prior to the first booster but not within 7 days of receiving a vaccine dose. Horses must have been vaccinated within 6 months before the show but not less than 7 days of arriving at the show. Foals In-foal mares that have already had vaccinations of primary Equine Influenza course should be vaccinated 4-6 weeks before the foal is due to be born. Foals should be vaccinated for Equine Influenza at 6 months to commence their primary course. We urge all owners to adhere to strict biosecurity protocols at all times. Vaccinations are subject to local risk assessments by the attending veterinarians. Please note that neither vaccination certificates nor passports should be sent to the show office prior to the event. RING 1

LIHS RISING STAR RIDDEN HORSES Judge: Mr C Yates, Essex

Open to members and pre-registered non-members, 15 yrs and over, eligible under Rising Star Amateur rules. - BSHA Rising Star Direct Qualifiers for Finals at London International Horse Show. Qualification will be confirmed by email once BSHA membership is completed within 14 days of qualification.

CLASS 1: RISING STAR SMALL HACK / RIDING HORSE

Mare or gelding, 4 years old and over, exceeding 148cm. Hacks not to exceed 154cm and Riding Horses not to exceed 158cm. Rider to be 15yrs or over. *The highest placed unqualified horse in the top 5 will qualify for the LIHS BSHA Rising Star Supreme Small Hack/Riding Horse Supreme Final at the LIHS in December. In addition, the two highest placed unqualified horses will qualify for the Associate Rising Star Hack/Riding Horse final at the BSHA National Championships Show in September. Associate Rising Star Qualification Cards will be awarded in the ring. **Horses are only eligible to qualify for the Small OR Large section, not both, please only enter either the Small or Large section.***

CLASS 2: RISING STAR LARGE HACK / RIDING HORSE

Mare or gelding, 4 years old and over. Hacks to exceed 154cm but not exceeding 160cm. Riding Horses to exceed 158cm. Rider to be 15yrs or over. *The highest placed unqualified horse in the top 5 will qualify for the LIHS BSHA Rising Star Large Hack/Riding Horse Supreme Final at the LIHS in December. In addition, the two highest unqualified placed horses will qualify for the Associate Rising Star Hack/Riding Horse final at the BSHA National Championships Show in September. Associate Rising Star Qualification Cards will be awarded in the ring. **Horses are only eligible to qualify for the Small OR Large section, not both, please only enter either the Small or Large section.***

CLASS 3: RISING STAR SMALL / LIGHTWEIGHT HUNTER

Mare or gelding, 4 years old or over, (Lightweight exceeding 158cms, Small Hunter exceeding 148cms, but not exceeding 158cms). Capable of carrying up to 79.5kgs (12 stone 7lbs). Rider to be 15yrs or over. *The highest placed unqualified horse in the top 5 will qualify for the LIHS BSHA Rising Star Small/Lightweight Hunter Supreme Final at the LIHS in December. In addition, the two highest placed unqualified horses will qualify for the Associate Rising Star Hunter final at the BSHA National Championships Show in September. Associate Rising Star Qualification Cards will be awarded in the ring.*

CLASS 4: RISING STAR MIDDLEWEIGHT / HEAVYWEIGHT HUNTER

Mare or gelding, 4 years old or over, exceeding 158cms. Capable of carrying over 89kgs (14 stone). Rider to be 15yrs or over. *The highest placed unqualified horse in the top 5 will qualify for the LIHS BSHA Rising Star Middleweight/Heavyweight Hunter Supreme Final at the LIHS in December. In addition, the two highest placed unqualified horses will qualify for the Associate Rising Star Hunter final at the BSHA National Championships Show in September. Associate Rising Star Qualification Cards will be awarded in the ring.*

CLASS 5: RISING STAR LIGHTWEIGHT / HEAVYWEIGHT COB

Mare or gelding, 4 years old and over, exceeding 148cm, but not exceeding 155cm. Rider to be 15yrs or over. *The highest placed unqualified horse in the top 5 will qualify for the LIHS BSHA Rising Star Cob Supreme Final at the LIHS in December. In addition, the two highest placed unqualified horses will qualify for the Associate Rising Star Cob final at the BSHA National Championships Show in September. Associate Rising Star Qualification Cards will be awarded in the ring.*

CLASS 6: RISING STAR MAXI COB

Mare or gelding, 4 years old and over, exceeding 155cms - to be judged as Cobs. Rider to be 15yrs or over. Judges must pay particular attention to type (i.e. short legged animals of COB type). To be shown hogged. *The highest placed unqualified horse in the top 5 will qualify for the LIHS BSHA Rising Star Maxi Cob Supreme Final at the LIHS in December. In addition, the two highest placed unqualified horses will qualify for the Associate Rising Star Cob final at the BSHA National Championships Show in September. Associate Rising Star Qualification Cards will be awarded in the ring.*

RISING STAR RIDDEN CHAMPIONSHIP - Kindly Sponsored by Paddock Apparel

1st & 2nd prize winners from classes 1 to 6 are eligible - Champion eligible for the Supreme

CLASS 7: IN HAND HEAVY HORSE OPEN Judge: Mr M Roberts, Holsworthy

All ages; To include registered horses and un-registered horses.

OPEN RIDDEN HORSES Judges: Conformation: Mr C Yates Ride: Ms F Jones

CLASS 8: OPEN RIDING HORSE/HACK

Mares or geldings, 4 years old or over.

CLASS 9: OPEN HUNTER

Mares or geldings, 4 years old or over.

CLASS 10: OPEN COB

Mares or geldings, 4 years old or over.

CLASS 11: RETRAINING OF RACEHORSES *Kindly sponsored by Chloe Crimmen Veterinary Physiotherapy*

Mares or geldings, 4 years old or over. *The class is open to thoroughbreds that have raced or been in training.*

OPEN RIDDEN HORSE CHAMPIONSHIP

1st & 2nd prize winners from classes 8 to 11 are eligible - Champion eligible for the Supreme

CLASS 12: OPEN DRIVING Judge: Mr B Green, Cornwall

Traditional & Non-Traditional Vehicles; Singles, Pairs, Tandems or Teams. *(1st place rosettes to be awarded to highest placed traditional, non-traditional, novice and best Junior Whip)*

CLASS 13: HEAVY HORSE OPEN RIDDEN Judge: Mr M Roberts, Holsworthy

4 years old & over; To include registered and un-registered horses & part bred horses (minimum 50% heavy horse); The judge will not ride.

RING TWO

CORNISH COMBINATION Judge: Mrs D Alderson, Devon

The following classes are open to exhibits owned and ridden by residents of Cornwall and conformation will not be judged. No rider may enter more than one class. Dress code: All mounted competitors must wear a hat or skull to the current safety standard; Tweed, Navy or Black jackets acceptable; No ear-rings or studs to be worn; Spurs may be worn in class 17 only.

CLASS 14: LEAD REIN

Mare or Gelding; 4 years old & over; Riders to have attained their 3rd birthday but not their 9th birthday by 1st January in the current year; Snaffle bridles must be worn with the leading rein attached to the noseband.

CLASS 15: FIRST RIDDEN

Mare or Gelding; 4 years old and over; Riders not to have attained their 12th by 1st January in the current year; No leading reins; Snaffle bridles only.

CLASS 16: YOUNG RIDER 16YRS & UNDER

Mare or Gelding; 4 years old and over; Riders not to have attained their 16th birthday by 1st January in the current year; Any suitable bridle.

BEST RIDER CHAMPIONSHIP

Best Rider from each from classes 14 to 16 will be nominated to come forward for the Championship.

CLASS 17: OPEN

Stallion, Mare or Gelding; 4 years old and over; Riders 16 years or over, Any suitable bridle.

CORNISH COMBINATION CHAMPIONSHIP - Kindly sponsored by Luke Cain Farriery

*1st & 2nd prizewinners from classes 14 to 17 are eligible - **Champion eligible for the Supreme***

WORKING HUNTER CLASSES Judge: Ms F Jones, Cornwall

Riders must be suitable for the pony/horse they are riding

CLASS 18: TINY TOTS OPEN WORKING HUNTER PONY.

Open to plaited or native ponies; Mare or Gelding; 4 years old & over; Not exceeding 122cms. Fences not to exceed 50cm. Riders 10 yrs old or under. May be lead or assisted. *(not eligible for Championship)*

CLASS 19: OPEN WORKING HUNTER. 60cms

Open to plaited or native ponies and horses; Stallion, Mare or Gelding; 4 years old & over. Fences not to exceed 60cms.

CLASS 20: OPEN WORKING HUNTER. 70cms

Open to plaited or native ponies and horses; Stallion, Mare or Gelding; 4 years old & over. Fences not to exceed 70cms.

CLASS 21: OPEN WORKING HUNTER. 80cms

Open to plaited or native ponies and horses; Stallion, Mare or Gelding; 4 years old & over. Fences not to exceed 80cms.

CLASS 22: OPEN WORKING HUNTER. 90cms

Open to plaited or native ponies and horses; Stallion, Mare or Gelding; 4 years old & over; Not exceeding 153cms. Fences not to exceed 90cms.

CLASS 23: OPEN WORKING SHOW HORSE

Open ONLY to Hacks, Cobs, Maxi Cobs and Riding Horses, mare or gelding 4 years old and over, exceeding 148cms. This class is NOT open to Hunters. Fences not to exceed 90cm.

CLASS 24: OPEN WORKING HUNTER. 1m

Health & Safety Policy

Health and Safety at Work etc. Act 1974

The Management of Health and Safety at Work Regulations 1999

GENERAL STATEMENT OF POLICY

We commit to operating the Association in accordance with the Health and Safety at Work Act 1974 and all applicable legislation made under the Act 'so far as is reasonably practicable'. Our policy is to ensure that the Show is operated in a safe manner for all our employees, volunteers and the general public, and to provide such information, training and supervision as is needed for this purpose.

We also accept our responsibility for the health and safety of other people who may be affected by our activities. The Association acknowledges that the Show is likely to attract those who may be vulnerable and will consider them in their risk assessment of the event. The Association has an Event Safety Management Plan in place which covers all aspects of the operation of the Show and is available from the Show Office.

The Board of Trustees acknowledge that Health and Safety responsibilities within the Association are of equal importance as other priorities and will ensure resources are available to manage Health and Safety. Although the Board of Trustees accept responsibility for the implementation of the Plan, it relies on individual employees/volunteers to accept their own duty and responsibility to themselves, fellow workers and others who might be injured/affected by their acts or omissions. The Plan will be kept up to date, and appropriate to the Association's activities. To ensure this, the Plan will be monitored and reviewed every year or more frequently if required.

SAFETY INFORMATION AND GUIDANCE

All Exhibitors must comply with the Health and Safety at Work Act 1974 and all relevant legislation and guidance. Animal exhibitors must also comply with the Animal Welfare Act 2018 and any relevant codes of practice, guidance, etc. provided by the relevant governing body organisations. Further safety information is contained within the Stithians Show Health and Safety Manual which is made available to those exhibiting at the Show.

SHOW SECURITY

The Association's appointed security contractor will provide night cover between 19:00 and 07:00 from the Monday before the Show and then 24/7 from 07:00 on the Saturday until 07:00 on the Tuesday after the Show. The Association use CCTV monitoring in some areas of the Showground to enhance safety and reduce the risk of criminal activity. The location of the cameras may be moved in accordance with notified risks. The Association will not be responsible for the safe custody of any article brought for exhibition, nor will they be liable for any loss or damage that may occur to any article. It is the exhibitors' responsibility to ensure they have adequately insured their stock and equipment whilst on site and to report any suspicious behaviour to the Security Team.

FIRE SAFETY

All catering outlets and trade stands must assess the risk of fire. Where an ignition source is identified, or where hot works or cooking is carried out on the stand then suitable firefighting and prevention measures must be put in place. BBQs are not permitted on the Showground.

FIRST AID/MEDICAL

If you are setting up prior to, or packing up after Show day, you are advised to ensure you have a first aid kit available. On Show day the Association's First Aid contractor will be on site. The nearest A & E Dept is at The Royal Cornwall Hospital, Triliske, Truro TR1 3LQ. Minor Injury Units are located at Camborne Redruth Community Hospital, Barncoose, Redruth, TR15 3ER and Falmouth Hospital, Trescobeeas Road, Falmouth, TR11 2JA; both of which require you to contact NHS 111 by phone or online prior to visiting. All accidents/incidents and near misses must be reported to the Show's Health and Safety Advisor who is contactable by radio or via the Show Office.

GAS SAFETY

Any fixed installation gas equipment (cookers, pipework, valves etc.) must comply with the provisions of the Gas Safety (Installation and Use) Regulations 1998. All catering vans / marquees with gas installation MUST have a Gas Safety Certificate issued by a competent Gas Safe Engineer and dated within the last 12 months. A copy of the certificate MUST BE provided to the organisers prior to entry to the event. Crimped connection fittings must be used rather than jubilee clips. Further information can be found on the Nationwide Caterers Association website The Gas Safety Checklist - The Do's and Don'ts - NCASS

ECOLI AND GENERAL INFECTION CONTROL

The Show provides the ideal opportunity for the public to interact with the animals. It is important that hand washing is carried out by everyone following contact with animals and pens. There are hand washing facilities in the animal areas and in the toilet blocks on the Showground.

ELECTRICAL SUPPLY

Legislation requires electrical equipment to be maintained in good condition and for it to be suitable for the environment in which it is to be used. All portable electrical equipment brought onto the Showground must be maintained in good condition and where required, evidence of portable appliance testing be available to our Officers. The Show reserves the right to remove from use any equipment that they deem to be unsafe. Further information is available from the HSE website <https://www.hse.gov.uk/pubns/books/hsg107.htm>

Diesel and LPG generators - the use of diesel and LPG generators is permitted provided modern, quiet equipment is used. Stand-alone petrol generators are not permitted. Petrol generators that are professionally built in as part of an operating unit may be used. The Association reserves the right to request any generator that is unsafe or causing a nuisance from fumes be switched off and removed.

SHOWGROUND TRAFFIC

All Showground traffic must give priority to pedestrians and riders and strictly observe speed restrictions at times when such movement is permitted. There is a one-way system in place during build up and break down - please adhere to this. The speed limit on site is **10mph**.

During the Show (09:00 to 18:00) all Showground roadways must be kept clear of any obstruction to allow unimpeded access by emergency vehicles. **There is no unauthorised vehicle movement permitted between the hours of 09:00 and 18:00.**

Livestock exhibitors: may leave the Showground prior to 18:00, subject to the approval of a Showyard Director and notification to the Section Secretary (movement is to enable compliance with Animal Welfare Regulations). The Livestock dispersal will be strictly controlled. Livestock exhibitors must park in the areas allocated to them and be respectful of others when parking.

WASTE

Traders and Exhibitors are responsible for ensuring that any waste is removed from site and their area is left in a clean and tidy state.

OPENING HOURS

Trade and Craft Stand Exhibitors are required to remain open until 18:00 and **MUST NOT** attempt to leave the Showground before that time. Those found to be packing up early and attempting to leave the Showground may find that their application is refused for future shows.

VIOLENCE AND AGGRESSION

Physical or verbal violence or aggression towards our Show Team, Contractors or Officials will not be tolerated; you will be asked to leave the Showground without any recompense. If you have a complaint we can usually deal with any issues if approached in a civil manner but cannot guarantee to always resolve issues on the day of the Show.

MAJOR INCIDENT PLANNING (SITE EVACUATION)

In the event of a major incident where it is necessary to evacuate the site or part of the site, please follow all signs and instructions from the organisers and Emergency Services. ALL people will be requested to evacuate the site, until it is deemed safe to return. The Association accepts no responsibility for any property or livestock or any person or persons who fail to comply with the request to evacuate the Showground.

Animal Escape - Animals are unpredictable and do occasionally break free. Please get yourself and others under your control to safety in a quiet and calm manner and allow those involved in the recapture to do this unimpeded.

WEATHER

It would be extremely unusual for us to cancel the event due to adverse weather. We have, however in the past had to delay set up due to high winds. Please ensure that your contact details are up to date when applying for a trade stand or exhibitors' space. In such circumstances we will communicate with you by email and social media.

It is your responsibility to ensure that you have appropriate structures for your stand. Garden-type gazebos are not suitable for use on the Showground and we encourage you to use a purpose-built shelter available from reputable suppliers. Please ensure that you have adequate anchorage and weights for your structure.

PUBLIC LIABILITY INSURANCE

Whilst the Association has its own Public Liability cover in place it is only for its own protection. All exhibitors must have their own Public Liability insurance which covers them for attendance at the Stithians Show.

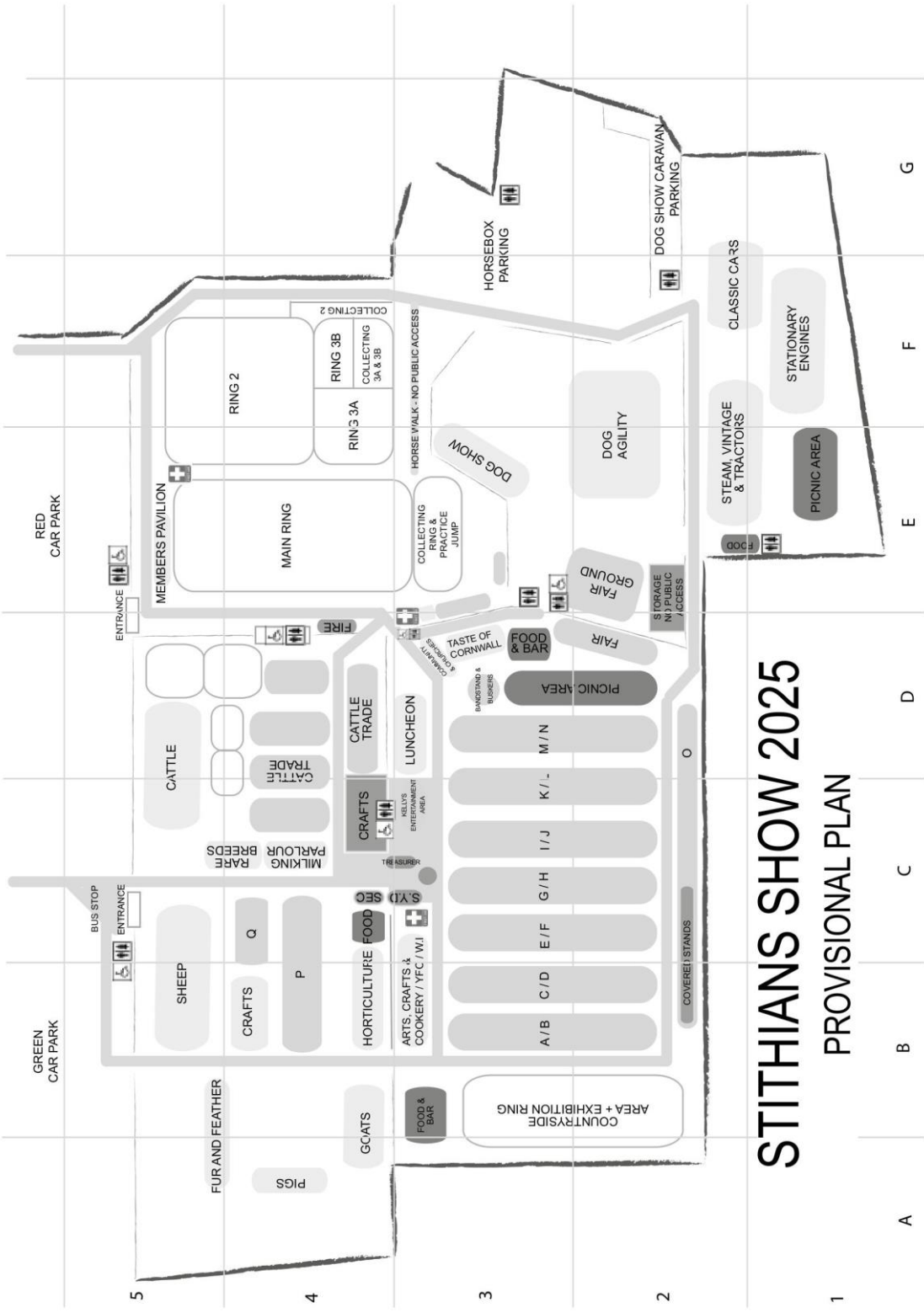
