## SHOWING CLASS AFFILIATION RULES

### British Show Horse Association (BSHA)

This show is affiliated to the British Show Horse Association (BSHA). Held under the rules of the British Show Horse Association. Owners, Riders, In Hand Handlers & Horses must be registered or have temporary membership with a Day/Show Ticket. Horses registered with the Association must be Owned, Exhibited, Produced and Ridden by current BSHA Members. Riders must be 15 years of age or older. Registration numbers must be quoted on your entry form.

**BSHA CLASSIC FINALS** The highest placed unqualified exhibit in the top five in each Open Affiliated class (Classes 7-12) will qualify to compete in the BSHA Classic Finals. The Finals will be held at the BSHA National Championship Show in September 2026.

**BSHA RISING STAR DIRECT QUALIFIERS FOR FINALS AT LONDON INTERNATIONAL HORSE SHOW (LIHS) 2026:** 17th – 21st December Competitors and horses must hold a minimum of LIHS Qualifier-Eligible Membership/ Horse Registration with the Association to be eligible to compete in the LIHS BSHA Showing series. Any competitor who qualifies for a LIHS Showing Series Supreme Final, must then complete full LIHS Qualified registration within 14 days of qualification for their qualification to stand, or it will pass to the next eligible exhibit (the nominal cost of Qualifier-Eligible membership will be taken off the cost of Full LIHS registration). Any competitors/ horses which have existing BSHA membership/ registration for 2026 will not be required to complete any LIHS Membership / Registration for these classes.

**LIHS RISING STAR CLASSES 2026:** Please note: Rising Star Amateur Rules 2026 are separate from BSHA Amateur rules in the main BSHA Rulebook. Please see the separate Rising Star Rulebook in the Rising Star section available on the BSHA website. <https://britishshowhorse.org/bsha-rising-stars-series/>. If you are in any doubt regarding your Rising Star Amateur status, please contact the BSHA Office directly, to have your status confirmed. Classes 1-5 qualify for LIHS BSHA Rising Star Supreme Finals at the London International Horse Show, highest placed unqualified in top five to qualify. A results points table will run for all qualifying classes, and a 'wild card' will be awarded to those unqualified with the highest points in each section following the final qualifier. The Judge will NOT ride exhibits in these classes or at the Finals.

### British Skewbald and Piebald Association (BSPA)

This show is affiliated to the British Skewbald and Piebald Association (BSPA). Classes 27-30 & 62-65 are qualifiers for the BSPA World Championships of Colour National Championship Show to be held at The College EC, Keysoe, Beds, in September 2026. BSPA classes are open to members and non-members with Skewbald and Piebald horses and ponies only. Only members can qualify for WCC. These classes are affiliated to the British Skewbald and Piebald association and are qualifiers for the World of Colour National Championship Show. All classes will be judged within the rules and criteria of the BSPA. Copies of the rulebook and membership/horse registration/over-stamping forms can be obtained from their show office 01354 638226 or downloaded from [www.bsponline.com](http://www.bsponline.com). All stallions 4 years and over must be graded licensed and registered with BSPA in order to compete, BSPA bridle discs to be worn). To in order to qualify all owners/handlers/riders must be members of the BSPA and all horses/ponies registered with BSPA prior to the show. BSPA qualification cards must be produced in the ring and be signed by the judge, otherwise qualification is invalid.

### The Showing Register (TSR)

This show is a qualifier for TSR Showing Finals. All In Hand & Ridden classes are qualifiers. You do not have to be a TSR member to qualify or enter a final. The Rider/Handler qualifies and can enter any horse/pony in any number of Finals. The 4 highest placed handlers/riders will qualify in each class. Competitors MUST have their qualification flyer signed by judge/steward/secretary. Flyers are available free from the website: [www.theshowingregister.co.uk](http://www.theshowingregister.co.uk)

### International Miniature Horse & Pony Society (IMHPS)

Exhibits in Classes 59-61 must be fully paid-up members of the International Miniature Horse and Pony Society Ltd (IMHPS) Horses registered with IMHPS and placed 1st to 3rd in both classes qualify for the Miniature Horse of the Year Show to be held in October 2026 at Keysoe College, Bedford.

**The Shetland Pony Stud-Book Society**

This show is affiliated to The Shetland Pony Stud-Book Society and “Best Shetland” rosettes will be awarded in classes 49 & 52 providing the exhibit is registered with the society.

**National Pony Society (NPS)**

This show is affiliated to the National Pony Society (NPS). Classes 40-47, 49-54 and 70-77 are qualifiers for the NPS Summer Championship Show (4<sup>th</sup> – 6<sup>th</sup> August 2026) to be held at the Three Counties Showground, Malvern. These classes are judged under the Rules of the NPS. Ponies must be registered in any of the British Riding Pony studbook sections or the Ridden Register; the GSB; the AHSB; the AASB, or registered in the main body of their respective M&M Stud Book. Part bred are not eligible unless over-stamped into one of the British Riding Pony studbook sections. or the Ridden Register. Qualifying rounds for most NPS competitions are open to ponies owned by NPS members and non- members but only ponies owned by adult NPS Qualifying or Life members are eligible to qualify for the final of the competition at the NPS Summer Championship Show at Malvern from 4<sup>th</sup> – 6<sup>th</sup> August 2025. The highest placed pony, if owned by an NPS member, in each class will qualify for the final. Qualification may pass down to third place if the first and second ponies are already qualified. NPS/WTJ Insurance Brokers Ltd Home Produced Ridden Championship - Riders of Home Produced ponies (see definition in the NPS Rules Book) can wear a white arm band in classes where this is indicated. These ponies, if owned by NPS members, are then eligible to qualify for the final at the NPS Summer Championship Show. The Owner’s Membership cards MUST be produced in the ring when requested or the qualification will be forfeit.

Classes 70, 72 and 74-77 are qualifiers for the NPS/ Kalusta Stud British Riding Pony (Show Pony) In Hand Supreme National Championship & NPS/Team Charlesworth British Riding Pony (Show Hunter Pony) In Hand National Championship. Both the highest placed Show Pony and the highest placed Show Hunter Pony, if owned by an NPS member, in each class will qualify for the final. Qualification may be passed down to 3rd place if the 1st and 2nd placed ponies have already qualified.

Classes 31 & 32 are qualifiers for the NPS Plaited LR/FR National Championship. The owner of the pony does not need to be a member to be awarded the qualification. Classes 32-35 are qualifiers for the NPS/Leeman Family Open Ridden SP/SHP Gold Medal Championship. The owner does not need to be an NPS member to qualify for the final.

Classes 36 & 37 are qualifiers for the NPS/Faulconbridge Part Bred Ridden National Championship. Classes 68 & 69 are qualifiers for the NPS/Faulconbridge Part Bred In Hand Supreme National Championship.

NPS Silver Medal Rosette Championships: These classes are judged under the Rules of the NPS. NPS Silver Medal Rosettes are only awarded when the owner of the champion pony is a Qualifying or Life member of the NPS. A valid membership card must be in the rider’s/handler’s possession on entering the ring and be produced immediately on request by either the judge or the steward. If the owner of the Champion pony is not a member, or the owner’s membership card is not immediately produced, the rosette may be awarded to the Reserve Champion provided they have the required membership card. If the Champion pony has previously qualified it is still entitled to the Silver Medal Rosette, but the qualification card goes to the Reserve Champion pony, provided the owner of that pony is a member of the NPS. The Silver Medal Rosette and the qualification card can be awarded no lower than first Reserve (third). Foals are not eligible for Silver Medal Championships. Qualifiers are entitled to compete in the final of the Silver Medal Rosette Championship to be held at the NPS Summer Championship Show 4<sup>th</sup> – 6<sup>th</sup> August 2026.

**IMPORTANT: Equine Influenza:**

In order to attend the 2026 Stithians Show all horses & ponies must have been vaccinated for Equine Influenza to comply with the requirements of the primary course (1st vaccination and then 2nd vaccination between 21 – 92 days later), followed by the first booster (150 – 215 days) and all subsequent boosters. Horses may compete having received the primary course and prior to the first booster but not within 7 days of receiving a vaccine dose. Horses must have been vaccinated within 6 months before the show but not less than 7 days of arriving at the show. Foals In-foal mares that have already had vaccinations of primary Equine Influenza course should be vaccinated 4-6 weeks before the foal is due to be born. Foals should be vaccinated for Equine Influenza at 6 months to commence their primary course. We urge all owners to adhere to strict biosecurity protocols at all times. Vaccinations are subject to local risk assessments by the attending veterinarians. Please note that neither vaccination certificates nor passports should be sent to the show office prior to the event. However, random checks will be carried out on the showground during the show. #### **2 Large Hack/ Riding Horse type**

Mare or gelding, 4 years old & over, exceeding 148cms. Hacks exceeding 154 cm, not exceeding 160cms and Riding Horses exceeding 158cms. Rider to be 15yrs or over.

*The highest placed unqualified horse in the top 5 will qualify for the LIHS BSHA Rising Star Supreme Large Hack/Riding Horse Supreme Final at the LIHS in December. QUALIFICATION WILL BE CONFIRMED BY EMAIL ONCE FULL LIHS QUALIFIED MEMBERSHIP & HORSE REGISTRATION IS COMPLETED WITHIN 14 DAYS OF QUALIFICATION. Please note LIHS Qualifier-Eligible membership must be in place before entering any BSHA LIHS qualifying class. In addition, the two highest unqualified placed horses will qualify for the Associate Rising Star Hack/Riding Horse final at the BSHA National Championships Show in September. Associate Rising Star Qualification Cards will be awarded in the ring.*

### **RISING STAR HUNTER**

#### **3 Small/Lightweight Hunter type**

Mare or gelding, 4 years old & over, (Lightweight exceeding 158cms, Small Hunter exceeding 148cms, but not exceeding 158cms). Capable of carrying up to 79.5kgs (12 stone 7lbs). Rider to be 15yrs or over.

*The highest placed unqualified horse in the top 5 will qualify for the LIHS BSHA Rising Star Small/Lightweight Hunter Supreme Final at the LIHS in December. QUALIFICATION WILL BE CONFIRMED BY EMAIL ONCE FULL LIHS QUALIFIED MEMBERSHIP & HORSE REGISTRATION IS COMPLETED WITHIN 14 DAYS OF QUALIFICATION. Please note LIHS Qualifier-Eligible membership must be in place before entering any BSHA LIHS qualifying class. In addition, the two highest placed unqualified horses will qualify for the Associate Rising Star Hunter final at the BSHA National Championships Show in September. Associate Rising Star Qualification Cards will be awarded in the ring.*

#### **4 Middleweight/Heavyweight Hunter type**

Mare or gelding, 4 years old & over, exceeding 158cms. Capable of carrying over 89kgs (14 stone). Rider to be 15yrs or over.

*The highest placed unqualified horse in the top 5 will qualify for the LIHS BSHA Rising Star Middleweight/Heavyweight Hunter Supreme Final at the LIHS in December. QUALIFICATION WILL BE CONFIRMED BY EMAIL ONCE FULL LIHS QUALIFIED MEMBERSHIP & HORSE REGISTRATION IS COMPLETED WITHIN 14 DAYS OF QUALIFICATION. Please note LIHS Qualifier-Eligible membership must be in place before entering any BSHA LIHS qualifying class. 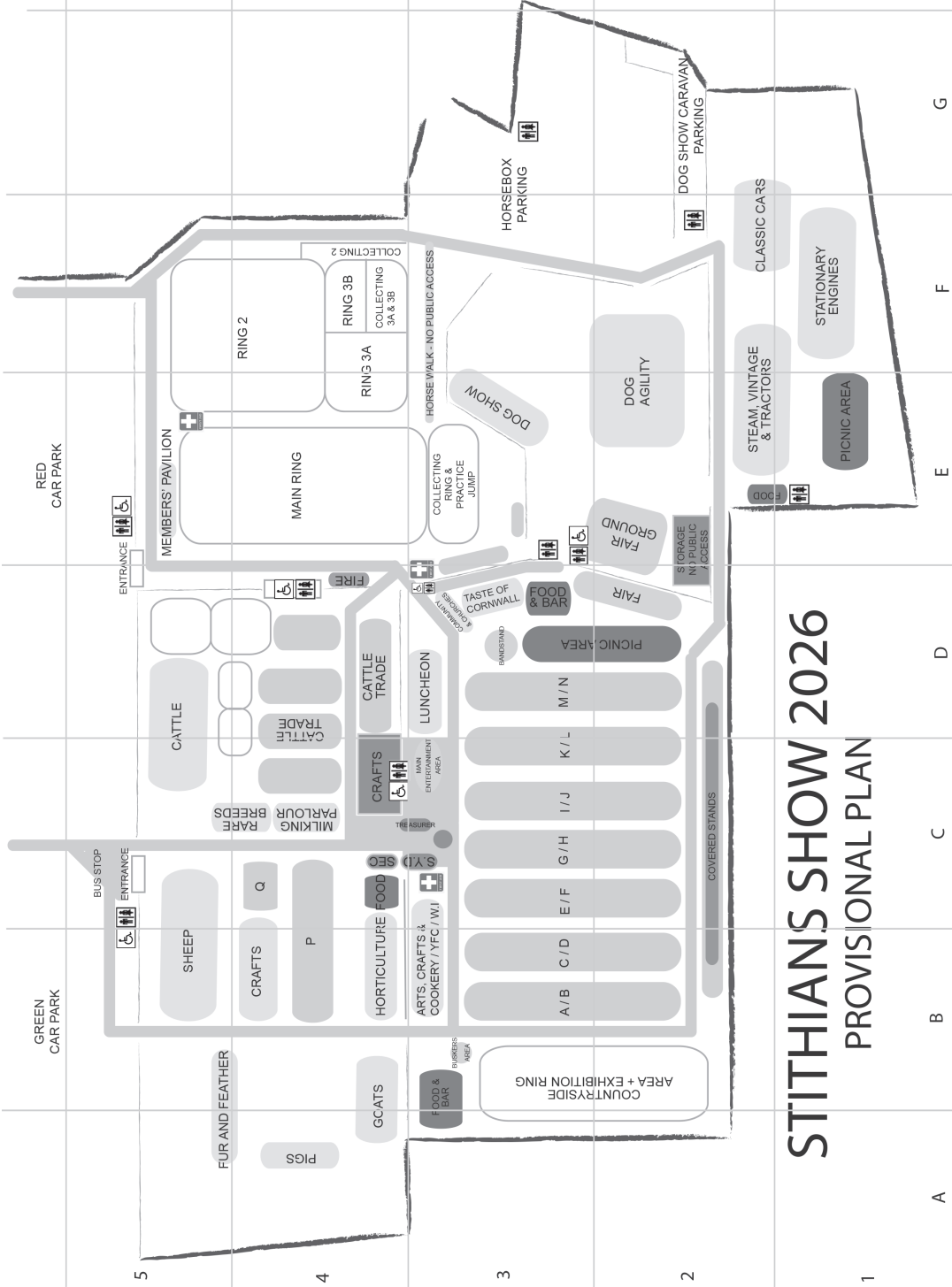

## **Health & Safety Policy**

Health and Safety at Work etc. Act 1974

The Management of Health and Safety at Work Regulations 1999

### **GENERAL STATEMENT OF POLICY**

We commit to operating the Association in accordance with the Health and Safety at Work Act 1974 and all applicable legislation made under the Act 'so far as is reasonably practicable'. Our policy is to ensure that the Show is operated in a safe manner for all our employees, volunteers and the general public, and to provide such information, training and supervision as is needed for this purpose.

We also accept our responsibility for the health and safety of other people who may be affected by our activities. The Association acknowledges that the Show is likely to attract those who may be vulnerable and will consider them in their risk assessment of the event. The Association has an Event Safety Management Plan in place which covers all aspects of the operation of the Show and is available from the Show Office.

The Board of Trustees acknowledge that Health and Safety responsibilities within the Association are of equal importance as other priorities and will ensure resources are available to manage Health and Safety. Although the Board of Trustees accept responsibility for the implementation of the Plan, it relies on individual employees/volunteers to accept their own duty and responsibility to themselves, fellow workers and others who might be injured/affected by their acts or omissions. The Plan will be kept up to date, and appropriate to the Association's activities. To ensure this, the Plan will be monitored and reviewed every year or more frequently if required.

### **SAFETY INFORMATION AND GUIDANCE**

All Exhibitors must comply with the Health and Safety at Work Act 1974 and all relevant legislation and guidance. Animal exhibitors must also comply with the Animal Welfare Act 2018 and any relevant codes of practice, guidance, etc. provided by the relevant governing body organisations. Further safety information is contained within the Stithians Show Health and Safety Manual which is made available to those exhibiting at the Show. All exhibitors will be expected to have read this document along with any relevant set-up and break down site rules.

### **SHOW SECURITY**

The Association's appointed security contractor will provide 24-hour CCTV monitoring of the site from the Monday before the Show and guarded night cover between 19:00 and 07:00 from the Thursday before the Show and then 24/7 from 07:00 on the Saturday until 07:00 on the Tuesday after the Show. The Association's use of CCTV monitoring in some areas of the Showground is to enhance safety and reduce the risk of criminal activity. The location of the cameras may be moved in accordance with notified risks. The Association will not be responsible for the safe custody of any article brought for exhibition, nor will they be liable for any loss or damage that may occur to any article. It is the exhibitors' responsibility to ensure they have adequately insured their stock and equipment whilst on site and to report any suspicious behaviour to the Security Team.

### **FIRE SAFETY**

All catering outlets and trade stands must assess the risk of fire. Where an ignition source is identified, or where hot works or cooking is carried out on the stand then suitable firefighting and prevention measures must be put in place. BBQs are not permitted on the Showground.

### **FIRST AID/MEDICAL COVER**

If you are setting up prior to, or packing up after Show day, you are advised to ensure you have a first aid kit available. On Show day the Association's First Aid contractor will be on site. The nearest A & E Dept is at The Royal Cornwall Hospital, Triliske, Truro TR1 3LQ. Minor Injury Units are located at Camborne Redruth Community Hospital, Barncoose, Redruth, TR15 3ER and Falmouth Hospital, Trescobeeas Road, Falmouth, TR11 2JA; both of which require you to contact NHS 111 by phone or online prior to visiting. All accidents/incidents and near misses must be reported to the Show's Health and Safety Advisor who is contactable by radio or via the Show Office.

### **GAS SAFETY**

Any fixed installation gas equipment (cookers, pipework, valves etc.) must comply with the provisions of the Gas Safety (Installation and Use) Regulations 1998. All catering vans / marquees with gas installation MUST have a Gas Safety Certificate issued by a competent Gas Safe Engineer and dated within the last 12 months. A copy of the

certificate MUST BE provided to the organisers prior to entry to the event. Crimped connection fittings must be used rather than jubilee clips. Further information can be found on the Nationwide Caterers Association website The Gas Safety Checklist - The Do's and Don'ts - NCASS"

## **ECOLI AND GENERAL INFECTION CONTROL**

The Show provides the ideal opportunity for the public to interact with the animals. It is important that hand washing with soap and water is carried out by everyone following contact with animals and pens. There are hand washing facilities in the animal areas and in the toilet blocks on the Showground.

## **ELECTRICAL SUPPLY**

Legislation requires electrical equipment to be maintained in good condition and for it to be suitable for the environment in which it is to be used. All portable electrical equipment brought onto the Showground must be maintained in good condition and where required, evidence of portable appliance testing be available to our Officers. The Show reserves the right to remove from use any equipment they deem to be unsafe. Further information is available from the HSE website <https://www.hse.gov.uk/pubns/books/hsg107.htm>

**Diesel and LPG generators** - the use of diesel and LPG generators is permitted provided modern, quiet equipment is used. Stand-alone petrol generators are not permitted. Petrol generators that are professionally built in as part of an operating unit may be used. The Association reserves the right to request any generator that is unsafe or causing a nuisance from fumes be switched off and removed.

## **SHOWGROUND TRAFFIC**

All Showground traffic must give priority to pedestrians and riders and strictly observe speed restrictions at times when such movement is permitted. There is a one-way system in place during build up and break down - please adhere to this. The speed limit on site is **10mph**.

During the Show (08:00 to 18:00) all Showground roadways must be kept clear of any obstruction to allow unimpeded access by emergency vehicles. **There is no unauthorised vehicle movement permitted between the hours of 08:30 and 18:00.**

**Livestock exhibitors:** may leave the Showground prior to 18:00, subject to the approval of a Showyard Director and notification to the Section Secretary (movement is to enable compliance with Animal Welfare Regulations). The Livestock dispersal will be strictly controlled. Livestock exhibitors must park in the areas allocated to them and be respectful of others when parking.

## **WASTE**

Traders and Exhibitors are responsible for ensuring that any waste is removed from site and their area is left in a clean and tidy state.

## **OPENING HOURS**

Trade and Craft Stand Exhibitors are required to remain open until 18:00 and **MUST NOT** attempt to leave the Showground before that time. Those found to be packing up early and attempting to leave the Showground may find that their application is refused for future Shows.

## **VIOLENCE AND AGGRESSION**

Physical or verbal violence or aggression towards our Show Team, Contractors or Officials will not be tolerated; you will be asked to leave the Showground without any recompense. If you have a complaint, we can usually deal with any issues if approached in a civil manner but cannot guarantee to always resolve issues on the day of the Show.

## **MAJOR INCIDENT PLANNING (SITE EVACUATION)**

In the event of a major incident where it is necessary to evacuate the site or part of the site, please follow all signs and instructions from the organisers and Emergency Services. ALL people will be requested to evacuate the site, until it is deemed safe to return. The Association accepts no responsibility for any property or livestock or any person or persons who fail to comply with the request to evacuate the Showground.

**Animal Escape** - Animals are unpredictable and do occasionally break free. Please get yourself and others under your control to safety in a quiet and calm manner and allow those involved in the recapture to do this unimpeded.

## **WEATHER**

It would be extremely unusual for us to cancel the event due to adverse weather. We have, however in the past had to delay set up due to high winds. Please ensure that your contact details are up to date when applying for a trade stand or exhibitors' space. In such circumstances we will communicate with you by email and social media.

It is your responsibility to ensure that you have appropriate structures for your stand. Garden-type gazebos are not suitable for use on the Showground and we encourage you to use a purpose-built shelter available from reputable suppliers. Please ensure that you have adequate anchorage and weights for your structure.

## **PUBLIC LIABILITY INSURANCE**

Whilst the Association has its own Public Liability cover in place it is only for its own protection. All exhibitors must have their own Public Liability insurance which covers them for attendance at the Stithians Show."
