The Organisers of this Show have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents and must obey the instructions of the Organisers, Officials and Stewards.

IMPORTANT: Equine Influenza:

In order to attend the 2022 Stithians Show all horses & ponies must have been vaccinated for Equine Influenza to comply with the requirements of the primary course (1^{st} vaccination and then 2^{nd} vaccination between 21-92 days later), followed by the first booster (150-215 days) and all subsequent boosters. Horses may compete having received the primary course and prior to the first booster but not within 7 days of receiving a vaccine dose. Horses must have been vaccinated within 6 months before the show but not less than 7 days of arriving at the show.

Foals

In-foal mares that have already had vaccinations of primary Equine Influenza course should be vaccinated 4-6 weeks before the foal is due to be born. Foals should be vaccinated for Equine Influenza at 6 months to commence their primary course.

We urge all owners to adhere to strict biosecurity protocols at all times. Vaccinations are subject to local risk assessments by the attending veterinarians. Please note that neither vaccination certificates nor passports should be sent to the show office prior to the event. However, random checks will be carried out on the showground during the show.

SHOWING CLASS AFFILIATION RULES

This show is affiliated to the British Show Horse Association (BSHA)

Exhibitors wishing to enter **Class 11** who are not registered with The British Show Horse Association can purchase a day ticket – details from www.britishshowhorse.org Horses registered with the Association must be owned, exhibited and ridden by current BSHA members. **Registration numbers must be quoted on entry form.** Day Tickets. Non-members may purchase up to a maximum of 2 Day tickets per Exhibitor, per Horse, per Rider, per season. A Day Ticket will allow entry into Working Show Horse Class 15. Horses registered on a Day Ticket do not require a JMB height certificate. Competitors can apply for a Day Ticket by downloading an application form from the BSHA website.

Classes 1-4 are qualifiers for the BHSA Rising Star 2022 – Open to members and non-members. Rising Star Hacks & Riding Horses: Mare or gelding, 4 years old or over, height must exceed 148cm but must not exceed 160cm for hack type. Rising Star Ridden Cobs: Mare or gelding, 4 years old or over, height must exceed 148cm with a recommended height limit of 160cm for cob type. Rising Star Ridden Hunter: Mare or gelding, 4 years old or over, exceeding 148cm. The two highest placed Horses, not already qualified in the Rising Star classes, will qualify for the Rising Star Finals, to be held at The BSHA National Championship Show in September 2022. The Judges will not ride the exhibits in qualifiers but the judge will ride at the finals. There will be regional clinic days offering training from BSHA accredited trainers.

RULES Rules for BSHA Rising Star Classes which must be entered into the spirit in which they are intended: 1. Open to Non-Members and those with no more than three years BSHA Membership. Owners, Riders and Horses, are not required to be Members of the British Show Horse Association inorder to compete in the BSHA Rising Star qualifying classes, the Rising Star Finals will require a day ticket. 2. These classes are specifically aimed at those Horses and Riders who are not regularly qualifying for the major Championship Shows and wish to improve. 3. Riders must not have competed at The Royal International Horse Show or The Horse of the Year Show, with the exception of the BSHA RIHS Amateur classes pre-2022 or SEIB Search for a Star. 4. Open to Horses which are stabled at home or in a DIY or non-show yard. 5. Horses to be ridden by an Amateur, please see the current BSHA Rule Book; this does not exclude receiving lessons from a Professional showing person. 6. No Professional is allowed to ride, to work-in (in any form), compete, or enter the Ring to groom/strip the Horse. 7. Failure to abide by the Rules may result in ineligibility to compete at the BSHA National Championship Show in any class. 8. The Judge will ride ALL the exhibits in the final. 9. To register for the Supreme Final at the BSHA National

Championships Show on the 10th September you must upload your details on our website using the details on the back of the qualifying rosette. The classes will be made available through grass root level shows, riding clubs and our already listed shows. They will be able to be amalgamated into one class or two classes until the series gains momentum. This could then end up with shows splitting classes and having a Rising Star championship. The firsts 2 placing will qualify for the final from all shows holding Rising Star classes. Those qualifying at a clinic may be asked to attend a regional clinic in preparation for the BSHA National Championship Show. The Supreme Final will be held at the BSHA National Championship Show, with a prelim judging and final championship. A bursary of £200 kindly donated by the Talbot Family will be presented to the winner to be used with a BSHA Accredited Trainer of their choice. The Rising Star Series will be supported and promoted using the 'selected' accredited trainers to the BSHA.

MEMBERSHIP The classes will be open to non-members and members who have never qualified for RIHS or HOYS before (not including SFAS). A qualification for a regional final would need a day ticket and also to attend the supreme final they would need another day ticket. The regional and supreme champions are then no longer able to compete within these classes for the following season. Hopefully this will be the transition to becoming full members and progressing into the existing classes. This enable people to follow this series for more than one season. In season 2 they have to be members.

This show is affiliated to the National Pony Society (NPS). Classes 17-33 are qualifiers for the NPS Summer Championship Show (2nd to 4th August 2022) to be held at the Three Counties Showground, Malvern. These classes are judged under the Rules of the NPS. Ponies must be registered in any of the British Riding Pony studbook sections or the Ridden Register; the GSB; the AHSB; the AASB, or registered in the main body of their respective M&M Stud Book. Part breds are not eligible unless overstamped into one of the British Riding Pony studbook sections. or the Ridden Register. Qualifying rounds for most NPS competitions are open to ponies owned by NPS members and non- members but only ponies owned by adult NPS Qualifying or Life members are eligible to qualify for the final of the competition at the NPS Summer Championship Show at

Malvern from 2nd – 4th August 2022. The highest placed pony, if owned by an NPS member, in each class will qualify for the final. Qualification may pass down to third place if the first and second ponies are already qualified. NPS/Home Produced Ridden Championship - Riders of Home Produced ponies (see definition in the NPS Rules Book) can wear a white arm band in classes where this is indicated. These ponies, if owned by NPS members, are then eligible to qualify for the final at the NPS Summer Championship Show. The Owner's Membership cards MUST be produced in the ring when requested or the qualification will be forfeit.

Classes 40, 42 & 43 are qualifiers for the NPS/Kalusta Stud British Riding Pony (Show Pony) In Hand Supreme National Championship & NPS/Team Charlesworth British Riding Pony (Show Hunter Pony) In Hand National Championship. Both the highest placed Show Pony and the highest placed Show Hunter Pony, if owned by an NPS member, in each class will qualify for the final. Qualification may be passed down to 3rd place if the 1st and 2nd placed ponies have already qualified.

NPS Silver Medal Rosette Championships: These classes are judged under the Rules of the NPS. NPS Silver Medal Rosettes are only awarded when the owner of the champion pony is a Qualifying or Life member of the NPS. A valid membership card must be in the rider's/handler's possession on entering the ring and be produced immediately on request by either the judge or the steward. If the owner of the Champion pony is not a member, or the owner's membership card is not immediately produced, the rosette may be awarded to the Reserve Champion provided they have the required membership card. If the champion pony has previously qualified it is still entitled to the Silver Medal Rosette, but the qualification goes to the Reserve Champion pony, provided the owner of that pony is a member of the NPS. The Silver Medal Rosette and the qualification card can be awarded no lower than first Reserve (third). Foals are not eligible for Silver Medal Championships. NPS M&M Breed & British Riding Pony (SP &SHP) Semi-Final Championship Qualifiers for the Great British In Hand Show - 24th September 2022, Onley Grounds EC.

This show is affiliated to the British Show Pony Society (BSPS) and all persons entering, competing, showing or otherwise taking part in BSPS classes are subject to the Constitution and Rules of the BSPS including the disciplinary procedures and shall be deemed to have consented to the jurisdiction of the BSPS. Affiliation No: BSPS 120/22

This show is a qualifier for the 2022 BSPS Championships Show, to be held 23rd to 27th August 2022 at Arena UK. The 1st and 2nd prize winners only in **classes 55 & 56** will qualify and the 1st, 2nd and 3rd prize winners only in **classes 61 & 62** will qualify for the Championships Show, provided the animal is registered in accordance with rules 21 & 26 of the BSPS 2022 rule book and ridden by a BSPS member. 1st to 4th prize winners in **classes 59 & 60** will qualify for the Champions Show.

This show is a qualifier for the BSPS Blue Riband Pony of the Year. The 1st & 2nd prize winners in **Classes 60 & 62** will qualify provided the pony is owned, registered and ridden by a BSPS member.

This show is a qualifier for The BSPS Binks Family Champion of Champions. 1st prize winners in Classes 48,53, 54, 56, 57, 59 & 62 will qualify.

This show is a qualifier for the BSPS "Classic Services Group" Challenge. Animals must qualify for the Challenge by attending any B.S.P.S. affiliated show and competing in the appropriate class. Ponies must not have qualified for the 2022 Horse of the Year Show. If a pony qualifies for the Horse of the Year Show it will forfeit its qualification for the Classic Services Group Challenge.

This show is affiliated to the British Skewbald and Piebald Association (BSPA)

Classes 44-47 are qualifiers for the BSPA World Championships of Colour National Championship Show to be held at The College EC, Keysoe, Beds, in September 2022.

BSPA classes are open to members and non -members with Skewbald and Piebald horses and ponies only. Only members can qualify for WCC. These classes are affiliated to the British Skewbald and Piebald association and are qualifiers for the World of Colour National Championship Show. All classes will be judged within the rules and criteria of the BSPA. Copies of the rulebook and membership/horse registration/over-stamping forms can be obtained from their show office 01354638226 or downloaded from www.bspaonline.com. All stallions 4 years and over must be graded licensed and registered with BSPA in order to compete, BSPA bridle discs to be worn). To in order to qualify all owners/handlers/riders must be members of the BSPA and all horses/ponies registered with BSPA prior to the show. BSPA qualification cards must be produced in the ring and be signed by the judge, otherwise qualification is invalid. All shows held after 10th August 2022 are qualifiers for WCC 2023 qualification 1-3 in all classes or 1-4 for classes exceeding 12.

This show is affiliated to The Shetland Pony Stud-Book Society and "Best Shetland" rosettes will be awarded in **classes 21, 23, 24 & 25** providing the exhibit is registered with the society.

Exhibits in Classes 38 & 39 must be fully paid up members of the International Miniature Horse and Pony Society Ltd (IMHPS) Horses registered with IMHPS and placed 1st - 3rd in both classes qualify for the Miniature Horse of the Year Show to be held in October 2022 at Keysoe College, Bedford.

This show is a qualifier for TSR Showing Finals. All In Hand & Ridden classes are qualifiers. You do not have to be a TSR member to qualify or enter a final. The Rider/Handler qualifies and can enter any horse/pony in any number of Finals. The 4 highest placed handlers/riders will qualify in each class. Competitors MUST have their qualification flyer signed by judge/steward/secretary. Flyers are available free from the website: www.theshowingregister.co.uk

Any exhibitor wishing to enter a protest must do so in writing to the Secretary, accompanied by a deposit of £20. If the protest is not sustained, the deposit may be forfeited. If the protest is upheld and any award winner becomes disqualified, the winner of the next succeeding award will take the award of the disqualified winner and the lowest award shall go to the reserve award. No protest can be accepted after the conclusion of the Show, nor will any protest be accepted until all the horses in the particular class have left the ring. This does not affect the protest procedures for affiliated classes



We also accept our responsibility for the health and safety of other people who may be affected by our activities. The Association acknowledges that the Show is likely to attract those who may be vulnerable and will consider them in their risk assessment of the event.

The Board of Trustees acknowledge that Health and Safety responsibilities within the Association are of equal importance as other priorities and will ensure resources are available to manage health and safety. Although the Board of Trustees accept responsibility for the implementation of the policy, it relies on individual employees/volunteers to accept their own duty and responsibility to themselves, fellow workers and others who might be injured/affected by their acts or omissions.

The Board of Trustees have nominated the Chairman and a representative from the Showyard Directors as signatories of the Health and Safety Policy.

A signed copy of the full Health and Safety Policy Statement and a copy of the Show's organisational chart is available from the Show Office.

The policy will be kept up to date, and appropriate to the Association's activities. To ensure this, the policy will be monitored and reviewed every year or more frequently if required.

SAFETY INFORMATION AND GUIDANCE

All Exhibitors must comply with the Health and Safety at Work Act 1974 and all relevant legislation and guidance. Animal exhibitors must also comply with the Animal Welfare Act 2018 and any relevant codes of practice, guidance, etc., provided by the relevant governing body organisations.

Further safety information is contained within the Stithians Show Health and Safety Manual which is made available to those exhibiting at the Show.

SHOW SECURITY

The Association's appointed security contractor will provide night cover between 19:00 and 07:00 from the Monday before the Show and then 24/7 from 07:00 on the Sunday until 07:00 on the Tuesday after the Show. The Showground is large, with multiple entrances and the security officials cannot be in all areas, at all times. The Association will not be responsible for the safe custody of any article brought for exhibition, nor will they be liable for any loss or damage that may occur to any article. Exhibitors and those visiting the Show are reminded to take care of their belongings and stock and to report any suspicious behaviour to the Security Team.

FIRE SAFETY

All catering outlets or trade stands must assess the risk of fire and provide fire prevention equipment where any potential ignition sources are present. BBQs are not permitted on the Showground.

FIRST AID/MEDICAL

If you are setting up prior to the Sunday of the Show or packing up after the Monday you are advised to ensure you have a first aid kit available. On Show day the Association's First Aid contractor will be on site. The nearest A & E Department is at The Royal Cornwall Hospital, Treliske, Truro TR1 3LQ. Minor Injury Units are located at Camborne Redruth Community Hospital, Barncoose, Redruth, TR15 3ER and Falmouth Hospital, Trescobeas Road, Falmouth, TR11 2JA; both of which require you to contact NHS 111 by phone or online prior to visiting. All accidents/incidents and near misses must be reported to the Show's Health and Safety Adviser who is contactable by radio or via the Show Office.

GAS SAFETY

Any fixed installation gas equipment (cookers, pipework, valves etc.) must comply with the provisions of the Gas Safety (Installation and Use) Regulations 1998. All catering vans / marquees with gas installation MUST have a Gas Safety Certificate issued by a competent Gas Safe Engineer and dated within the last 12 months. A copy of the certificate MUST BE provided to the organisers prior to entry to the event. Crimped connection fittings must be used rather than jubilee clips. ELECTRICAL SUPPLY

Legislation requires electrical equipment to be maintained in good condition and for it to be suitable for the environment in which it is to be used. All portable electrical equipment brought onto the Showground must be maintained in good condition and where required evidence of portable appliance testing must be made available to our Officers. The Show reserves the right to remove from use any equipment that they deem to be unsafe. Further information is available from the HSE website https://www.hse.gov.uk/pubns/books/hsg107.htm

DIESEL AND LPG GENERATORS

The use of diesel and LPG generators is permitted provided modern, quiet equipment is used. Stand-alone petrol generators are not permitted. Petrol generators that are professionally built in as part of an operating unit may be used. The Association reserves the right to request any generator that is unsafe or causing a nuisance from fumes be switched off and removed.

SHOWGROUND TRAFFIC

All Showground traffic must give priority to pedestrians and riders and strictly observe speed restrictions at times when such movement is permitted. The speed limit on site is **10 mph**.

During the Show all Showground roadways must be kept clear of any obstruction to allow unimpeded access by emergency vehicles. There is no unauthorised vehicle movement permitted between the hours of 09:00 and 18:00.

Livestock exhibitors: may leave the Showground prior to 18:00 hours, subject to the approval of a Showyard Director and notification to the Section Secretary (where movement is to enable compliance with Animal Welfare Regulations). The Livestock dispersal will be strictly controlled.

OPENING HOURS

Trade and Craft Stand Exhibitors are required to remain open until 18:00 and MUST NOT attempt to leave the Showground before that time. Those found to be packing up early and attempting to leave the Showground may find that their application is refused for future shows.

MAJOR INCIDENT PLANNING (SITE EVACUATION)

In the event of a major incident where it is necessary to evacuate the site or part of the site, please follow all signs and instructions from the organisers and Emergency Services. ALL people will be requested to evacuate the site, until it is deemed safe to return. The Association accepts no responsibility for any property or livestock or any person or persons who fail to comply with the request to evacuate the Showground. (Animal Escape) Animals are unpredictable and do occasionally break free. Please get yourself and others under your control to safety in a quiet and calm manner and allow those involved in the recapture to do this unimpeded.

PUBLIC LIABILITY INSURANCE

Whilst the Association has its public liability cover in place it is only for its own protection. All exhibitors must have their own public liability insurance which covers them for attendance at the Stithians Show.
